1990 WORLDCON SITE SELECTION BALLOT

Instructions

1. Please fill in your name and address overleaf. Remember that this information has to be read in at least two countries: avoid using any local abbreviations that might be confusing. This will be used by the winning bid for their records. Also include your Conspiracy membership number if you know it.
2. You have to be a member of Conspiracy to vote. If you are not already a member, enclose a membership fee of £10 (US\$15) supporting membership fee, or £38.00 (US\$65) attending membership fee, and fill in the relevant parts of the form. Postal memberships of Conspiracy will be accepted only if they arrive before 1st August.
3. Your voting fee must be included with your ballot. This has been set at £12; \$20 US, or 40 Dutch guilders would also be acceptable. Please make cheques and money orders payable to '48th World Science Fiction Convention'. This fee gives you supporting membership of the 1990 Worldcon no matter who wins the bid. The winning bid may charge an additional fee (not exceeding \$20 US) to convert to attending membership within 90 days of the end of Conspiracy.
4. A single transferable vote system will be used to count the ballots. Mark your first choice of site with a '1', your second with a '2', etc. If your first choice of site is eliminated in the first count your second choice will be used in the second count, and so on until a clear winner has been decided. You may write-in a candidate, but that bid must have filed a bidder statement with Conspiracy before the ballots are counted. (A bidder statement is a letter of agreement with the proposed facilities, and the rules under which the committee would operate.) A vote for 'None of the above' means that you want the site for the convention decided by the Conspiracy Business meeting. 'No Preference' means just that; you will become a supporting member of the winning bid without having chosen between them.
5. Ballots must be posted before 31st July (to arrive before 25 August) to:
