Pictorial Cancellations by Candace Pulleine

In June of 1995 I suggested to Karen the possibly of LSCII requesting a pictorial cancellation commemorating the first WorldCon held in Texas. I also volunteered to be liaison with the U.S.P.S in obtaining it, since I work for the U.S. Postal Service and have previously obtained a pictorial cancellation for Houston's local Star Trek group. Karen told me to present a report to the committee in the apa.

The attached page from the POSTAL BULLETIN (which comes out every two weeks) explains about Pictorial Cancellations, in some cases prints the actual cancellations, and tells how individuals can get these cancellations through the mail.

If the cancellations are requested and approved early enough, they often get printed in some of the stamp newspapers and magazines. When I worked with the Star Trek cancellation, the USPS sent out a press release and some area people even came by the convention to get their cancellations in person, rather than by mail. Also collectors from all over the nation request them by mail.

Pictorial Cancellations Announcement 96-4

As a community service, the Postal Service offers pictorial cancellations to commemorate local events celebrated in communities throughout the nation. A list of upcoming events for which pictorial cancellations are authorized appears below. If available, the sponsor of the pictorial cancellation appears in italics under the date. Also provided, as space permits, are illustrations of those cancellations that were reproducible and available at press time.

People attending these local events may obtain the cancellation in person at the temporary post office station established there. Those who cannot attend the event, but who wish to obtain the cancellation, may submit a mail order request. Pictorial cancellations are available only for the dates indicated, and requests must be postmarked no later than 30 days following the requested pictorial cancellation date.

All requests must include a stamped envelope or postcard bearing at least the minimum First-Class Mail postage (32 cents per envelope or 20 cents per postcard). Items submitted for cancellation may not include postage issued after the date of the requested cancellation. Such items will be returned unserviced.

Customers wishing to obtain a cancellation should affix stamps to any envelope or postcard of their choice, address the envelope or postcard to themselves or others, insert a card of postcard thickness in envelopes for sturdiness, and tuck in the flap. Place the envelope or postcard in a larger envelope and address it to: PICTORIAL CAN-CELLATIONS, followed by the NAME OF THE STATION, ADDRESS, CITY, STATE, ZIP + 4 CODE, exactly as listed below (using all capitals and no punctuation, except the hyphen in the ZIP + 4 Code).

After applying the pictorial cancellation, the Postal Service returns the envelope or postcard through the mail. Customers who want their serviced item returned under protected cover should include a larger, stamped, selfaddressed envelope.
