

LOS ANGELES BIDS CONSOLIDATE: A meeting of the Los Angeles in bidding committee on April 5 appeared to settle the problem of LA bidding against itself. Bjo Trimble attended, and offered some specific criticisms of the bid led by Stevens/Miller/Pelz, and conventions they or others on the committee had recently staged. Although there was a wide range of reaction to what she had to say, the committee unanimously offered the Trimbles a seat on a programming committee which will be established if LA wins the bid. This proposal, which did not require the Trimbles to join the bidding committee (members help finance the bid with quarterly assessments), was accepted by Bjo (to my understanding). The committee also makes clear that if elected, it intends to discriminate against no one for being a 'media fan' or fan of other nonliterary sf. And, because of the desperate need for staff on a worldcon, there was never any desire to exclude non-LASFSians from the operating committee.

M. DAVID JOHNSON GAFIATES -- AND DOESN'T CLEAN UP AFTERWARDS:
In a letter dated March 17, Chicago fan M. David Johnson announced his gafiation, and cessation of publishing CONACS. He resigned from all cons, clubs and apas. Said Johnson, "I will no longer accept nor respond to any fannish correspondence of any nature whatsoever." No explanation has been discovered. Johnson headed security at Noreascon II.

Diana Sainsbury will wed Ross Pavlac, Co-Chairman of the 1982 Worldcon, on May 30, 1981. Although this is as close to an occasion of state as fandom is likely to get, Sainsbury, a high school teacher, and Pavlac, aka The Avenging Aardvark, will have a basic church wedding in Chicago.



Larue adds these notes: "(1) The 13 chapters of COSMOS were ruled to be a complete, self-contained entity and not a continuing series, and the show is thus eligible in the Dramatic Presentation Category. (2) 'The Brave Little Toaster' is technically a novelette, but the preponderance of nominations have placed it in the Novella category. (3) 'One Wing' may technically be a novel, but the preponderance of nominations have placed it in the Novella category. (4) WARHOON 28 received nominations in both the Fanzine and NonFiction Book category, and it has been placed in the latter. (5) THE RINGWORLD ENGINEERS, although published in a limited press edition in 1979, was ruled by the Noreascon committee in conjunction with Denvention to be eligible for the 1980 awards /sic/. (6) SUPERMAN II, although released in Australia in 1980, was ruled ineligible this year, and presumably

eligible next year at Chic on IV. (7) 'Best Fanzine' rather than the incorrect 'Best Amateur Magazine' that appeared on the nominating ballot, will be the terminology used on the final ballot. (8) Final ballots must be signed. Clubs, 'guests of' and other nonassigned or nonentities may not vote."

Editorialization: Although I disagree with a number of the interpretations listed above, none of the following criticisms are meant to be taken with the same seriousness that I used to criticize committees for admitting professional magazines to the Best Amateur Magazine category, before it was amended. That I considered a failure by the committee to enforce the rules; what follows is mere dissent from some of the ways they have enforced them.

Simplest - item (5) confuses the Hugos with the Nebulas. The 1980 Hugos would refer to the awards distributed at Boston, while the 1980 Nebulas would be the awards distributed (in 1981) for work published in that year. (Seacon & Iggy, but not Noreascon, made the same error.)

Item (1) poses this problem, in my view: how can a work qualify both as Nonfiction and Dramatic Presentation? Just having scanned a list of every nominee in this category since 1959, I found only one nonfictional event has ever been up for the award before. The TV coverage of the Apollo XI moon landing won the 1970 Hugo for its category. At least in 1970 Dramatic Presentation was the only category it could have competed in. This year there is a nonfiction category, and COSMOS is already a nominee. I feel this was a decision not fully thought out and researched by the committee.

Items (2) and (3) -- while the voters may not count wordlengths, the committee must. Seeing that the works nominated are considered in their proper length-categories is a responsibility of the committee, which cannot be bucked back to the voters no matter how many of them are wrong.

Item (4) - WARHOON 28 apparently received enough nominations to compete either in the Nonfiction or Fanzine category. There are arguments to be marshalled on either side. However I feel the real issue has been lost -- WARHOON 28 is of such historic significance that it merits special recognition by the Worldcon. The committee, I am told, has already passed it over. Politically, WARHOON hasn't had the circulation to compete with either LOCUS or COSMOS. But one wonders -- if COSMOS can go in two categories, why not WARHOON?

Item (8) - I believe the refusal to count ballots cast by clubs explicitly violates the contract of membership. Unlike 'guest of' blank memberships, which are held by no one, club memberships are held by entities. LASFS, Little Men's, and FRED (New Haven) are three among many clubs which over the years have purchased memberships and cast the ballot by vote of the meeting. Since the cancellation of voting rights was not announced before the memberships were sold, there is a contract to honor such ballots. Furthermore, by disallowing them, the committee revokes a fun and traditional fan activity. Lastly, by accepting the charade of assigning a club membership to an individual, the committee does not stop the votes from being cast.

Nevertheless, many thanks to Steve Larue for his prompt publication of the nominees, and his grit in going public with the specific rules interpretations.

And while I'm here, let me note the bid committee leadership for Baltimore consists of Chair, Mike Walsh, Vice-Chair Edie Williams, Sceretary Scott Dennis, Treasurer Shirley Avery, and Ted Manekin (whose title is recorded in my illegible handwriting).

NEW YORK IN '86: To add to my continual misreporting of this item, a correction from Ben Yalow: to the individuals listed last time, who comprise the officers & opperations committee, must be added the balance of the committee -- Seth Breidbart, Walt Cole, Linda Deneroff, Lise Eisenberg, Gary Farber, Stu Hellinger, Hope Leibowitz, Elan Litt, Sue-Rae Rosenfeld, Elyse Rosenstein, Steve Rosenstein, Louise Sachter, Art Saha, Kate Schaefer, Stu Shiffman, Giani Siri and Anna Vargo.

MEANWHILE, BACK AT THE RANCH: Having read the item ending the preceding page you will have a list of players to reflect on while you read the next press release from Chaos-on-the-Hudson. Quoting Robert Sacks, "The New York in '83 NASFIC Bidding Committee has decided to bid for the 1983 Worldcon to better promote the NASFIC bid...This bid is not related to the Lunarians '86 bid." Those familiar with the WSFS Constitution will recall that a NASFIC is held when the Worldcon is overseas. Prior to this announced New York bid, contenders for the 1983 Worldcon included Australia, Baltimore and Copenhagen. A NASFIC would be held if either foreign bidder won the Worldcon. In 1973, when the fate of the 1975 worldcon was being decided, and Australia appeared to have it won walking away, Chuck Crayne entered an LA in '75 worldcon bid to popularize his NASFiC bid which eventually defeated a rival LA entry. Crayne's worldcon bid was overwhelmingly defeated, but didn't harm his chances for the NASFiC in the slightest.

But is a similar purpose being served by the New York worldcon/Nasfic bid? Read on, as Brian Burley says: "On Friday, March 20 1981, The New York in '83 Worldcon Bid Committee placed an announcement of its formation on the flyer table at the 1981 Lunacon. This flyer was ordered removed by the chairman of the 1981 Lunacon, on the grounds that she found the phrase 'Not connected with the Lunarians NY in '86 bid objectionable. That phrase had been inserted on the order of the chairman of the New York in '83 bid for the following reasons: (1) To avoid the confusion that comes when two groups are bidding for the same city. (2) To make the political statement of the belief of the chairman of the New York in '83 committee (who resigned from the '86 committee in part for that reason) that the '86 committee had been taken over by members of the clique that currently dominates the Lunarians..."

Thus the light begins to cut through the fog. With less than five months to go before the '83 bid winners are decided, and certainly less than that before the voting deadline, all three other bidders have announced their committee, and what facilities they propose to use. NY in '83 has furnished a committee list -- Chairman Brian Burley, Vice Chairmen Rick Buchanan and Robert Sacks (Sacks is also Secretary), Treasurer Thom Anderson, Deputy Secretary Joe Braman, Fred Kuhn and Robert Osband. For \$1 Pre-Supporting Memberships are available, which will be applied to either the Worldcon or NASFIC, whichever wins. Make checks payable to "Thom Anderson, Treasurer, NY in '83", and send them with your complete address to Joe Braman, Pre-Supporting NY in '83, 444 E. 82nd St. 4M, NYC NY 10028. Their second press release concludes with the reminder, "This bid is not related to the New York in '86 bid" for which Ben Yalow is probably grateful... Now all I have to do is wait for the letters telling me how many names I left off the list of NASFIC committee persons.

BUT FIRST, THIS COMMERCIAL MESSAGE: Brooklyn's own Freff reports "I'm shifting away from running Daystar /records/. Whether the company will be crashed or turned back over to the people who originally backed Fred /Kuhn's/ record or something else has yet to be



worked out. But since I'm no longer working with Fred in the ongoing attempt to make Light an actual <u>functioning</u> band, and other work is looming, it has become a practical necessity to move on.

"Last December, through the good fortune of a fannish connection in a major NYC talent agency, I got a shot at auditioning for the national touring company of the Broadway play BARNUM. Having never done anything on this level, I decided the only way to go through it was to treat it like a piece of guerilla theater. (For my songs I did 'Dead People' by me and James Langdell, and a children's circus song to the tue of 'Chopstix' that was written by me, Tanith Lee and Janet Prato.) Lo and behold, they liked me. They thought I was a little strange, but they liked me. Two more auditions have followed, and on March 2 I have my fourth. This one, they say, is the final. It had better be, considering the fact that the tour starts in May. At this point all I know of my chances are that (a) only four people have been invited to this many auditions, out of three months of looking at prospective performers, that (b) they are casting an entire road company, which means a lot of slots, and (c) at this last audition somebody could dislike the shape of my nose and I'd be out on my ass, just like that...."

Freff also describes how a demo project "became the demo of an eight person orchestra named WEIRD LOAD." Everyone is a multi-instrumentalist. The first demo includes three songs and a tag. Adrian Cosentini and Freff's song "It Don't Make No Difference" has been picked up for airplay by WNEW-FM, while Freff's "Reality Police" has been played on several university stations. Handed out with the demo tape is a notesheet including this synopsis of "Reality Police": "While recording the rhythm tracks for this one, other musicians wandering in and out of the studio compared it to Frank Zappa, Steely Dan, Devo, Stravinsky, and 'Macarthur Park.' And that was before we overdubbed the alto sax, duck call, tympani, toy piano, synthesizer and steel shelving unit. Your guess is as good as anybody else's, now. (Sure is catchy, though.)"

For those keeping score, Weird Load consists of Adiran Cosentini, Salli-Jo Davis, Freff, John Clifford Hampden, Mary E.T.B. Kessler, Mike Molinari, Jeff Neiblum and Mario Silvati. That will be, until I get the usual "who you left off the NY committee" correction memo.

The tip of the Eurcon iceberg poked up in ANSIBLE 16, in the form of this John Brunner letter: "The muddle concerning Eurocon 1982 is infinitely more complicated than indicated in ANSIBLE 15....

It has turned out that the withdrawal of the Hungarian bid was done without consulting the country's more-than-forty SF fan clubs...who in the interim had not only held a special meeting to plan the convention but had enlisted the support of the Writers' Union and applied for an okay from the Ministry of Culture. Said okay is now to hand! We are left lumbered with the hideously embarassing mix-up resulting from one person falling ill and withdrawing without telling everyone else in the intended host country. Pascal Dunommun (one very nice guy) was so eager to get a Swiss con rolling, he too had organized a preliminary meeting before the news arrived that Mr. (Hungarian) Kuczka had neglected to persuade everyone else that without him it wouldn't work.... On the current evidence, Hungary is the destination."

Brunner's note piqued my interest, and is amplified by Waldemar Kumming in MUNICH ROUNDUP 151 -- but not to confuse the chronology, Brunner's item is probably fresher than MRU dated 12/80: "Under the Eurocon rotation plan the '82 con was to go to an East European country; the Hungarians put in a bid first which was well received by most delegates but withdrawn when the Russian delegate got up and announced the Russian bid. This was disliked by all but accepted after some debate, as it was realised that not accepting the bid might put an end to any East European participation at Eurocons. However, both the Hungarian and a Swiss bid were also accepted as alternatives in case the Russians were unable to hold the con. The caution implicit in this decision has since been entirely justified by events. The Russians have declared that they are unable to hold the convention because the writers' union (which would have to stage it) could no get hotel space allocation for '82. Some British fans are rooting for an '84 Eurocon in Britain,... but there is also some talk of moving that to '82."



CONVENTIONAL REPORTAGE

CHATTACON 6 (Jan 16-18): From Eva Chalker Whitley, "The masquerade was better than usual with some exceptions: top prize winners from the MidSouthCon of last summer and last year's Chattacon showed up wearing the same costumes and doing the same shtiks, and despite

my objections, the other judges (Jean Longyear, Sharon Webb, Bob Tucker) insisted on giving them a prize anyway. The other incident was even worse -- one guy, who came as an ambassador from some planet of blue-faced hulks, did a fairly funny presentation, then started doing imitations, and finally, when it appeared he would be on stage all night, was dragged off by Tola Varnelli (who was running it). When he was brought back for his prize (I think we gave him best presentation) he started doing MORE imitations capping them off with raised arm salutes and yells of 'Sieg Heil! Sieg Heil!' to which the audience enthusiastically responded! I was outraged and shocked, but everyone else INCLUDING MY FELLOW JUDGES laughed it off." Attendance was about 300, she estimates.

CONFUSION: (Jan. 23-25): Writes Leah Zeldses, "I think most of the 709 attendees had a good time, but I can't be sure, not being one of them. It was holy hell for the help. ConFusion 1981 was characterized from the beginning by a chronic shortage of personnel, and things got worse instead of better. I was in charge of publicity and publications and my job was supposed to have ended before the convention started, but somehow I became a sort of secretary for the chairman and general girl friday, taking care of all the lastminute and forgotten details, and believe me there were a lot of them. It was Nancy Tucker's first time as chairman, and under difficult (as mentioned) circumstances, and things got a bit out of control. I don t think many of the cracks showed, however. No one (literally) besides the committee showed up for Sunday's gripe session. ... The Cosmos & Chaos Juggling Exposition was a big hit, and Barry Longyear's speech was hilarious. Financially, the convention did quite well, making a profit of about \$2000. This is mostly a credit to our strong treasurer, Jean Barnard /considering that last year's ConFusion went a couple hundred dollars in the red despite smooth operation and equivalent attendance/. Surplus funds will be donated to the Science Fiction Oral History Association, and some will be used for a party for the con workers.'

BOSKONE 18: (Feb. 13-16): George Flynn begins, "Attendance was around 1600-1650.... Announcing the 3000-member limit (in sheer panic after Noreascon) was a tactical error; reinforced by the high costs, it tended to scare away out-of-towners who were afraid of not getting in, while the number of local turkeys walking in was up. We've now got the weapons-carrying problem in full force: I understand we confiscated a crossbow, somebody had his machete stolen while sleeping in public, and of course at the gripe session we had complaints that our policy of not allowing drawn weapons was an interference with their freedom. One was arguing that we should have made space for a, 'blaster battle'. Perhaps a more interesting symptom of what's happening to fandom was the complaint, at the same session, that the huckster room contained "almost nothing but books!" The program this year was somewhat limited, since a lot of pros didn't feel like coming to Boston again so soon. Art show sales were about \$17000 (compared with c. \$25K two years ago and \$80K at Noreascon). Tanith Lee was a delightful GoH. The committee were mostly newer people in NESFA, the first string still being burned out from Noreascon.

Continues Mark Swanson, "Part of the problem was the hotel. The

Sheraton Boston has new management. While interested in holding on to the convention, they seem to have tried to 'minimize the damage', feeling scarred by Noreascon II. The result was overkill. Thus, many parties got closed down Saturday due to 'excessive noise'. This hadn't happened before at Boskones that I'd heard of....Boskone did have more costumes than previous years being worn all through the con. Alas, too many were Star Wars, Star Trek or BS Galactica-based. Saturday night I watched a twit in a 'Space Marines' costume make himself obnoxious to a Marine sniper in undress. Good thing that the US Marines enforce courtesy while in uniform. All in all, a great convention requires the united efforts of fans, hotel and con committee. And only the committee was up to the job this year. Better luck next time."

Regarding weapons, David Wallace demurs, "This is fine if it is some metal monstrosity which looks like a machine gun or a laser, but going after plastic 'phazors' (sic) or light sabers is a bit ridiculous."

CAPRICON (Feb. 20-22): Leah Zeldes narrates, "It had all the typical problems of a first convention -- programming late or nonexistent, hotel hassles, etc -- and a few more besides. Approximately 500 people attended; many of them seemed to be local walkins and fringe fans."

DATCLONE (Feb. 27): Martin Morse Wooster reports, "This ultra-fannish relaxacon, sponsored by WSFA, was held the last weekend of February in the Sheraton in Gettysburg PA. Attendance was 75 but included such a varied crew as Taral and Victoria, D Potter, Jim Gilpatrick and his coterie. A surprised Gilpatrick was made 'Fan Guest of Honour.' Highlights included a trip to a Danskin factory-surplus outlet in York..."

MARCON XVI (March 13-15): Contributes Franz Zrilich, "According to Mark Evans, close to 500, if not more, people attended. The Huckster's Room was huge. Art show was big, too. ... The video room seemed more well-attended than the film room -- possibly because the equipment was in better shape.... The video room also had a lot of Doctor Who stuff, too. There is quite a big Who boom out here, with fan clubs and scarves popping out of the woodwork all over the place. Programming was virtually nonexistent at the panel level. What little there was was weakly attended. Not too many pros showed up. Andrew J. Offutt was Pro GoH. ... There was a state-wide high school wrestling tournament in town the same weekend and they kept the thugs out when they started pouring in like roaches with cries of 'free beer!'"

SATYRICON (Aprril 3-5): Mike Rogers actually wrote to tell me about SFPA's 100th Issue collation, but if I don't stick it here, who knows where there'll be room. Says Mike "The pagecount for SFPA #100 was 1748 pages!! As far as we know, that's an all-time record /for an apa mailing/. The collation at Satyricon in Knoxville went quite well. There was a made scramble to finish the 00 and get to the print shop before they closed; I ended up typing the waitlist. Had Guy Lillian not gotten there in time, the backup plan was to drive to Chattanooga to use the Lynches' mimeo & electrostencil machine!" A near-miss for Southern car-wreck fandom... Footnote: Harry Andruschak says his 300+ page zine was omitted from the mailing by Guy Lillian (OE).

Also, 'Final award ballots shall include name, signature..." -- indicating at least a person in any case. Since this seems to be a new issue to me, I would be glad to throw it open for debate if you or anyone else is willing."
