

# WESTERCON SITE SELECTION BALLOT

## SITE SELECTION VOTING RULES (CONT.)

### TO CAST YOUR VOTE BY MAIL:

Completely fill out Part 1 and Part 3. Your check will be your receipt. It is not necessary to complete Part 2.

Mail the completed ballot along with your check made out to Westercon 42 for \$ 15.00 (Fifteen Dollars) to:

Ballots must be postmarked by June 20, 1987 and received no later than June 30, 1987 to be counted.

### TO CAST YOUR VOTE IN PERSON:

Completely fill out Part 1 of the ballot. Take the ballot with your voting fee to the site selection table. The clerk will take your money and fill out Part 2 as your receipt, as well as cut apart Parts 1, 2 and 3. You will be given back Part 2 and Part 3. NOW fill out Part 3 and place it in the ballot box. Keep Part 2 as your receipt.

## SITE SELECTION VOTING RULES

Voting for the Westercon Site Selection shall consist of (1) filling out this ballot; (2) paying a fee of \$ 15.00 and (3) turning in this ballot to the current Westercon Committee for tabulation.

Voting is done by the "preference" method. Once you have chosen the site you wish to vote for, place a "1" next to that site. Place a "2" next to your choice for second place, a "3" next to your third choice etc., until you have either run out of choices or do not wish to vote further. If there is a mark next to only one site, the ballot shall be counted as having cast a first-choice vote for that site. Any ballot which has marks other than as described above, shall be disqualified for the count.

Votes will be tallied by the voters' first choices. If no majority is obtained, the site which places last in the initial tallying will be eliminated and the ballots listing it as first choice will be redistributed on the basis of those ballots' second choices. The process shall be repeated until a majority has been obtained.

One (1) individual equals one (1) membership equals one (1) vote. Corporations and Associations may purchase voting memberships but must cast them as no preference. A "guest of" membership must have been transferred to a specific person prior to casting the vote.
