2013 Site Selection For Westercon in 2015 Ballot Rules

Members of Westercon 66 are eligible to vote on the site of Westercon 68, the 2015 West Coast Science Fantasy Conference. You can vote using this ballot either at the convention or by mail. You may authorize another person to deliver your ballot to the convention for you. To be eligible to vote, you must be a member of Westercon 66 and you must pay a voting fee of US\$10.00. You must pay this voting fee at the same time you vote. Make the check or money order for your voting fee payable to "Westercon 68." Credit cards will be accepted onsite only . You must vote using a paper ballot; there is no web or e-mail voting. Do not send cash through the mail. Westercon will not be responsible for any ballots lost in the mail. We will not count your ballot if it arrives without a voting fee.

The voting fee entitles you to at least a supporting membership in whichever site is selected to host the 2015 West Coast Science Fantasy Conference (Westercon 68). The winning bid may require you to pay a conversion fee to convert your supporting membership into an attending membership. Determination of such a conversion fee is the prerogative of the winning bid.

Voting is by preferential ballot. Place a "1" next to the site you want to win. Place a "2" next to your second choice, a "3" by your third choice, and so forth. If you want to vote for a write-in bid, write the name of the bid in the space provided and write your preference next to your choice as with any other choice on the ballot.

The balloting period at Westercon 66 is scheduled to end at 7:00 PM PDT Friday July 5, 2013. The full schedule of the polls is at <u>http://www.westercon66.org/westercon-business/site-selection-and-bidding/</u>.

If no bid receives a majority of the first-place votes cast, the ballot cast for the candidate which received the least number of votes will be redistributed based on the next-highest preference listed on those ballots. This process continues until one candidate receives a majority. "None of the Above" counts as though it were a bid. Votes for "No Preference" do not count toward the total number of votes cast, and we will not count any of your choices ranked after "No Preference." (In other words, "No Preference" ballots are counted as if they were blank, so voting that way is a way of abstaining.) A single "X" or similar mark will be counted as a first place vote for that candidate with no other preferences. Any other marks will invalidate your ballot. The Site Selection Administrator must be able to clearly determine how you voted in order to count your ballot.

If you have more than one Westercon 66 membership in your name, you can vote only once for anything other than "No Preference." (That is, if you have multiple memberships, you can vote them all, but you must vote for "No Preference" on any ballot other than the first one.) Memberships held by corporations, associations, or "Guest of" memberships can vote only for "No Preference". The Site Selection Administrator is authorized to mark ballots to enforce these rules. Should "None of the Above" or an invalid bid win the election, the site for 2015 will be selected by the Westercon Business Meeting at Westercon 66 as provided for in the Westercon Bylaws. The results of the site selection will be announced at a session of the Westercon Business Meeting or by announcement in the convention newsletter or other means of general announcement. The time and place of this meeting (if one is required) will be announced in the program book, and will be available at Site Selection.

You may submit your ballot one of three ways:

- 1. In person, at Westercon 66 in Sacramento, on Thursday July 4, 2013 between 1pm and 5pm, or Friday, July 5, 2013, between 10am and 7pm.
- By mail (instructions are on the ballot). Mailed ballots must be received by June 20.
 Ballots arriving at our mailbox after June 20 will not be processed.
- 3. By proxy: you may fill out your ballot as though voting by mail, and have it hand carried by another person to the convention, to be delivered to the Site Selection desk during the voting hours on Thursday and Friday.

Please note your 8-digit membership number on the address on this cover sheet. That is the number to enter on the "Westercon 66 Membership Number" line on the ballot.
