## **MEMBERSHIPS**

Membership Types

We have two types of membership, attending and supporting. A supporting member receives all general publications, and has the right to vote in the 1984 site selection and the 1982 Hugo Awards. An attending member get all that plus the right to attend Chicon IV.

## Attending Memberships

Supporting Memberships

You can become a supporting member of Chicon IV for \$15 until July 15, 1982. Note that a presupporting membership in the Chicago in '82 bid committee is <u>not</u> a supporting membership.

To Convert Supporting Memberships

If you voted in the 1982 site selection, you're already a supporting member. Your conversion will cost the current attending fee minus \$7.50 U.S. If you didn't vote, but are a supporting member, it'll cost the current attending fee minus the \$15 you paid for your supporting membership.

Membership Refunds

We can't refund your membership, but we can transfer it to someone else before July 15,1982. Transfers will be honored only upon written notice from the original member.





Fannish Names

We'll send your mail any way you want, but because the Post Awful doesn't always remember fannish names, we'll send it in care of your real name. If you register with a fannish name, your convention badge will be in the fannish name only, unless you tell us differently.

Moving

Unless you relish the thought of never receiving your mail, TELL US WHEN YOU MOVE. Send all address changes and questions regarding registration to the Registration Dept., c/o the Chicon IV P.O. Box.

Membership Problems

If there is a problem with your membership, please tell us! We'll keep trying to reach you, but if the only information we have is wrong we'll never be able to straighten things out. If we still haven't made contact with you by the time several letters have been sent to you, your membership will be terminated and your money will be refunded if the amount you sent wasn't enough to qualify you as a Chicon IV member.

Unless you'd like to receive your PRs just in time for Worldcon '92, TELL US WHEN YOU MOVE! While it's true the Post Awful will forward bulk rate mail (we still mail the PRs by bulk rate), it will cost us 70 cents. For another quarter, the Post Awful will send us an address correction. That's already 95 cents, and you haven't even seen your PR yet. Then add the cost of re-mailing. This delays delivery of your

mail, makes us unhappy and the Post Awful very rich. Similarly, if your PR is refused or returned because it was unclaimed, Chicon IV must pass on the additional charge for return postage to you. If this has already happened to you (ghod forbid), please send us a list of the PRs you have not received and your correct address.

Multiple Memberships

You can buy a membership for another person without naming that individual right now. That person will be listed as "guest of (your name)" on the membership card. You can convert "guest of" to a specific name until July 15, 1982. Please be aware that "guest of" memberships are not eligible to vote for the Hugo Awards or the 1984 site selection unless they are converted to a name. If you have a group or club and want to purchase memberships together, it's best if you assign the memberships in an individual's name. Otherwise, your membership cards will only name the organization with each person listed as guest #1, guest #2 and so on. Again, these memberships are ineligible to vote unless they have been converted to names by the July 15,1982 deadline.

## HOW TO WRITE TO CHICON

An amazing variety of media can be used to send messages through the mail, but please restrict yourself to paper and pen or typewriter. Please put your full address on all correspondence to us. Include your membership number, so our computer can quickly decide who you are. All of our mail is marked:

#### ADDRESS CORRECTION REQUESTED FORWARDING AND RETURN POSTAGE GUARANTEED

If you move (and we'll say it ONE MORE TIME), please send us your new address, before you move if possible.

If you are just joining us, you will get a postcard ASAP by first class mail, telling you that your new membership has been received.

Contrary to popular opinion, your letters to us are not automatically filed in the Chicago Sanitary Landfill. Registrations go directly to our Chicon IV Registrar. Everything else is filed, and photocopies go to our co-chairmen Larry

and Ross, and to each department referred to in the letter.

If your letter needs a reply, the department involved is responsible for sending you one. If your letter is of general interest, we may want it for the fanzine *Cons and Shell Games*. If you don't want your letter quoted therein, please mark it DNQ.

## FILM PROGRAM

No Worldcon would be complete without hundreds of people sitting together in a large room watching their favorite movies and saying the lines along with the characters. Chicon IV will do its part to keep media fandom alive by providing two tracks of extensive and innovative programming, held entirely at the Hyatt Regency.


The main track will run 18-20 hours daily, and will consist of theatrical releases. Greg Rihn, head of the film department, is working on the schedule now, but it's still much too soon to announce titles.

The second track will run at least 12 hours a day and its contents are still open to suggestion. We plan to rerun a few popular films from the main track, but reruns will not be the top attraction here. Some of the ideas under consideration are: blocks that focus on a certain director or filmmaker, Late Night Turkeys (like "Attack of the Killer Tomatoes"), foreign science fiction and fantasy, a videotape of the masquerade, and amateur productions made by members of Chicon IV. Amateur films submitted for viewing must be screened and receive approval before they are shown. Look for further details in PR 4.

If you're currently working in films or video tape, and have access to anything you'd like shown at the convention, write Greg Rihn c/o the Chicon P.O. Box. Or if you're Phred Phan and have some suggestions or old favorites you'd like to see, we want to hear from you, too.

## VOLUNTEERING

Many of you have written and volunteered to work for Chicon IV, before and at the convention. This is fantastic. We can't do it without your help and we are grateful that so many of you are willing to work when you could be at a program item or party. We are currently receiving a lot of worried letters from fans who volunteered months ago, but haven't heard from us. This isn't because we've forgotten you or, worse, don't want you. The convention is still almost a year away, and several departments are only just now organizing their staffs. Many positions will not be filled for months



yet. So, don't worry. The individual departments you have volunteered to help will contact you as soon as they are ready. Don't worry, your offers will be amply rewarded with all the jobs you want.

## **PROGRAMMING**

The mad schemers in our Programming Division are planning three main tracks of programming for Thursday, Friday, and Monday, and four (count 'em) tracks for Saturday and Sunday. Many other special interest items will run "off the main track" in smaller function rooms. Based on observations at past conventions, the division has decided to divide program items into two loosely-defined types—"literary" and "other." The "literary" panels will cover everything from generalized genre to in-depth study of specific authors' works. The "other" panels will cover science and technology, media, art, fandom, you name it. These categories aren't carved in stone, and no doubt they'll overlap, but they give you (and us) an idea of what to expect.


Not all program items will be in traditional panel form. We plan slide shows, in-depth interviews and several unusual (heh, heh) events we'll keep under our hats for the moment.

At recent cons it has been obvious that people want to meet professionals, and people with specialized interests want to meet in smaller, more intimate groups than a main-track meeting room can provide. Therefore, we've set up a special-interest subdivision to coordinate activities such as authors' forums, discussion groups, seminars and workshops, and meetings of established special interest groups. We have

allocated a number of small rooms for this purpose. If you would like to participate in or run a particular workshop or seminar, or if you have a favorite special interest group, please let us know immediately!

We are currently contacting professionals and fans for ideas and assistance, and we'll have a tentative list of speakers and specific panel ideas in PR4. Remember, we're always eager for suggestions and volunteers. Incidentally, our earlier request for volunteers got a good response, and we expect to be contacting people who volunteered for specific job assignments in the near future. Believe us, there's plenty of work to share.

NOTE: While we have allocated a number of rooms for special interest group use, space and time are finite. Space for special interest groups will be assigned on a first come, first served basis. While we will accommodate anyone who asks for space (somehow), we can't guarantee that last-minute requests will be given their first choice for location, or even space in the Hyatt Regency (we will try to place them inside the state of Illinois). If you are a member of a group that will want meeting space, please let us know NOW! All requests should include the following information: Name of the group, person to contact and that person's address, approximate size of meeting, and day and time preferred.







## ROTSLER'S RULES FOR MASQUERADES

Joni Stopa, Chicon masquerade czar, provided these rules, submitted by William Rostler, famous fan artist and ardent masquerade attendee. Joni suggests these rules be followed, as she intends to draw up specific masquerade rules based on these.

- 1: There should be a weight limit for the purchase of leotards.
- 2: Every contestant should first see him-self/herself from the rear.
- 3: Whether prince or pauper, act like it. Stay in character.
- 4: Speak distinctly, but not at length . . . or not at all.
- 5: Learn to use the microphone properly . . . or not at all.
- 6: Do not lecture your audience. You are not there to make protracted statements on your particular "thing," but to entertain. When in doubt, keep your mouth shut.
- 7: No name tags on costumes.
- 8: Parts of your costume should not be edible or smell. Parts of your costume should not fall off accidently.
- 9: Hand in a legible entry card, even to the point of writing out phonetically any difficult or unusual words.

- 10: If you have something for the narrator to read, keep it brief; eliminate the unpronounceable, incomprehensible, made-up names. Do not duplicate on microphone what the narrator has already said.
- 11: If you are going to attempt a costume cliche, you must do it better than ever before, or have a good variation, preferably comic.
- 12: Consider carefully before going nude or semi-nude.
- 13: Thou shalt wear shoes to match thy costume.
- 14: If you are thinking of doing something you intend to be amusing, try it out on an honest friend.
  - Craig Miller's Corollary: Short is better than long; funny is better than non-funny; short and funny is best.
- 15: If you have the slightest doubt that your costume—based on a cover or story description—might be unfamiliar to the judges, do not hesitate to supply them with a copy of the cover, illustration or descriptive text.
- 16: Remember, some people can grow a beard and some cannot.
- 17: Presentation can make a mediocre costume and break a good one.
- 18: Keep all presentations short. Action is better than words.
- 19: Learn to manage your props, accessories and music.
- 20: Do not commit the unforgivable sin: Do Not Be Boring.
- 21: Rehearse! Rehearse! REHEARSE!

  Len Wein's Law: Those who think these rules don't apply to them are wrong.

## HANDICAPPED FANS

The Chicon committee recognizes the special needs of handicapped fans, and is attempting to respond by setting up the Handicapped Member Assistance Department. Plans are for a four-person staff to be on duty in shifts for eight hours each day during the main convention functions, with the manager and/or assistant manager on call the remaining 16. Prior to the convention, the department will check the Hyatt for potential problems, and corrections will be made wherever possible.

We need to know what your needs are, as early as possible. If you have any specific ideas on how such needs can best be handled, feel free to suggest—you'll probably think of something we haven't. We don't expect to be able to do everything for everybody, but we do want to help as much as we can. Obviously, we're more likely to succeed if we know the potential problems in advance.

To anyone coming who is able to deal with the handicapped individual—both formally and informally trained: would you consider giving a little of your time as a member of this Department? We hope to set up staff schedules so that each staff member will only have to put in a couple of hours per day, leaving as much time as possible for enjoying the convention. Evening on-call time will be minimal or non-existent.

## **HUCKSTER ROOM**

Well over half of our 8-foot by 2-foot dealer's tables have been sold. To reserve one of those remaining, please send the full price of \$80 (we no longer accept \$50 deposits) to Dick Spelman, c/o the Chicon P.O. Box. Since tables are assigned as money is received, early payment will give you a better chance of obtaining a table. No one will be permitted to sell from his or her hotel room.

There are four major restrictions we will place on dealers:

1. All merchandise must be related to science fiction or fantasy.

- The display of merchandise must not interfere with traffic flow or the sales of other hucksters.
- 3. All trademarked or copyrighted merchandise must be properly licensed and legal.
- 4. Sales of all weapons must comply with local laws and the Chicon IV Weapons Policy.

If you have written for Huckster Room information and received no reply within four to six weeks, please write again. Your communication may have found a crack to slip through. Further information is available from Dick Spelman c/o the Chicon IV P.O. Box.

#### ART SHOW UPDATE

Chicon IV's Art Show will have at least 250 panels for hanging artwork and a number of tables and display cases for jewelry and other 3-D work. The show will open for viewing at 10 a.m. each day of the convention; closing times will be determined according to each day's evening programming schedule.

Most artwork will be sold by bid sheet—the piece goes to whoever has the highest written bid on the sheet when the show closes on the work's sale day. If more than six written bids are received, the piece will go to auction (auction details follow). If you plan to bid on art, you'll need to register at the Art Show control desk and receive a bidding number. You will have to write this number along with your name on the bid sheet. We're not trying to make things difficult; We just have to screen out false bids. There will be arrangements for charging your purchase and paying by personal check.

Art Show security workers, wearing clearly visible insignia, will be in attendance at all times. Large bags and cameras will not be allowed into the show; the security people will watch your belongings and issue you a claim check. The security types will also observe that bids are properly recorded, make sure that artwork is not being handled, and help with any problems that arise (as though there could be problems!). Again, the security people are not out to be difficult, they are just trying to keep things running smoothly.

ARTISTS! Art show procedures, information and reservation forms will be mailed to all who request them by February 1, 1982. This should give you time to decide the type and quantity of artwork you want to bring. If you haven't already written to us for this information, do so now. Requests will be answered in the order they are received. If you have sent your request, please be patient. Your letter is on file and we know you're waiting.

Rules and requirements will be pretty much the same as those at Noreascon (the 1980 Worldcon), and the fee structure has been devised to suit both artists and the convention (really). The rate will be \$20 per panel or table plus a 10 percent commission on sales.

Once you get your information, you'll have to make your reservations before August 1, 1982, and all reservations will have to be accompanied by the required fees. Don't wait too long, since space will probably fill up quickly. A waiting list will be established in case previously registered artists cancel.

NEGATIVES: No artwork may be entered at the door (i.e., after the August 1 deadline). The art show will not have a sketch table. Finally, ALL ARTWORK MUST BE ORIGINAL. Only special-

ized prints (such as lithographs) will be allowed in the show.

POSITIVES: Awards, by separate fan and artist votes, will be made in professional and fan categories for Best in Show/Most Popular, Science Fiction, Fantasy, Humor, Media, Handicraft and a special category for best Hippocampus (anyone who finds a live hippocampus should have this one sewn up).

OTHER OPPORTUNITIES FOR GLORY: We'd like to arrange a "Meet the Artist" program within the Art Show area. This would be a series of informal events where willing artists could spend a little pre-advertised time chatting with admirers. We'd also like attending artists to be available for a general get-together with art(ist)? lovers one evening during the convention. We'll let you know when. There'll also be at least one artist panel on the general convention program, and you can volunteer for this, too. If you have any other ideas for artrelated programming, please share them with us.

## **HOTELS**

The Chicon hotels are a varied sample of the best accommodations in Chicago. Reservations will be handled centrally by the Hyatt Regency Chicago, the convention's headquarters hotel, and will take into account your preferences as stated on the hotel registration card you'll find in this PR. Mail your card early to get your first choice.

All hotels accept major credit cards and travellers checks, including international. Personal checks will be accepted for advance reservations, but make arrangements upon arrival for any other personal check payments to hotels.

We might as well mention that while all the hotels are aware their guests may show up in costume, and they adopt a fairly sanguine attitude about this, none of them are exactly thrilled about serving Darth Vader or a full-dress barbarian in a restaurant that expects a coat and tie. Choose your restaurants accordingly. You'll fit right in some places, though; the Palmer House lobby practically requires Edwardian attire and the space-age Marriott lobby cries out for 2001 space suits.



THE HYATT-REGENCY CHICAGO, at 151 E. Wacker Drive, is the main convention hotel. By the time Chicon rolls around the hotel will have hosted two Windycons and so will be accustomed to us (poor souls).

Chicon has blocked 1900 of the Hyatt's 2033 rooms. This includes handicapped access rooms, but register <u>early</u>. All guest rooms are large and feature large bathrooms, color TV

(in-room movies available at extra cost) and AM-FM clock radios. Sleeping arrangements are one king-size, or two doubles, or two "oversize twin" beds per room. No pets are allowed. The room rates are about half the normal rate and very inexpensive for the area (they like us). Children under 18 stay free in their parent's or guardian's room.

If you've decided to spare no expense for accommodations, check out the Chicago suites at \$175, the Regency at \$200, and the State at \$225. The Monarch suites, combining to become the convention's hospitality suite, total 3200 square feet, with not one but two grand pianos, two fireplaces, and plenty of comfortable sit-down space. You can't have that one, but some of the other suites feature similar accoutrements.

<u>Parking:</u> There will be a special hotel-garage parking rate for Chicon members, but the rate has yet to be announced.

Restaurants: The Hyatt has five restaurants and, as you'd expect in this sort of hotel, prices range from modest to outrageous.

The Skyway serves breakfast and lunch, cocktails after hours. It's a bit expensive, but portions are generous. It offers the standard plus some unexpecteds, like Yogurt and Cucumber Soup and Vegetable Wellington. Beware the man with the orange juice; he will charge \$2.50 a glass.


Stetson's is a lunch and dinner place, mainly steaks but some fish and poultry included. Lunch menu has salads and sandwiches as well.

Scampi's is in the Hyatt's Atrium Lobby. It specializes in Northern Italian entrees, and has some interesting salads. Many entrees are expensive, but you can eat reasonably here by sticking to appetizers, salads and pasta. Scampi's is open for breakfast, lunch and dinner, and is currently open 24-hours.

Captain Streeter's currently serves breakfast, lunch and dinner, with a magnificent Sunday brunch. This restaurant is being considered for 24-hour status during the convention.

Mrs. O'Leary's serves lunch and dinner; salads and sandwiches for lunch. Dinner entrees start at about \$10 to \$20 for beef, fresh fish and other standard fare. Dessert menu will cause caloric greed.

Truffles is the Hyatt's first-class continental restaurant, prices in keeping with that reputation. Figure a minimum of \$25 per person. Many of the entrees come garnished with the namesake fungus.



THE PALMER HOUSE is an elegant, older hotel in the style of the Parker House in Boston or the Waldorf-Astoria in New York. If you are coming to Chicago a few days early to sight-see, this is the closest hotel to the attractions of Chicago's Loop. It is the farthest from the Hyatt, however, so the Palmer House is offering the lowest room prices, quite a savings from the median \$85 a night. If you are traveling in a large group, you can request connecting rooms. Room refrigerators can be obtained, but the supply is limited, so request one when you register and register early.

The rooms are moderate to small-sized, newly redecorated, and homey in an older, comfortable vein. The hotel is sandwiched into the south end of the State Street Mall, between commercial highrises, so do not expect a magnificent view. Handicapped-accessible rooms are being renovated; 20-30 are expected to be ready in time for Chicon. Some rooms are too small for cribs or rollaways, so register early to request these. One-bedroom parlor suites start at \$130, two-bedroom suites with parlor at \$330 a night.

Please note that the management, in keeping with the hotel's discreet reputation, requests no loud parties in the guest rooms. If you want a quiet place to retire, this is it.

Parking is available at several lots nearby for a range of prices. Indoor parking at the Mid-Continental Building on Wabash Avenue currently costs \$6 a day for Palmer House guests. At the Monroe Street garage, a city-owned public lot, underground parking is \$4.50 a day. No re-entry privileges are available at either lot.

The restaurants at the Palmer House are moderate to expensive. The coffee shop is open for breakfast and lunch. The French Quarter has breakfast and lunch buffets, as well as entrees from the largely-Creole menu. Palmer's Steak House is popular with the State Street business lunch crowd and also serves dinner. The Den, a pub, serves huge roast beef sandwiches and other fare during lunch.

The expensive set starts with the Empire Room, at this point open only for lunch, the Polynesian-style Trader Vic's for lunch and dinner ('til midnight) and finally the Gaslight Club, a latenight show-and-supper club for members and Palmer House guests only. All restaurants are wheel-chair accessible (some with a little fiddling, like going through a back entrance) as are all public parts of the hotel.



THE MARRIOTT is just a couple blocks north of the Hyatt, across the Chicago River on the Magnificent Mile, an area on north Michigan Avenue that glitters with the city's most elegant shops and restaurants. The hotel boasts a fair sample of these, and if you are a habitual window shopper you will have a hard time getting out the front door. The back door opens onto Rush Street, famous for restaurants, discos, and all manner of nightlife.

Rooms are moderate to large-sized, boasting huge picture windows with a great view. Rooms have color TV (in-room movies extra) and AM-FM radio. Refrigerators are available only in the suites. Twenty handicapped-access rooms are available, and all guest rooms are big enough for a wheelchair to maneuver. The pubs, part of the lobby and other public parts of the hotel may pose problems, though.


Rooms are available with two double beds, or a king-size or queen-size bed. Children under 18 stay free with an adult. One-bedroom suites start at \$225, spectacular bi-level suites start at \$425.

Recreational facilities include platform tennis and a health club with lap pool and whirlpool, at no charge to guests except court time and lockers. For more sedentary relaxation, there's a good-sized electronic games parlor.

Parking is available at two outdoor lots, one at Rush and Ohio (currently \$6.75 a day) and a city-owned lot at Rush and Grand which costs \$4.05 a day but closes from midnight to 6 a.m. There are no in-out privileges at either lot.

Restaurants at the Marriott are reasonably priced for the area. JW's is the expensive one. The Fourth Edition is a late-night cocktails and hors d'oeurves bar. La Plaza serves buffet lunch and steaks, etc. for dinner (the salad bar is a knockout) and Allie's Bakery is open for breakfast, lunch and dinner. There is 24-hour room service.





THE EXECUTIVE HOUSE is the closest hotel to the Hyatt, down the block and across Michigan Avenue. It's a small hotel, and not as highly advertised as the other Chicon hotels, but it has a charm and warmth you wouldn't expect in an American big-city hotel. It was designed as a residence hotel, which means the rooms are spacious and each has a counter area with wet bar and refrigerator. There's room service for the lazy and a 6th-floor vending machine pantry. The hotel has several amenities, one of which is the free in-room movies. Another is the view. Most rooms have a small balcony that looks out on the lake, the Chicago River, the Magnificent Mile or combinations thereof. Amazing!

Handicapped access is a problem, though. There are steps leading into the hotel, although the hotel staff can put down a temporary ramp on request. The bathroom doors in the guest rooms are just too narrow for wheelchairs.

Restaurants. The Executive House has two restaurants, both accessible. Seasons in the Penthouse is an art-deco room with a great view, serving steaks and continental cuisine. It is moderately expensive (\$15 to \$20 entrees). The Chicago Storage Company has a good reputation as an after-work drinks and dinner place. It is open for breakfast, lunch and dinner, and may lengthen its hours if business warrants. This restaurant can accommodate special diets with advance notice, and the staff reacted surprisingly well when costumed diners appeared during the last Windycon.

Parking is indoors; an attendant parks your car and \$7.50 allows you in and out as much as you wish. The garage cannot accommodate vans or trucks, only regular passenger cars.

Recreational facilities are available to Executive House guests at special rates at two luxurious nearby health clubs. McClurg Court and

Downtown Court Club both have pools and rates are about \$5 a day plus court time. Tell the hotel concierge about the facilities you want and choose on the basis of his/her advice.

THE RADISSON is just 1-1/2 blocks north of the Hyatt. Old hands at Chicago traveling might remember it as the Sheraton Chicago. Older hands might remember it as the Medinah Temple. The lobby and guest rooms are newly remodeled, but no one has tampered with the magnificent architectural details in the public rooms, blending moorish and medieval styles. SCA people will feel right at home.

Incidentally, the Radisson has fannish experience; Windycon III was held there when it was still the Sheraton, and Capricon II will be held there in February '82.

The Radisson is the only Chicon hotel that allows pets, but they are tolerated rather than welcomed. Roscoe and Mephistopheles will have to stay in their cage or traveling carrier when no humans are in the room with them.

The guest rooms are spacious, newly remodeled in a rather spare contemporary style. Remodeling is still in process, so it's hard to say how many handicapped-access rooms will be finished—at least a dozen. The regular rooms have twins, double, two doubles, queen or king-sized beds. Rooms large enough to accommodate triples or quads are limited, so reserve these early.

The Radisson's swimming pool is the most decadent we've ever seen. Marble, carpeting, lights recessed behind carved arches—a Roman emperor's bath comes to mind. Hours are currently noon to 9 p.m., the same for the sauna. Pool hours may be extended.

Restaurants here come in all prices. The Cartouche is an inexpensive and imaginative coffee shop. Kenneth's Deli offers salads and sandwiches "for here or to go." The Sakkara Room is currently remodeling but will probably be open by convention time for continental lunches and dinners. The Kon-Tiki Ports is renowned for Oriental-Polynesian food and decor. The little-bridges-over-reflecting-pools decor means this restaurant is not the best for wheelchair access, but the other restaurants are accessible.

<u>Parking</u> is the same as for the Marriott; the two lots on Rush Street are closest.

We believe Chicon offers accommodations to suit most needs and pockets. Wherever you stay (even Aunt Ruth's guest room), we look forward to seeing you in '82.



## **HUGO** Nominations Rules

#### PLEASE READ THE FOLLOWING INSTRUCTIONS CAREFULLY BEFORE NOMINATING

You must be a member of Chicon IV to nominate, or to vote on the final ballot. (Your membership number isn't required, but including it will save us a little work; your name and address are required.) If you aren't a member already, just fill out the required information and enclose the membership fee with your ballot. All nominations should be sent to Chicon IV, P.O. Box 5349, Chicago, IL 60680, and must be postmarked no later than March 15, 1982 to be counted. We will be counting these ballots as soon as possible, so if you share our faith in the Post Awful's ability to screw up, mail your ballot early. And if you live overseas, please use air mail.

We're distributing these ballots fairly early, so most of you should have at least a month before the nomination deadline. (Because surface mail moves very slowly when going to other continents, ballots are being distributed to our overseas members via air mail.) While we'd prefer that you not wait until the very last minute, we do hope that you'll take your time before voting. Please don't nominate the first stories that come to mind; consider your nomination carefully. If you have a serious question about the rules, write to us, and we'll try to find you an answer. But please, don't ask us to count words. You can get a rough number by counting the words in a typical page, and multiplying by the number of pages the story takes up.

You may make up to five nominations in each category; but if you wish to nominate a smaller number, or to make no nominations in a given category, feel free to do so. Please do not nominate "No Award," which under the rules must appear on the final ballot anyway. We have included spaces for the "source" under the fiction categories; you don't have to fill these out, but you can do so if you think your nomination is one we might not recognize. (It's a good idea to look them up anyway to make sure you have the title right.) PLEASE PRINT OR TYPE.

The following definitions of the Hugo categories are based on the World Science Fiction Society Constitution.

## Science Fiction Achievement Awards (Hugos)

BEST NOVEL: A science fiction or fantasy story of 40,000 words or more, appearing for the first time during the calendar year 1981. A work originally in a language other than English is also eligible if it first appeared in English translation in 1981. Publication date, or cover date in the case of a dated periodical, takes precedence over copyright date. A serial's date of appearance is taken to be the date of the last installment. Individual stories appearing as a series are eligible only as individual stories, and are not eligible taken together under the title of the series.

BEST NOVELLA: Same rules as for Best Novel, except the length must be between 17,500 and 40,000 words.

BEST NOVELETTE: Same rules as for Best Novel, except the length must be between 7,500 and 17,500 words.

BEST SHORT STORY: Same rules as for Best Novel, except the length must be less than 7,500 words.

BEST NON-FICTION BOOK: Any non-fiction work relating to the field of science fiction or fantasy.

BEST DRAMATIC PRESENTATION: Any production, in any medium, of dramatized science fiction or fantasy which was publicly presented for the first time in its present dramatic form during the calendar year 1981. Individual programs presented as a part of a series are eligible, but the series as a whole is not. (If you do nominate an individual program in a series, you'd better include the name of the series for identification.)

BEST PROFESSIONAL ARTIST: An illustrator whose work has appeared in the field of professionally published science fiction or fantasy during the calendar year 1981.

BEST PROFESSIONAL EDITOR: The editor of any professional publication devoted primarily to science fiction or fantasy during the calendar year 1981.


BEST FANZINE: Any generally available fannish publication devoted to science fiction, fantasy, or related subjects which has published four or more issues, at least one of which appeared during the calendar year 1981. (We are not going to even attempt to define "fannish" or "fanzine" in this limited space.)

BEST FAN WRITER: Any person whose writing has appeared in fanzines (as defined above) during the calendar year 1981.

BEST FAN ARTIST: An artist or cartoonist whose work has appeared in fanzines (as defined above) or through other public display during the calendar year 1981. Any person named on the final ballot in the Professional Artist category is ineligible for the Fan Artist award in the same year.

## John W. Campbell Award

FOR BEST NEW WRITER (sponsored by Davis Publications): Any writer whose first professionally published science fiction or fantasy story appeared during the calendar years 1980 or 1981. (Date of publication is defined in the same way as for the Hugo fiction awards.)

## CONSTITUTION

## of the World Science Fiction Society, October 1981

New provisions adopted at Denvention II are shown in bold face and areas of old wording that were deleted are shown in italics within square brackets ([]).

#### ARTICLE I — Name, Objectives, Membership, and Organization

- **SECTION 1:** The name of this organization shall be the World Science Fiction Society, hereinafter referred to as WSFS.
- **SECTION 2:** WSFS is an unincorporated literary society whose functions are:
  - A. To choose the recipients of the annual Science Fiction Achievement Awards (the Hugos),
  - B. To choose the locations and Committees for the annual World Science Fiction Conventions,
  - C. To attend those Conventions, and
  - D. To perform such other activities as may be necessary or incidental to the above purposes.
- **SECTION 3:** The Membership of WSFS shall consist of all people who have paid membership dues to the Convention Committee of the current World Science Fiction Convention.
- SECTION 4: Members of the Society paying the minimum fee towards membership with their site-selection ballots shall be members of the selected Convention with the right to receive all generally distributed publications. Such members may convert to members with the right of general attendance at the selected Convention and its Business Meeting by paying, within ninety (90) days of site selection, an additional fee, set by the selected Convention Committee, of not more than the minimum voting fee and not more than the difference between the voting fee and the attending fee for new members.
- SECTION 5: Authority and responsibility for all matters concerning the Convention, except those reserved herein to the Society, shall rest with the Convention Committee, which shall act in its own name and not in that of the Society.
- SECTION 6: Each Convention Committee should dispose of surplus funds remaining after accounts are settled for the current Convention for the benefit of the Society as a whole. Each Convention Committee shall retain an independent accountant at least a year before their Convention and shall publish a financial statement prepared by said accountant within ninety (90) days after their Convention and a final financial statement within a year.

#### ARTICLE II — Science Fiction Achievement Awards (the Hugos)

- **SECTION 1:** Selection of the Science Fiction Achievement Awards, known as the Hugos, shall be made as follows in the subsequent Sections of this Article.
- SECTION 2: Best Novel: A science fiction or fantasy story of forty thousand (40,000) words or more appearing for the first time during the previous calendar year. A work originally appearing in a language other than English shall also be eligible in the year in which it is first issued in English translation. A story, once it has appeared in English, may thus be eligible only once. Publication date, or cover date in the case of a dated periodical, takes precedence over copyright date. A serial takes its appearance to be the date of the last installment. Individual stories appearing as a series are eligible only as individual stories and are not eligible taken together under the title of the series. An author may withdraw a version of his work from consideration if he feels that that version is not representative of what he wrote. The Convention Committee may relocate a story into a more appropriate category if it feels that it is necessary, provided that the story is within five thousand (5,000) words of the new category limits.
- **SECTION 3:** Best Novella: The rules shall be the same as those for Best Novel, with length between seventeen thousand five hundred (17,500) and forty thousand (40,000) words.
- **SECTION 4:** Best Novelette: The rules shall be the same as those for Best Novel, with length between seven thousand five hundred (7,500) and seventeen thousand five hundred (17,500) words.
- **SECTION 5:** Best Short Story: The rules shall be the same as those for Best Novel, with length less than seven thousand five hundred (7,500) words.
- SECTION 6: Best Non-Fiction Book: Any non-fictional work relating to the field of science fiction or fantasy appearing for the first time in book form during the previous calendar year.
- **SECTION 7:**Best Dramatic Presentation: Any production in any medium of dramatized science fiction or fantasy which has been publicly presented for the first time in its present dramatic form during the previous calendar year. In the case of individual programs presented as a series, each program is individually eligible, but the series as a whole is not eligible.

#### ARTICLE II — Science Fiction Achievement Awards (the Hugos)

- **SECTION 1:** Selection of the Science Fiction Achievement Awards, known as the Hugos, shall be made as follows in the subsequent Sections of this Article.
- SECTION 2: Best Novel: A science fiction or fantasy story of forty thousand (40,000) words or more appearing for the

first time during the previous calendar year. A work originally appearing in a language other than English shall also be eligible in the year in which it is first issued in English translation. A story, once it has appeared in English, may thus be eligible only once. Publication date, or cover date in the case of a dated periodical, takes precedence over copyright date. The Convention Committee may relocate a story into a more appropriate category if it feels that it is necessary, provided that the story is within five thousand (5,000) words of the new category limits.

- **SECTION 3:** Best Novella: The rules shall be the same as those for Best Novel, with length between seventeen thousand five hundred (17,500) and forty thousand (40,000) words.
- **SECTION 4:** Best Novelette: The rules shall be the same as those for Best Novel, with length between seven thousand five hundred (7,500) and seventeen thousand five hundred (17,500) words.
- **SECTION 5:** Best Short Story: The rules shall be the same as those for Best Novel, with length less than seven thousand five hundred (7,500) words.
- **SECTION 6:** Best Non-Fiction Book: Any non-fictional work relating to the field of science fiction or fantasy appearing for the first time in book form during the previous calendar year.
- **SECTION 7:** Best Dramatic Presentation: Any production in any medium of dramatized science fiction or fantasy which has been publicly presented for the first time in its present dramatic form during the previous calendar year. In the case of individual programs presented as a series, each program is individually eligible, but the series as a whole is not eligible.
- **SECTION 8:** Best Professional Artist: An illustrator whose work has appeared in the field of professionally published science fiction or fantasy during the previous calendar year.
- **SECTION 9:** Best Professional Editor: The editor of any professional publication devoted primarily to science fiction or fantasy during the previous calendar year.
- **SECTION 10:** Best Fanzine: Any generally available fannish publication devoted to science fiction, fantasy, or related subjects, which has published four (4) or more issues, at least one (1) of which appeared in the previous calendar year. The words "fanzine" and "fannish" shall be defined only by the will of the membership, and the Convention Committee shall impose no additional criteria.
- **SECTION 11:** Best Fan Writer: Any person whose writing has appeared in magazines of the type defined in Section 10 above.
- **SECTION 12:** Best Fan Artist: An artist or cartoonist whose work has appeared through publication in magazines of the type defined in Section 10 above or through other public display during the previous calendar year. Any person whose name appears on the final Awards ballot for a given year under the Professional Artist category shall not be eligible for the Fan Artist Award for that year.
- SECTION 13: Additional Category: Not more than one special category may be created by the current Convention Committee with nomination and voting to be the same as for the permanent categories. The Convention Committee is not required to create any such category; such action by a Convention Committee should be under exceptional circumstances only; and the special category created by one Convention Committee shall not be binding on following Committees. Awards created under this Section shall be considered to be Science Fiction Achievement Awards, or Hugos.
- SECTION 14: Name and Design: The Hugo Award shall continue to be standardized on the rocket ship design of Jack McKnight and Ben Jason. Each Convention Committee may select its own choice of base design. The name (Hugo) and the design shall not be extended to any other award.
- **SECTION 15:** No Award: At the discretion of an individual Convention Committee, if the lack of nominations or final votes in a specific category shows a marked lack of interest in that category on the part of the voters, the Award in that category shall be cancelled for that year. In addition, the entry "No Award" shall be mandatory in each category of Hugo on the final ballot. In any event, No Award shall be given whenever the total number of valid ballots cast for a specific category is less than twenty-five percent (25%) of the total number of final Award ballots (excluding those cast for No Award) received.
- SECTION 16: Nominations: Selection of nominees for the final Award voting shall be done by a poll conducted by the Convention Committee, in which each Society member shall be allowed to make five (5) equally weighted nomination in every category. [under rules determined by the Committee.] Nomination shall be solicited for, and the final Award ballot shall list, only the Hugo Awards and the John W. Capbell Memorial Award for Best New Writer. Assignment to the proper category of nominees nominated in more than one category, and eligibility of nominees, shall be determined by the Convention Committee. No nominee shall appear on the final Award ballot if it received fewer nominations than the lesser of either: five percent (5%) of the number of nomination ballots cast in that category, or the number of nominations received by the third-place nominee in that category.
- SECTION 17: Voting: Final Award voting shall be by mail, with ballots sent only to Society members. Final Award ballots shall include name, signature, address, and membership-number spaces to be filled in by the voter. Final Award ballots shall standardize nominees given in each category to not more than five (5) (six (6) in the case of tie votes) plus "No Award." The Committee shall, on or with the final ballot, designate, for each nominee in the printed fiction categories, one or more books, anthologies, or magazines in which the nominee appeared (including the book publisher or magazine issue date(s)). Voters shall indicate the order of their preference for the nominees in each category.

- SECTION 18: Tallying: Counting of all votes shall be the responsibility of the Convention Committee, which is responsible for all matters concerning the Awards. In each category, votes shall first be tallied by the voter's first choices. If no majority is then obtained, the nominee who places last in the initial tallying shall be eliminated and the ballots listing it as first choice shall be redistributed on the basis of those ballots' second choices. This process shall be repeated until a majority vote winner is obtained. The complete numerical vote totals, including all preliminary tallies for first, second, ... places, shall be made public by the Convention Committee within ninety (90) days after the convention.
- SECTION 19: Exclusions: No member of the current Convention Committee nor any publications closely connected with a member of the Committee shall be eligible for an Award. However, should the Committee delegate all authority under this Article to a Subcommittee whose decisions are irrevocable by the Convention Committee, then this exclusion shall apply to members of the Subcommittee only.

#### ARTICLE III - Future Convention Selection

- SECTION 1: The Society shall choose the location and Committee of the Convention to be held two (2) years from the date of the current Convention. Voting shall be by mail or ballot cast at the current Convention with runoff ballot as described in Article II, Section 18, and shall be limited to Society members who have paid at least [five dollars (\$5.00]] ten dollars (\$10.00) towards membership in the Convention whose site is being selected. The current Convention Committee shall administer the mail balloting, collect the advance membership fees, and turn over those funds to the winning Committee before the end of the current Convention. The minimum voting fee can be modified for a particular year by unanimous agreement of the current Convention Committee and all bidding Committees who have filed before the mail ballots are set. The site-selection voting totals shall be announced at the Business Meeting and published in the first or second Progress Report of the winning Committee, with the by-mail and at-convention votes distinguished.
- **SECTION 2:** Site-selection ballots shall include name, signature, address, and membership-number spaces to be filled in by the voter. Each site-selection ballot shall list the options "None of the above" and "No preference" after the bidders and with equal prominence. The minimum fee in force shall be listed on all site-selection ballots.
- SECTION 3: The name and address information shall be separated from the ballots and the ballots counted only at the Convention with two (2) witnesses from each bidding committee allowed to observe. Each bidding committee may make a record of the name and address of every voter. A ballot voted with first or only choice for "No preference" shall be ignored for site selection. A ballot voted with lower than first choice for "No preference" shall be ignored if all higher choices on the ballot have been eliminated in preferential tallying. "None of the above" shall be treated as a bid for tallying. If it wins, the duty of site selection shall devolve on the Business Meeting of the current Convention. If the Business Meeting is unable to decide by the end of the Convention, the Committee for the following Convention shall make the selection without undue delay. When a site and Committee are chosen by a Business Meeting or Convention Committee, they are not restricted by region or other qualifications and the choice of an out-of-rotation site shall not affect the regional rotation for subsequent years. If no bids qualify to be on the ballot, the selection shall proceed as though "None of the above" had won.
- **SECTION 4:** Bids from prospective Committees shall be allowed on the ballot by the current Convention Committee only upon presentation of adequate evidence of an agreement with the proposed sites' facilities, such as a conditional contract or a letter of agreement. To be eligible for site selection, a bidding committee must state the rules under which the Convention Committee will operate, including a specification of the term of office of their chief executive officer or officers and the conditions and procedures for the selection and replacement of such officer or officers. Written copies of these rules must be made available by the bidding committee to any member of the Society on request.
- SECTION 5: To ensure equitable distribution of sites, North America is divided into three (3) regions as follows: Western: Baja California, New Mexico, Colorado, Wyoming, Montana, Saskatchewan, and all states and provinces westward; Central: Central America, Mexico (except as above), and all states and provinces between Western and Eastern regions; and Eastern: Florida, Georgia, South Carolina, North Carolina, Virginia, West Virginia, Pennsylvania, New York, Quebec, and all states and provinces eastward. Convention sites shall rotate in the order Western, Central, Eastern region.
- SECTION 6: A Convention site outside of North America may be selected by a majority vote at any Convention. In the event of such outside Convention being selected, there shall be an interim Continental Convention in the region whose turn it would have normally been, to be held in the same year as the overseas World Science Fiction Convention, with rotation skipping that region the following year. To skip a region without giving it an interim Continental Convention shall require a three-quarters (3/4) majority vote. Selection of the site of such Continental Convention may be by vote of the Business Meeting or by such other method as the competing bidders might agree upon.
- **SECTION 7:** Each World Science Fiction Convention Committee shall provide a reasonable opportunity for bona fide bidding committees for the Convention to be selected one year hence to make presentations.
- SECTION 8: With sites being selected two (2) years in advance, there are therefore at least two Convention Committees in existence at any given time. If one should become unable to perform its duties, the surviving Convention Committee shall determine what it is to do, by mail poll of the Society if there is time for one, or by decision of the Committee if there is not time.

#### ARTICLE IV — Constitution and Powers of the Business Meeting

- SECTION 1: Any proposal to amend the Constitution of WSFS shall require for passage a majority of all the votes cast on the question at the Business Meeting of the Society at which it is first debated, and also ratification by a simple majority vote of those members present and voting at a Business Meeting of the Society held at the World Convention immediately following that at which the amendment was first approved. Failure to ratify in the manner described shall void the proposed amendment.
- **SECTION 2:** Any change to the Constitution of WSFS shall take effect at the end of the World Science Fiction Convention at which such change is ratified.
- **SECTION 3:** The conduct of the affairs of the Society shall be determined by this Constitution together with all ratified amendments hereto and such Standing Rules as the Business Meeting shall adopt for its own governance.
- SECTION 4: Business Meetings of the Society shall be held at advertised times at each World Science Fiction Convention. The current Convention Committee shall provide the Presiding Officer and Staff for each Meeting. Meetings shall be conducted in accordance with Robert's Rules of Order, Newly Revised, the Standing Rules, and such other rules as may be published by the Committee in advance.
- **SECTION 5:** The Constitution of WSFS, together with an explanation of proposed changes approved but not yet ratified, and the Standing Rules shall be printed by the current Convention Committee, distributed with the Hugo nomination ballots, and printed in the Convention book, if there is one.

## Standing Rules for the Governance of the Worldcon Business Meeting

New provisions adopted at Denvention II are shown in bold face and old provisions deleted at Denvention II are shown in italics within square brackets ([]).

- Business of the Annual Meeting of the World Science Fiction Society shall be transacted in one or more sessions called Preliminary Business Meetings and one or more Main Business Meetings. The first session shall be designated as a Preliminary Business Meeting. At least eighteen (18) hours shall elapse between the final Preliminary Business Meeting and the one or more Main Business Meetings. One Business Meeting session shall also be designated the Site-Selection Meeting where site-selection business shall be the special order of business.
- The Preliminary Business Meetings may not pass, reject, or ratify amendments to the Consitution, but the motions to "object to consideration", to "table", to "divide the question", to "postpone" to a later part of the Preliminary Business Meetings, and to "refer" to a committee to report later in the same Annual Business Meeting are in order when allowed by Robert's Rules. The Preliminary Business Meetings may alter or suspend any of the rules of debate included in these Standing Rules. Motions may be amended or consolidated at these Meetings with the consent of the original maker. Absense from these Meetings of the original maker shall consitute consent to amendment and to such interpretations of the intent of the motion as the Presiding Officer or the Parliamentarian may in good faith attempt. [The Preliminary Business Meeting may not pass, reject, or ratify amendments to the Constitution, but the motions to "object to consideration", to "table", to "divide the question", to "postpone" to a later part of the Preliminary Business Meeting, and to "refer" to a committee to report later in the same Business Meeting are in order. The Preliminary Business Meeting may alter or suspend any of the rules of debate included in these Standing Rules. Motions may be amended or consolidated at this Meeting with the consent of the original maker. Absence from this Meeting of the original maker shall constitute consent to amendment and to such interpretations of the intent of the motion as the Presiding Officer or the Parliamentarian may in good faith attempt.]
- The deadline for the submission of non-privileged new business shall be two hours after the official opening of the Convention or eighteen hours before the first Preliminary Business Meeting, whichever is later.
- Six (6) identical legible copies of all proposals requiring a vote shall be submitted to the Presiding Officer before the deadline given in Rule 3 above. All proposals or motions of more than seventy-five (75) words shall be accompanied by at least one hundred additional identical, legible copies for distribution to and intelligent discussion by the Meeting attendees unless they have actually been distributed to the attendees at the convention by the Convention Committee. All proposals or motions shall be legibly signed by the maker and at least one seconder. The Presiding Officer may accept otherwise qualified motions submitted after the deadline, but all such motions shall be placed at the end of the agenda. The Presiding Officer will reject as out of order any proposal or motion which is obviously illegal or hopelessly incoherent in a grammatical sense.
- Debate on all motions of less than fifty (50) words shall be limited to six (6) minutes. Debate on all other motions shall be limited to twenty (20) minutes; if a question is divided, these size criteria and time limits shall be applied to each section. Time shall be allotted equally to both sides of a question. Time spent on points of order or other neutral matters arising from a motion shall be charged one half to each side. The Preliminary Business Meeting may alter these limits for a particular motion by a majority vote.
- RULE 6: Debate on all amendments to main motions shall be limited to five (5) minutes, to be divided as above.
- While 7: Unless it is an amendment by substitution, an amendment to a main motion may be changed only under those provisions allowing modification through the consent of the maker of the amendment, i.e., second-order amendments are not allowed except in the case of a substitute as the first-order amendment.
- RULE 8: A person speaking to a motion may not immediately offer a motion to close debate or to refer to a committee.

Motions to close debate will not be accepted until at least one speaker from each side of the question has been heard, nor will they be accepted within one minute of the expiration of the time allotted for debate on that motion. The motion to table shall require a two-thirds vote for adoption.

- RULE 9: In keeping with the intent of the limitations on debate time, the motion to postpone indefinitely shall not be allowed.
- **RULE 10:** A request for a division of the house (an exact count of the voting) will be honored only when requested by at least ten percent (10%) of those present in the house.
- RULE 11: Motions, other than Constitutional amendments awaiting ratification, may be carried forward from one year to the next only by being postponed definitely or by being referred to a committee.
- RULE 12: These Standing Rules, and any others adopted by a Preliminary Business Meeting, may be suspended for an individual item of business by a two-thirds majority vote.
- The sole purpose of a request for a "point of information" is to ask the Presiding Officer or the Parliamentarian for his opinion of the effect of a motion or for his guidance as to the correct procedure to follow. Attempts to circumvent the rules of debate under the guise of "points of information" or "points of order" will be dealt with as "dilatory motions" as specified in Robert's Rules of Order, Newly Revised.
- Citations to Articles, Sections, or specific sentences of the Society Constitution or Standing Rules are for the sake of easy reference only. They do not form a part of the substantive area of a motion. Correct enumeration of Articles, Sections, and Rules and correct insertions and deletions will be provided by the Secretary of the Business Meeting when the Constitution and Standing Rules are certified to the next Worldcon. Therefore, motions from the floor to renumber or correct citations will not be in order. The Secretary will also adjust any other Section of the Constitution equally affected by an amendment unless otherwise ordered by the Business Meeting. Any correction of fact to the Minutes or to the Constitution or Standing Rules as published should be brought to the attention of the Secretary and to that of the next available Business Meeting as soon as they are discovered.
- RULE 15: At all sessions of the Business Meeting, the hall will be divided into smoking and non-smoking sections by the Presiding Officer of the Meeting.
- The World Science Fiction Society Business Meeting is a mass meeting of the Society's membership which the Convention is required to sponsor in accordance with the WSFS Constitution and these Standing Rules. Therefore, (1) the quorum is the number of people present and (2) the decisions of the Chair as to who is entitled to the floor are not subject to appeal. The motion to adjourn the Main Meeting will be in order after the amendments to the Constitution proposed at the last Worldcon Business Meeting for ratification at the current Business Meeting have been acted upon.
- RULE 17: If time permits at the Site Selection Meeting, bidders for the convention one year beyond the date of the Worldcon being voted upon will be allotted five (5) minutes each to make such presentations as they may wish.
- These Standing Rules shall continue in effect until altered, suspended, or rescinded by the action of any Business Meeting. Amendment, suspension, or rescission of these Standing Rules may be done in the form of a motion from the floor of any Business Meeting made by any member of the Business Meeting, and such action will become effective immediately after the end of the Business Meeting at which it was passed.

## **Business Passed on to Chicon IV**

ITEM 1: MOVED, to amend the WSFS Constitution as follows:

A) Insert the following as a new section in Article I:

Every Worldcon Committee shall include the following notice in each of its publications: "'World Science Fiction Society', 'WSFS', 'World Science Fiction Convention', 'Worldcon', 'Science Fiction Achievement Award', and 'Hugo Award' are registered service marks of the World Science Fiction Society, an unincorporated literary society."

B) Substitute "Hugo Awards" for all occurrences of "Hugos".

C) Insert "(hereinafter referred to as the Worldcon)" after the first occurrence of "World Science Fiction Convention" and substitute "Worldcon" for "World Science Fiction Convention" or "Convention" (except in the phrase "Continental Convention") thereafter.

- ITEM 2: MOVED, to amend Article IV, Section 2, of the WSFS Constitution by adding the following:

  except that no change imposing additional costs or financial obligations upon Convention Committees shall be binding upon any Committee already selected at the time when it takes effect.
- ITEM 3: MOVED, to amend Article II, Section 7, of the WSFS Constitution by altering the last sentence to read:

  In the case of individual programs presented as a series, each program is individually eligible, but the series as a whole is not eligible; however, a sequence of installments constituting a single dramatic unit may be considered as a single program (eligible in the year of the final installement).
- ITEM 4: MOVED; to amend Article III of the WSFS Constitution by inserting the following new section between the current Sections 3 and 4:

The deadline for bids from prospective Committees to be included on the ballot, as well as all information

needed for filing such bids, shall be published by the current Committee and sent to all members of the Society at least four (4) months before the deadline for such bids. (Publication in a progress report prior to the date specified shall meet this requirement.)


ITEM 5: MOVED, to amend Article II of thw WSFS Consitutiton by adding the following new section:

Extended Eligibility: In the event that a potential Hugo nominee receives extremely limited distribution in the year of its first publication or presentation, its eligibility may be extended for an additional year by a three-fourths (3/4) vote of the intervening Business Meeting of the Society.

ITEM 6: Report of the WSFS Mark Registration Committee: This Committee was continued at the Denvention II Business Meeting to seek protection for the names used by WSFS. It can be contacted through its Chairman, Donald Eastlake, Box N, MIT Branch Post Office, Cambridge, MA 02139, United States of America.

Report of the WSFS Constitution Drafting Committee: This Committee was formed at the Denvention II Business Meeting with instructions to report to Chicon IV. ## THE OFFICIAL CHICON IV OPERATION RATHOLE BALLOT

("Oh, my Ghod, Harriet, they're serious!")

This is history. Never before have so many been asked to fritter away so much for so little reason without apology. You can participate in this momentous undertaking. You can make history. You can sail bravely into this uncharted whirlpool of originality. You can also fill out and mail this ballot.

For those of you who missed PRs 1 and 2 (they have been mailed, haven't they?), a brief summary of the situation:

During the Chicago in '82 bid, some wiseacre suggested Chicon hold a contest for the most frivolous way to spend \$2-3000 of the convention's money. The fan community would submit ideas and the best ones, culled by a "committee of frivolous experts," (the exact phrase was coined later) would appear in Progress Report 3 for voting. The other wiseacres on the committee, incredibly, agreed.

So here we are with a budget item called "Operation Rathole" and \$2,000. The committee has pledged to perpetrate the top votegetter, plus other true Ratholes if funds remain. The criteria for a True Rathole are simple:

- 1. The Rathole must have no redeeming social value. At all. This rule is absolute.

We could combine all of these, devoting a separate car to each. Amazing how inventive fans get when they're not paying the \$1 fare.

If you vote for Rathole #1, feel free to note your favorite variation, or add another to the list.

#### RATHOLE #2—GROUCHOS

It's the universal funny disguise. Black-rimmed phony glasses, big nose, optional mustache. Silliest when worn over a pair of real glasses. Everybody's worn one. But have you all worn them at the same time in the same place? Several thousand of you?

Welcome to Rathole #2. Every attending member gets a "Groucho." Use optional but strongly encouraged.

#### RATHOLE #3—PIZZA

If you've never encountered the real "Chicagostyle" deep dish pizza, now's your chance. If you've never thought a convention hospitality suite could get crowded enough, this, too, is your chance. We can order pizza for everybody!

Well, not exactly. But we could order a lot of pizza, delivered from several of Chicago's best pizzarias on Thursday, Friday, Saturday and Sunday nights.

#### RATHOLE #4—I'D LIKE TO GET YOU ON A SLOW BOAT TO GRAND RAPIDS



#### RATHOLE #9 — ARCHAEOLOGY

Every big-time pro used to be a neophyte. Many of them were full-fledged neofans, scribbling long and rabid contributions to fanzines and prozine letter columns throughout their tortured adolescence (be it 1930's or 1970's). These people are now fine, respectable folks, and boy, are they glad those spurts of creativity are lost forever in stacks of old, moldering publications, never to be seen again.

Heh, heh.

Rathole #10 would fund a massive research project in search of the earliest published traces of now-recognized sf writers, editors, artists and others. This might have a historically redeeming value, and might serve as a beacon of hope to the furious scribblers of the 1980's. These undesirable social benefits must be weighed against the Rathole-approved fun of reading this stuff. We would naturally publish a Rathole Report to be distributed at the convention, suitably bound so it will last long enough to embarrass us later.


With \$2,000, we figure we can get a good-sized story out of this and maybe three or four
