Dear Dealer,

Getting your merchandise through customs is not that difficult, as long as you know how to do it.

You will need a 'Certificate of Origin' and a (proforma) invoice. (And a T2L or EUR 1 if you are from Europe).

But there are several options and in order to give a personal advise, we need to know a few things from you as soon as possible.

1. What kind of goods are you bringing to ConFiction.  
(be as specific as possible)
2. How do you transport the goods to Holland:  
A: by air in your baggage.  
B: as freight by a forwarder (land, sea or air)  
C: in your car. (specify: passenger car or van)
3. Where are you crossing the Dutch boarder.  
(this can be an airport, harbor or road).
- 4 The total value of your goods.
5. An estimation of the number of boxes or cases.
6. An estimation of the total weight.

As soon as we get this information from you, we will inform you about the best way to get your merchandise through customs. Including: what papers do you need, who to ask for etc.

P.S. On books and magazines the VAT (sales tax) in Holland is 6% and no import duty. On all other goods the VAT is 18.5% and the import duty ranging from 5% to 15%.  
(no import duty if you are from Europe).


