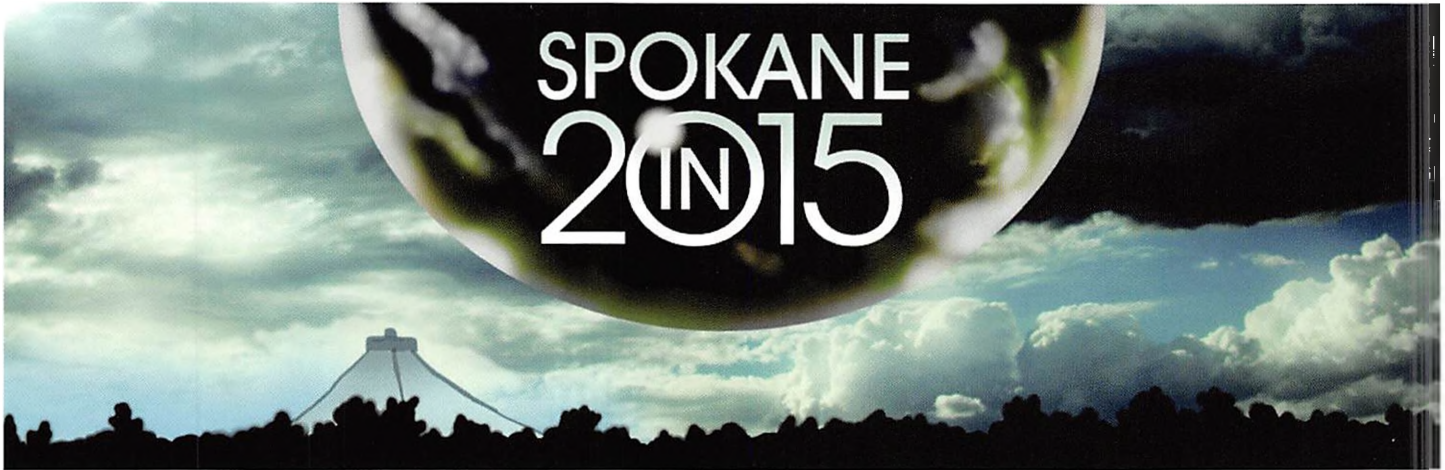

Housing Introduction

Hotel bookings will open Monday, January 21, 2013, starting at 8:00am CST. All bookings will be handled through the LoneStarCon website at <http://www.lonestarcon3.org/housing-introduction/index.shtml>

Fear not! Our helpful and friendly housing staff will be available to address accommodation requests and issues beginning January 21st as well. Of course, prior to this, they will be more than happy to answer any general questions you may have regarding our hotels. You can reach them at housing@lonestarcon3.org.

Accommodations for our members will be provided by two hotels: the Marriott Rivercenter and the Marriott River Walk. During the day, most of the Convention will be held in the Henry B. Gonzalez Convention Center. At night, most of the Convention activities, including the hotel room parties, will move to the Marriott Rivercenter.

Both hotels are conveniently situated near the Henry B. Gonzalez Convention Center and offer an easy access to the pleasant San Antonio River Walk. The River Walk, a pedestrian-only, fully wheelchair-accessible foot path, offers direct access to the Convention Center without having to face street traffic.

Both the Marriotts and the Convention Center were used for the previous San Antonio Worldcon. Those of you who attended in 1997 will already be familiar with our facilities. Though we will not be utilizing the expanded space, the Convention Center has been considerably expanded since we were last there and may look a bit different. All our facilities are nonsmoking and both Marriot hotels have the same room rates: \$154 for single or double occupancy, and \$175 for triple or quad occupancy.

The San Antonio Marriot River Walk

The River Walk is located directly across the street from the Convention Center, and is an entirely non-party hotel. With 375 rooms, this is the smaller of the two Marriotts.

Feeling a bit peckish? The River Walk features the Cactus Flower Restaurant a Tex-Mex restaurant open for breakfast, lunch and dinner. And of course, there's a Starbucks for that morning caffeine fix.

The San Antonio Marriot Rivercenter

Located just beyond the Marriott River Walk is the San Antonio Marriott Rivercenter, the larger of our two Convention hotels. The Marriott Rivercenter will play host

to the Hugo Awards Ceremony, Masquerade, evening/night convention programming, as well as the Con Suite and room/suite parties. There are plenty of rooms on both party and non-party floors as this is our largest hotel, with over 900 rooms and suites available.

Need a bite to eat and don't want to leave the hotel? Sozo's, a Spanish restaurant, is available for breakfast, lunch and dinner. The Bar offers casual light fare, refreshments, and cocktails in a relaxing environment. And of course, Starbucks Coffee is available for your coffee needs.

Both hotels have extended their room service availability to 24 hours for the duration of the convention.

With the rooms in the Rivercenter hotel, and the additional 375 being held at the River Walk, we will have more rooms at our disposal than almost any other Worldcon, since 2006 (well except for Chicon 7). We can also expand these blocks if necessary so there are more than plenty of rooms in both properties.

Making Reservations

All standard room reservations will be made through Passkey rather than directly through the hotels. This will also include any changes you might need to make to your reservations. The hotels, and the Marriott housing system, will not be able to see your reservations until they are transferred to the hotel systems on August 8th. **So, until that date, please do not contact the hotels about changes to your reservations, or with any questions about them.** They will not be able to assist you. Instead, please contact Passkey with those issues. After August 8th, you will be able to contact Marriott reservations concerning any changes or questions.

The housing page on the website will have full contact information for Passkey, along with the URL for making reservations, when reservations open on January 21st.

Reserving Rooms and Suites:

All rooms will be booked through Passkey, directly by you. The convention won't handle booking your rooms, although we will be glad to assist you if there are problems that Passkey's help desk can't handle. As always, the friendly housing staff will be available at housing@lonestarcon3.org should you encounter any problems with your reservations.

Suites can only be booked through the convention; Passkey cannot take reservations for suites, only regular sleeping

rooms. If you're interested in booking a suite, then please read the later article on booking suites; this will give you more information on the types available.

The Marriott Rivercenter is the party hotel. All parties, both in suites and regular room parties, may only be held there. The River Walk is an entirely quiet hotel.

There will be parties in the Rivercenter, and we love them! Keep in mind that parties there may only be held on the floors in the designated party block. The other floors in the hotel are quiet floors, and as such, parties cannot be held there.

In order to assist people who need the right number of beds in their rooms (and to avoid the problem of running out of two bedded rooms when people show up to register with four people), we have divided the reservation blocks for both

hotels into one bed and two bed blocks.

Please make sure you book into the correct block when making your reservations.

This means that, in the River Walk hotel, there will be two blocks from which to select when making your reservation – the one bed or two bed block. In the Rivercenter hotel, there will be four blocks to select from, since you will select between party and non-party, as well as the number of beds.

There will be more details about making reservations on our website when reservations open on January 21st.

Booking Party & Non-Party Suites

All of the suites at LoneStarCon can only be booked by requesting them from the convention, due to their limited availability. Meaning, we cannot be certain we have enough to handle all requests. It is likely that Party Suites will be rotated amongst people who desire them, if we don't have enough to fill all of the requests. All requests for suites must be made by emailing the convention at suites@lonestarcon3.org. If you want a suite, for a party or otherwise, please email suites@lonestarcon3.org, telling us what you want the suite for; the general type and price range you require and what nights you want it for.

All parties must be held in the Rivercenter, as this is the only hotel for which we have a corkage waiver. This waiver allows you to bring in your own food and beverages without being required to purchase them from the hotel. Party suites are available in a range of sizes from 500 to 1200 sq. ft. However, the party floors also include a large number of regular (370 sq. ft.) rooms ideal for smaller parties that don't need the extra space or cost of a suite, or for people who want convenient access to the parties. These rooms can be booked through the regular convention bookings page, at the standard rate. Be certain, when booking on the regular convention booking page for the Rivercenter, to select the party block. There will be links there to book both party and non-party rooms. Note that some of the suites include a bedroom, and additional connecting bedrooms are available for some of the suites. Those connecting bedrooms, like the suites themselves, can only be booked through the convention.

The suites vary in price, size and arrangement, from the smallest suites (the Junior Executive, sometimes referred to as the King Junior) at 500 sq. ft. to the Vice Presidential/Luxury suites at over 1200 sq. ft. Most of the suites include a bedroom area, and many can also have a connecting standard bedroom added for the standard amount. Suite pricing starts at \$231 for the cheapest suites, and increases to \$770 for a Luxury suite, or \$924 for a Presidential suite. More information on all the Rivercenter suite types available and the rates charged can be found on the convention web pages.

Not all of the suite types are available on either the party or non-party floors, but most of the smaller and medium sized suites can be found on both sets of floors.

The River Walk is a non-party hotel, but we do have a very small number of suites available for non-party uses. There are fewer than a half dozen of them – each different, but all about 500 square feet, and priced at \$385.



To make the best use of the available suites we will be taking suite reservations through March 31st. All reservations received by then will be treated as if they arrived on the same day for determining allocation. Requests received after this date will only be assigned after all earlier requests have been assigned. Requesters will hear from us as we make their suite allocations and all allocations should be completed by late May.

Exhibits

Art Show

The Art Show for LoneStarCon3 will be set up in Exhibit Hall A of the Henry B. Gonzalez Convention Center. This is the same area of the convention center as the Dealer's Room and special exhibits, among other items.

For the artists, we will be using display set-ups similar to those used in recent Worldcons. Our panels will be 4' x 4' and we are planning on keeping the fees in line with those charged in previous years in relation to the square footage per panel. The Art Show will also be taking a commission on sales made. All exhibiting artists will need to be a member of LoneStarCon3, supporting or attending. We will accept mail-in and agented art submissions. With agented submissions, the agent needs the membership, not the artist.

We will also be publishing an Artist Showcase. All artists registered for the Art Show are encouraged to send us a bio, a personal photo and a sample image of their artwork for publication.

There will be an Artists' Alley. This will be a portion of the Art Show footprint with tables for use by artists in the Art Show as well as last minute attendees. For artists in the Art Show, there will not be a fee for a table in the Artists' Alley, for last minute attendees, there will be. Sales in the Artists' Alley will be the responsibility of the artist, the Art Show will not be a party to, nor take a commission from, any sales in the Alley.

In the Art Show, we will have Quick Sales in order to allow one day members of the convention to take art home easily.

Dealer's Room

The Dealer's Room will be located in the Hall A of the Henry B. Gonzales Convention Center as it was in 1997 at LoneStarCon 2. We will be taking applications and deposits beginning January 1, 2013. All applications (with deposit) will be handled as they are received. Any dealer making application after the room is sold out will be placed on the wait list. There will not be a deposit required to be on the wait list. The room will be juried and the final decision as to who will be allowed to set up in the dealer's area will rest with the Dealer's Room management.

Tables will be 8ft x 30in and will be provided with 2 chairs each. Booths will be 10ft x 10ft and be provided with 2 chairs and 1 table each. Be prepared to bring your own table coverings. Electrical drops for the tables or booths will carry an additional charge. Each dealer may reserve a maximum of 5 tables or 3 booths. Booths will be located around the sides of the room and all tables will be in islands in the center.

A deposit of \$100 will be required to reserve each table or booth. Final pricing will begin at \$175 for a single table, \$250 each for multiple tables. Booths will be priced at \$750. Deposits will be applied to the final price of the tables or booths. Final payment will be due on or before July 31, 2013. All deposits will be refundable for dealers cancelling their reservation or otherwise not being in the room. Mail in applications should be sent to LoneStarCon3 at PO Box 27277, Austin, TX 78755, USA. Make checks payable to LoneStarCon 3.

All dealers and their helpers must have attending memberships before they will be allowed to set up in the room. In recognition of their mutually beneficial relationship between with the convention, dealers will be able to purchase up to two memberships at a special rate of \$180 for themselves or their helpers.

The Dealer's Room will be a non-smoking area. Food and beverages will not be allowed in the room (except for dealers and their helpers who must keep them in their booths or behind their tables.)

Returned checks will result in the dealer being moved to the bottom of the priority list and a second incidence will result in the dealer's reservation being permanently revoked.

All dealers are required to have a valid, current Texas Sales Tax License on file with us before opening of business on Thursday, August 29, 2013. Application information will be posted on the LSC3 website under Dealers. Please allow 3 weeks to complete the application.

There will be some restrictions on what types of merchandise can be sold in the room. Personal services such as massage, face painting or tattooing will be prohibited. Any other restrictions on merchandise or services will be published in a future Progress Report and on the website.

Dealer's Room hours will be 12 Noon to 6pm on Thursday, 10am to 6pm on Friday, Saturday and Sunday, and 10am to 3pm on Monday. Dealers will be allowed in the room early each day for opening set up.

Welcome Kiosk

One of the new ideas we're trying out this year is a Welcome Kiosk. Just after making it through registration, fans will be greeted by a large display explaining some basic information about the convention. The front side will feature basic information about Worldcon, meant mostly for first-time members, some of whom may never have been to any convention. The Code of Conduct will be posted on this side. It will also direct members to the other three sides, stating their purposes, and point out the locations of the most likely places a new arrival will need to know the locations of – Info Desk, Volunteers, Accessibility Services, and Program Participant Check-In.

The second side will focus on what there is to see and where it can be seen. Locations and times for the dealers' room, art show, film track, general programming, special events, and music will be featured on this side. This will include maps of the facilities and their environs, with some basic restaurant information as well.

The third side will focus on where and how to meet people. The consuite, fan tables, room parties, fan lounge, filk circles, and bar will feature here, along with basic etiquette for enjoying them. We also want to highlight kaffeeklatsches, gaming, and Strolling with the Stars here.

Finally, the fourth side will summarize the other three sides in Spanish. As we will be sharing our convention center with a Hispanic cultural event and plan on a Spanish-language track of programming, we want to make sure that we make Spanish-speaking fans as welcome as those who speak English.

Services

Accessibility Services

The location of LoneStarCon 3 is completely accessible by those who are mobility impaired. The Con Suite is on the mezzanine of the Marriott Rivercenter Hotel as is evening Filk and some other program items. Parties are in this hotel. There are 10 elevators here and you can rest assured that we will have a plan for those with mobies to get where they need to be with a minimum wait.

Child Care

We are in the process of negotiating with a professional childcare provider for LoneStarCon3. Childcare services will be available to all children aged 12 or under as of the start of the convention. Child memberships costing \$75 are available for all children in this age group. Children under 6 can attend the convention as Kids-in-Tow without paying a membership fee, but will pay a higher rate per hour than children with a membership. The Masquerade

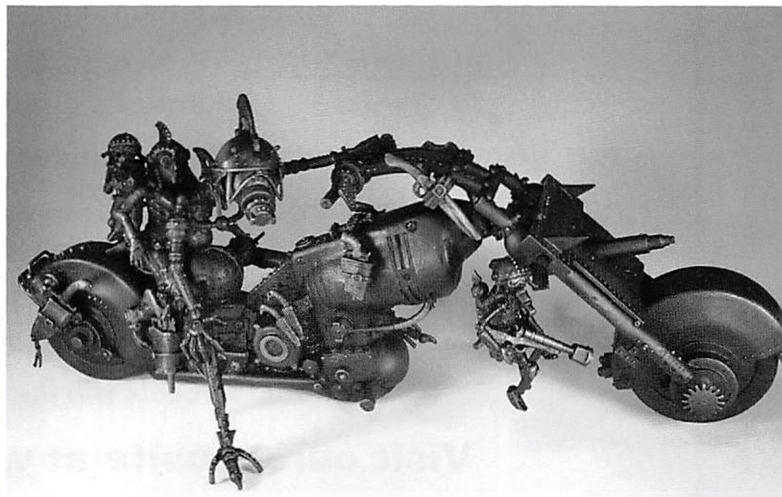

What's Up with These Odd Covers?

Brad W. Foster

After doing the six-covers-make-one-big-image series for the Progress Reports for LoneStarCon 2 back in 1995-1997, I always thought it would be fun to try another such large-scale project, though in a different way. So, when the folks behind LoneStarCon 3 said they were up to allowing me to play with all the covers once more (though only four of them would be available this time), I wanted to use this to add in a few new ideas.

The image is broken into four equal sections; PR#1 in the lower left section. The background of the image toward the right of the cover shows the simple rough pencil sketchiness of how my drawings start out. As your eye moves to the left and up, the background pencils get tighter and more controlled, the next phase of working on a drawing.

The cover for PR#2 is the upper left of the full image. Here the background shows the next stage of the drawing process, where I have now gone back over my pencils and redrawn everything once more, this time in tight ink lines, then erased and cleaned up all the pencils that remain. I think of this as the "coloring book" page, as everything is now finished in simple outline.

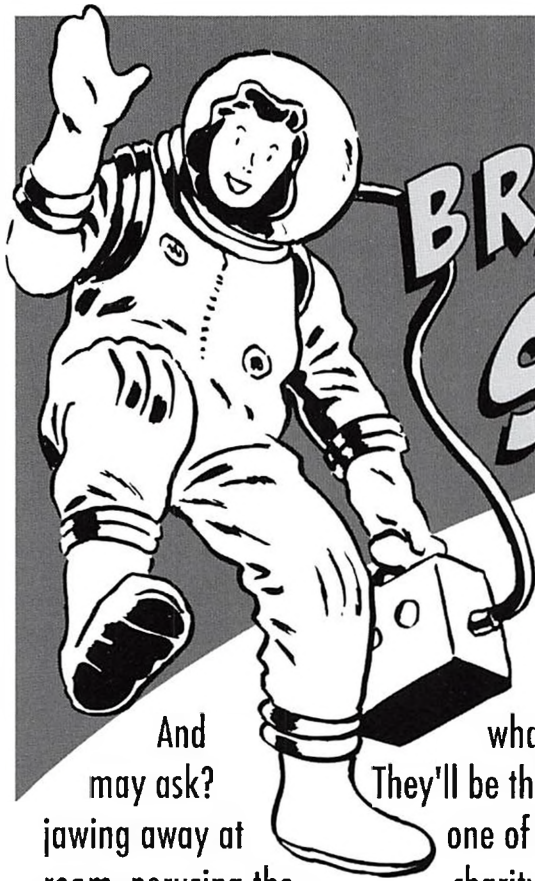
The cover for PR#3 moves to the upper right of the full image, and here I will start to drop in shadows and shade, where I move from the flat "coloring book" look to moving different levels away from each other.

The final cover for PR#4 will complete the progress of the art, and all the details will be executed at this point to finish the image, either in b&w ink or digital color, depending on where I would like the image to go. (At the writing of this short text, I am not totally sure which direction I will take the piece for the final cover!)

Each cover is also designed to have a few foreground elements to stand out from the background changes, completely finished using digital airbrush, which I think also makes for a nice "pop" look to the art. Once you have all four of the Progress Reports, set them side-by-side to form the complete full image, and you can then follow the progress of one drawing, within the drawing itself.

By the way, special note should go to cover designer Bill Child for taking my weird little idea here and making it all work with his layouts and color choices. I look forward as much as anyone else to seeing how each cover finally ends up!

- you are an Attending, Young Adult or Supporting Member of LoneStarCon 3 (the 2013 World Science Fiction Convention);
- or you had an Attending, Young Adult or Supporting Member of Chicon 7 (the 2012 World Science Fiction Convention);
- or you are an Attending, Young Adult or Supporting Member of LonCon 3 (the 2014 World Science Fiction Convention)

Deadline

All ballots must be received prior to March 10, 2013 11:59 pm EDT. Please mail as early as possible to ensure that your ballot will be counted. Paper ballots should be mailed to **Hugo Nominations, c/o Todd Dashoff, P.O. Box 310, Huntingdon Valley, PA 19006**. Taping the ballot shut is permissible in U.S. domestic mail; however, we recommend mailing your ballot in an envelope. Ballots mailed outside the U.S. or with payments enclosed must be in an envelope.

How to Nominate by Mail or Online

Please fill in the eligibility section on the previous page. Do not forget to sign the ballot—we will not count unsigned ballots.

- You may nominate up to five persons or works in each category. However, you are permitted (and even encouraged) to make fewer nominations or none at all if you are not familiar with the works that fall into that category. The nominations are equally weighted: the order in which you list them has no effect on the outcome.
- “No Award” will appear automatically in every category on the final ballot—there is no need to include that choice on the nomination form.
- If your nominee is not well known, please provide a source where his or her 2012 work in that category may be found. This information makes identifying the work you intend to nominate easier for us.
- Please type or print clearly. We cannot count illegible ballots.
- Please note that items may be relocated to a different category by the Hugo Awards Administrator if they are within 20% of the category boundary (such as in the case of Novel/Novella, Novella/Novelette, Novelette/Short Story, and Dramatic Presentation, Long Form/ Dramatic Presentation, Short Form).
- Online nominations will be available via the LoneStarCon 3 website: **www.lonestarcon3.org**. You will need your PIN to nominate via the web. PINs will be emailed to members, are included on the mailing label of your Progress Report, or you may e-mail **hugopin@lonestarcon3.org** to request a PIN.

The final Hugo Ballot containing the nominees in each category that received the most nominations will be distributed by LoneStarCon 3 in April/May 2013. Only members of LoneStarCon 3 (including those who join after January 31, 2013) will be eligible to vote on the final ballot. If you have any questions, feel free to pass them on to us at **hugoadmin@lonestarcon3.org**.

Eligibility

Works published in 2012 for the first time anywhere or for the first time in English are eligible for the Hugo Awards being awarded in 2013. Books are considered to have been published on the publication date, which usually appears with the copyright information on the back of the title page. If there is no stated publication date, the copyright date will be used instead. A dated periodical is considered to have been published on the cover date, regardless of when it was placed on sale or copyrighted. Serialized stories or dramatic presentations are eligible in the year in which the last installment appears.

Extended eligibility for non-US published works: The 2012 WSFS Business Meeting, as authorized by section 3.2.3 of the WSFS Constitution, passed a resolution providing that works originally published outside the United States prior to 2012 but first published in the United States of America in 2012 shall be eligible for the 2012 Hugo Awards, unless they have already appeared on a final Hugo Award ballot.

Other eligibility rules are included with the specific categories. The full rules for the Hugo Awards are contained in the WSFS Constitution, available at <http://www.lonestarcon3.org/wsfs/wsfs-bm-2013.shtml>, and printed in LoneStarCon 3's Progress Report 3, on page 26.

Exclusions

The LoneStarCon 3 Committee has irrevocably delegated all Hugo Administration authority to a subcommittee. Therefore, only Todd Dashoff, Saul Jaffe, Steven Staton, Ben Yalow and Vince Docherty are ineligible for the 2013 Hugo Awards.

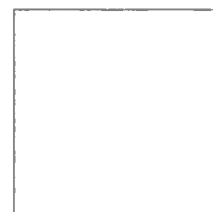

WSFS – Standing Rules

Standing Rules for the Governance of the World Science Fiction Society Business Meeting

Group 1: Meetings

Rule 1.1: Meeting and Session. The Annual Meeting of the World Science Fiction Society shall consist of one or more Preliminary Business Meetings and one or more Main Business Meetings. The first meeting shall be designated as a Preliminary Business Meeting. All meetings at a Worldcon (preliminary, main, or otherwise) shall be considered a single “session” as defined in the Parliamentary Authority (see section 5.1 of the WSFS Constitution), regardless of whether such gatherings are called “meetings” or “sessions.”

Rule 1.2: Preliminary Business Meeting(s). The Preliminary Business Meeting may not directly reject, pass, or ratify amendments to the Constitution; however, all motions adhering to a Constitutional amendment are in order if otherwise allowed. The Preliminary Business Meeting may not refer a Constitutional amendment to a committee unless the committee’s instructions are to report to the Main Business Meeting. The Preliminary Business Meeting may not postpone consideration of a Constitutional amendment beyond the last Preliminary Business Meeting. The Preliminary Business Meeting may not amend a Constitutional amendment pending ratification. The Preliminary Business Meeting may consider any business not expressly forbidden to it by the Standing Rules or expressly reserved to the Main Business Meeting.

Rule 1.3: Main Business Meeting(s). The Main Business Meeting may reject, pass, or ratify amendments to the Constitution. One Main Meeting shall be also be designated as the Site-Selection Meeting, where Site-Selection business shall be the special order of business.

Rule 1.4: Scheduling of Meetings. The first Main Meeting shall be scheduled no less than eighteen (18) hours after the conclusion of the last Preliminary Meeting. No meeting shall be scheduled to begin before 10:00 or after 13:00 local time.

Rule 1.5: Smoking. If smoking is allowed in the place where the Business Meeting is held, the Presiding Officer shall divide the room into smoking and nonsmoking sections at the beginning of each meeting.

Rule 1.6: Recording of Sessions. The Presiding Officer may arrange for the recording of meetings in any medium and for the distribution of such recordings. Individual members may also record meetings at their own discretion, subject to the will of the assembly as authorized by rule 5.9.

Group 2: New Business

Rule 2.1: Deadline for Submission of New Business. The deadline for submission of nonprivileged new business to the Business Meeting shall be fourteen (14) days before the first Preliminary Meeting. The Presiding Officer may accept otherwise qualified motions submitted after the deadline, but all such motions shall be placed at the end of the agenda.

Rule 2.2: Requirements for Submission of New Business. Two hundred (200) identical, legible copies of all proposals for nonprivileged new business shall be submitted to the Presiding Officer before the deadline in Rule 2.1 unless such proposals are distributed to the attendees at the Worldcon by the Worldcon Committee. All proposals must be legibly signed by a maker and at least one seconder.

Rule 2.3: Interpretation of Motions. The Presiding Officer shall reject as out of order any proposal or motion that is obviously illegal or hopelessly incoherent. In the absence of the maker of a motion or instructions to the contrary, the Presiding Officer shall be free to interpret the meaning of any motion.

Rule 2.4: Short Title. Any item of new business considered by the Business Meeting shall contain a short title.

Group 3: Debate Time Limits

Rule 3.1: Main Motions. The Presiding Officer shall designate the default debate time for main motions. The Business Meeting may, by majority vote, set the initial debate time limit for any motion to any positive whole number of minutes.

Rule 3.2: Allotment of Time. If a question is divided, the time limits applicable to the question before it was divided shall apply to each portion of the divided question. Debate time shall be allotted equally to each side of a question. Time spent on points of order or other neutral matters arising from a motion shall be divided equally and charged to each side.

Rule 3.3: Amendments. Debate on all amendments to main motions shall be limited to five (5) minutes, allotted equally to each side. Time spent on debate of an amendment shall be charged against the time for the main motion.

Rule 3.4: Motions Allowed After Expiration. Motions that adhere to the main motion shall not be out of order because of the expiration of debate time, but shall be undebatable.

WSFS Standing Rules (continued)

Rule 3.5: Minimum Substantive Debate. If the debate time expires before either or both sides of the question have had an opportunity for substantive debate, any side that has not had such an opportunity shall have two (2) minutes to be used solely for the purpose of substantive debate.

Group 4: Official Papers

Rule 4.1: Indicating Revisions. The Business Meeting staff shall clearly indicate all changes (including deletions) from the previous year's version when they provide the Constitution and Standing Rules for publication prior to the following Worldcon. However, the failure to indicate such changes shall not affect the validity of the documents.

Rule 4.2: Corrections. Any correction of fact to the Minutes or to the Constitution or Standing Rules as published should be brought to the attention of the Secretary of the Business Meeting in question and of the next available Business Meeting as soon as they are discovered.

Rule 4.3: Numbers, Titles, References, and Technical Corrections. Numbers and titles of the various parts of the Constitution and Standing Rules are for the sake of easy reference only. They do not form a substantive part of these documents nor of any motion to amend these documents. The Business Meeting Secretary shall incorporate into these documents appropriate changes as required by newly adopted amendments. When making any such adjustments required by this section, the Business Meeting Secretary shall change article and section numbers, titles, and internal cross-references as necessary to maintain a consistent, parallel structure, which shall not be altered unless the Business Meeting explicitly so directs. The Business Meeting Secretary may change punctuation, capitalization, grammar, and other wording in the Constitution and Standing Rules only insofar as such changes clarify meaning and enhance consistency, and only insofar as such changes do not modify the substantive meaning of the documents.

Rule 4.4: Submission Deadlines: Reports. All WSFS Committee Reports and all Worldcon Annual Financial Reports (see Constitution Section 2.9.1) shall be submitted to the Business Meeting by no later than fourteen (14) days before the first Preliminary Business Meeting.

Rule 4.5: Availability of BM Materials. All WSFS Committee Reports, Worldcon Annual Financial Reports, and New Business submitted to the Business Meeting before the 14-day deadline (see Rules 2.1 and 4.4) shall be made generally available to WSFS members (e.g. via publication on the host Worldcon's web site) by no later than ten (10) days before the first Preliminary Business Meeting.

Group 5: Variations of Rules

Rule 5.1: Nonstandard Parliamentary Authority. If a Worldcon Committee adopts for the governance of the Business Meeting a parliamentary authority other than that specified in the Constitution, the Committee must in timely fashion publish information about how to obtain copies of the authority in question.

Rule 5.2: Constitutional and Standing Rule Amendments. Motions to Amend the Constitution, to Ratify a Constitutional Amendment, and to Amend the Standing Rules shall be considered ordinary main motions, except as otherwise provided in the Standing Rules or Constitution. An object to consideration shall not be in order against ratification of a constitutional amendment.

Rule 5.3: Postpone Indefinitely. The motion to Postpone Indefinitely shall not be allowed.

Rule 5.4: Amend; Secondary Amendments. Secondary amendments (amendments to amendments) are not allowed except when the primary amendment is to substitute.

Rule 5.5: Previous Question. A person speaking to a motion may not immediately offer a motion to close debate. The motion for the Previous Question (also known as the motion "close debate," "call the question," and "vote now") shall not be in order when there is less than one minute of debate time remaining, nor when either or both sides of the debate have yet to speak to a question. Before voting on the motion for the Previous Question, the Presiding Officer shall, without debate, ask for a show of hands of those persons who still wish to speak to the matter under consideration.

Rule 5.6: Lay on the Table. The motion to Lay on the Table shall require a two-thirds (2/3) vote for adoption.

Rule 5.7: Adjournment. The incidental main motion to adjourn sine die shall not be in order until all Special and General Orders have been discharged.

Rule 5.8: Suspension of Rules. Rules protecting the rights of absentees, including this rule, may not be suspended.

Rule 5.9: Start/Stop Recording. If the meeting is being recorded, a motion to Stop Recording or to Start Recording is a privileged motion and shall be handled in the same way as a motion to Enter or Leave Executive Session.

Group 6: Mark Protection Committee Elections

Rule 6.1: Nominations. Nominations for election to the Mark Protection Committee shall be allowed from the floor at each Preliminary Business Meeting. To be listed on the ballot, each nominee must submit to the Secretary of the Business Meeting

the nominee's consent to nomination and the nominee's current region of residence. A nominee shall be ineligible if the nominee could not be elected due to the regional residence restrictions. The deadline for submitting such consent to nomination shall be set by the Secretary.

Rule 6.2: Elections. Elections to the Mark Protection Committee shall be a special order of business at a designated Main Business Meeting. Voting shall be by written preferential ballot with write-in votes allowed. Votes for write-in candidates who do not submit written consent to nomination and region of residence to the Presiding Officer before the close of balloting shall be ignored. The ballot shall list each nominee's name and region of residence. The first seat filled shall be by normal preferential ballot procedures as defined in Section 6.3 of the WSFS Constitution. There shall be no run-off candidate. After a seat is filled, votes for the elected member and for any nominee who is now ineligible due to regional residence restrictions shall be eliminated before conducting the next ballot. This procedure shall continue until all seats are filled. In the event of a first-place tie for any seat, the tie shall be broken unless all tied candidates can be elected simultaneously. Should there be any partial-term vacancies on the committee, the partial-term seat(s) shall be filled after the full-term seats have been filled.

Group 7: Miscellaneous

Rule 7.1: Question Time. During the Site-Selection Meeting, fifteen (15) minutes of program time shall be allocated to each future seated Worldcon committee. During the first five (5) minutes, each committee may make such presentations as they wish. The remaining time shall be allocated for questions to be asked about that committee's Worldcon. Questions may be submitted in writing at any previous meeting. Questions submitted in writing shall have priority over other questions if the person who submitted the question is present and still wishes to ask the question. No person may ask a second question as long as any person wishes to ask a first question. Questions are limited to fifteen (15) seconds and responses to two (2) minutes. If time permits at the Site-Selection Meeting, committees bidding for the right to host any Worldcon whose selection will take place in the next calendar year shall be allocated five (5) minutes of program time to make such presentations as they wish. The time limits in this rule may be modified by majority vote.

Rule 7.2: Dilatory Actions; Misuse of Inquiries. The sole purpose of a "point of information" or "parliamentary inquiry" is to ask the Presiding Officer for an opinion of the effect of a motion or for guidance as to the correct procedure to follow. The Presiding Officer shall treat as dilatory any attempts to

circumvent the rules of debate under the guise of points of information, parliamentary inquiries, or other queries and requests.

Rule 7.3: Counted Vote. The Presiding Officer shall take a counted vote upon the request of ten percent (10%) of those members attending the meeting.

Rule 7.4: Carrying Business Forward. Motions other than Constitutional amendments awaiting ratification may be carried forward from one year to the next only by being postponed definitely or by being referred to a committee.

Rule 7.5: Continuing Resolutions. Resolutions of continuing effect ("continuing resolutions") may be repealed or amended by majority vote of subsequent Business Meetings without notice, and shall be automatically repealed or amended by applicable amendments to the Constitution or Standing Rules or by conflicting resolutions passed by subsequent Business Meetings.

Rule 7.6: Committees. All committees are authorized to organize themselves in any lawful manner and to adopt rules for the conduct of their business, which may include conducting balloting by mail and limiting debate, subject to any contrary provisions of the Constitution, the Standing Rules, or instructions given to the committee by the Business Meeting.

Rule 7.7: Nitpicking and Flyspecking Committee. The Business Meeting shall appoint a Nitpicking and Flyspecking Committee. The Committee shall: (1) Maintain the list of Rulings and Resolutions of Continuing Effect (2) Codify the Customs and Usages of WSFS and of the Business Meeting.

Rule 7.8: Worldcon Runners Guide Editorial Committee. The Business Meeting shall appoint a Worldcon Runners Guide Editorial Committee. The Committee shall maintain the Worldcon Runners Guide, which shall contain a compilation of the best practices in use among those who run Worldcons.

2012 WSFS Business Meeting

CONSTITUTION

of the World Science Fiction Society, as of September 2, 2012

Article 1

Name, Objectives, Membership, and Organization

Section 1.1: Name.

The name of this organization shall be the World Science Fiction Society, hereinafter referred to as WSFS or the Society.

Section 1.2: Objectives.

WSFS is an unincorporated literary society whose functions are:

- (1) To choose the recipients of the annual Hugo Awards (Science Fiction Achievement Awards).
- (2) To choose the locations and Committees for the annual World Science Fiction Conventions (hereinafter referred to as Worldcons).
- (3) To attend those Worldcons.
- (4) To choose the locations and Committees for the occasional North American Science Fiction Conventions (hereinafter referred to as NASFiCs).
- (5) To perform such other activities as may be necessary or incidental to the above purposes.

Section 1.3: Restrictions.

No part of the Society's net earnings shall be paid to its members, officers, or other private persons except in furtherance of the Society's purposes. The Society shall not attempt to influence legislation or any political campaign for public office. Should the Society dissolve, its assets shall be distributed by the current Worldcon Committee or the appropriate court having jurisdiction, exclusively for charitable purposes. In this section, references to the Society include the Mark Protection Committee and all other agencies of the Society but not convention bidding or operating committees.

Section 1.4: Membership.

The Membership of WSFS shall consist of all people who have paid membership dues to the Committee of the current Worldcon.

Section 1.5: Memberships.

1.5.1: Each Worldcon shall offer supporting and attending memberships.

1.5.2: The rights of supporting members of a Worldcon include the right to receive all of its generally distributed publications.

1.5.3: Electronic distribution of publications, if offered, shall be opt-in.

1.5.4: The rights of attending members of a Worldcon include the rights of supporting members plus the right of general attendance at said Worldcon and at the WSFS Business Meeting held thereat.

1.5.5: Members of WSFS who cast a site-selection ballot with the required fee shall be supporting members of the selected Worldcon.

1.5.6: Voters have the right to convert to attending membership in the selected Worldcon within ninety (90) days of its selection, for an additional fee set by its committee. This fee must not exceed four (4) times the site-selection fee and must not exceed the difference between the site-selection fee and the fee for new attending members.

1.5.7: The Worldcon Committee shall make provision for persons to become supporting members for no more than one hundred and twenty-five percent (125%) of the site-selection fee, or such higher amount as has been approved by the Business Meeting, until a cutoff date no earlier than ninety (90) days before their Worldcon.

1.5.8: Other memberships and fees shall be at the discretion of the Worldcon Committee.

Section 1.6: Authority.

Authority and responsibility for all matters concerning the Worldcon, except those reserved herein to WSFS, shall rest with the Worldcon Committee, which shall act in its own name and not in that of WSFS.

Section 1.7: The Mark Protection Committee.

1.7.1: There shall be a Mark Protection Committee of WSFS, which shall be responsible for registration and protection of the marks used by or under the authority of WSFS.

1.7.2: The Mark Protection Committee shall submit to the Business Meeting at each Worldcon a report of its activities since the previous Worldcon, including a statement of income and expense.

1.7.3: The Mark Protection Committee shall hold a meeting at each Worldcon after the end of the

Business Meeting, at a time and place announced at the Business Meeting.

1.7.4: The Mark Protection Committee shall determine and elect its own officers.

Section 1.8: Membership of the Mark Protection Committee.

1.8.1: The Mark Protection Committee shall consist of:

(1) One (1) member appointed to serve at the pleasure of each future selected Worldcon Committee and each of the two (2) immediately preceding Worldcon Committees

(2) One (1) member appointed to serve at the pleasure of each future selected NASFiC Committee and for each Committee of a NASFiC held in the previous two years, and

(3) Nine (9) members elected three (3) each year to staggered three-year terms by the Business Meeting.

1.8.2: No more than three (3) elected members may represent any single North American region, as defined in Section 1.8.5. Each elected member shall represent the region (if any) in which the member resided at the time they were elected.

1.8.3: Newly elected members take their seats, and the term of office ends for elected and appointed members whose terms expire that year, at the end of the Business Meeting.

1.8.4: If vacancies occur in elected memberships in the Committee, the remainder of the position's term may be filled by the Business Meeting, and until then temporarily filled by the Committee.

1.8.5: To ensure equitable distribution of representation, North America is divided into three (3) regions as follows:

(1) Western: Baja California, New Mexico, Colorado, Wyoming, Montana, Saskatchewan, and all states, provinces, and territories westward including Hawaii, Alaska, the Yukon, and the Northwest Territories.

(2) Central: Central America, the islands of the Caribbean, Mexico (except as above), and all states, provinces, and territories between the Western and Eastern regions.

(3) Eastern: Florida, Georgia, South Carolina, North Carolina, Virginia, West Virginia, Pennsylvania, New York, Quebec, and all states, provinces, and territories eastward including the District of Columbia, St. Pierre et Miquelon, Bermuda, and the Bahamas.

Article 2 - Powers and Duties of Worldcon Committees

Section 2.1: Duties.

Each Worldcon Committee shall, in accordance with this Constitution, provide for

- (1) administering the Hugo Awards,
- (2) administering any future Worldcon or NASFiC site selection required, and
- (3) holding a WSFS Business Meeting.

Section 2.2: Marks.

Every Worldcon and NASFiC Committee shall include the following notice in each of its publications:

"World Science Fiction Society," "WSFS," "World Science Fiction Convention," "Worldcon," "NASFiC," "Hugo Award," the Hugo Award Logo, and the distinctive design of the Hugo Award Trophy Rocket are service marks of the World Science Fiction Society, an unincorporated literary society.

Section 2.3: Official Representative.

Each future selected Worldcon Committee shall designate an official representative to the Business Meeting to answer questions about their Worldcon.

Section 2.4: Distribution of Rules.

The current Worldcon Committee shall publish the WSFS Constitution and Standing Rules, together with an explanation of proposed changes approved but not yet ratified. The Committee shall distribute these documents to all WSFS members at a point between nine and three months prior to the Worldcon, and shall also distribute them on paper to all WSFS members in attendance at the Worldcon upon registration.

Section 2.5: Bid Presentations.

Each Worldcon Committee shall provide a reasonable opportunity for *bona fide* bidding committees for the Worldcon to be selected the following year to make presentations.

Constitution (continued)

Section 2.6: Incapacity of Committees.

With sites being selected two (2) years in advance, there are at least two (2) selected current or future Worldcon Committees at all times. If one of these should be unable to perform its duties, the other selected current or future Worldcon Committee shall determine what action to take, by consulting the Business Meeting or by mail poll of WSFS if there is sufficient time, or by decision of the Committee if there is not sufficient time. Where a site and Committee are chosen by a Business Meeting or Worldcon Committee pursuant to this section, they are not restricted by exclusion zone or other qualifications.

Section 2.7: Membership Pass-along.

Within ninety (90) days after a Worldcon, the administering Committee shall, except where prohibited by local law, forward its best information as to the names and postal addresses of all of its Worldcon members to the Committee of the next Worldcon.

Section 2.8: Financial Openness.

Any member of WSFS shall have the right, under reasonable conditions, to examine the financial records and books of account of the current Worldcon or NASFiC Committee, all future selected Worldcon or NASFiC Committees, the two (2) immediately preceding Worldcon Committees, and the Committees of any NASFiCs held in the previous two (2) years.

Section 2.9: Financial Reports.

2.9.1: Each future selected Worldcon or NASFiC Committee shall submit an annual financial report, including a statement of income and expenses, to each WSFS Business Meeting after the Committee's selection.

2.9.2: Each Worldcon or NASFiC Committee shall submit a report on its cumulative surplus/loss at the next Business Meeting after its convention.

2.9.3: Each Worldcon or NASFiC Committee should dispose of surplus funds remaining after accounts are settled for its convention for the benefit of WSFS as a whole.

2.9.4: In the event of a surplus, the Worldcon or NASFiC Committee, or any alternative organizational entity established to oversee and disburse that surplus, shall file annual financial reports regarding the

disbursement of that surplus at each year's Business Meeting, until the surplus is totally expended or an amount equal to the original surplus has been disbursed.

Article 3 - Hugo Awards

Section 3.1: Introduction.

Selection of the Hugo Awards shall be made as provided in this Article.

Section 3.2: General.

3.2.1: Unless otherwise specified, Hugo Awards are given for work in the field of science fiction or fantasy appearing for the first time during the previous calendar year.

3.2.2: A work originally appearing in a language other than English shall also be eligible for the year in which it is first issued in English translation.

3.2.3: The Business Meeting may by a three-quarters (3/4) vote provide that works originally published outside the United States of America and first published in the United States of America in the current year shall also be eligible for Hugo Awards given in the following year.

3.2.4: A work shall not be eligible if in a prior year it received sufficient nominations to appear on the final award ballot.

3.2.5: Publication date, or cover date in the case of a dated periodical, takes precedence over copyright date.

3.2.6: Works appearing in a series are eligible as individual works, but the series as a whole is not eligible. However, a work appearing in a number of parts shall be eligible for the year of the final part.

3.2.7: In the written fiction categories, an author may withdraw a version of a work from consideration if the author feels that the version is not representative of what that author wrote.

3.2.8: The Worldcon Committee shall not consider previews, promotional trailers, commercials, public service announcements, or other extraneous material when determining the length of a work. Running times of dramatic presentations shall be based on their first general release.

3.2.9: The Worldcon Committee may relocate a story into a more appropriate category if it feels that it is necessary, provided that the length of the story is within the lesser of five thousand (5,000) words or twenty percent (20%) of the new category limits.

3.2.10: The Worldcon Committee may relocate a dramatic presentation work into a more appropriate category if it feels that it is necessary, provided that the length of the work is within twenty percent (20%) of the new category boundary.

3.2.11: A Professional Publication is one which meets at least one of the following two criteria:

(1) it provided at least a quarter the income of any one person or,

(2) was owned or published by any entity which provided at least a quarter the income of any of its staff and/or owner.

3.2.12: The Worldcon Committee is responsible for all matters concerning the Awards.

Section 3.3: Categories.

3.3.1: Best Novel. A science fiction or fantasy story of forty thousand (40,000) words or more.

3.3.2: Best Novella. A science fiction or fantasy story of between seventeen thousand five hundred (17,500) and forty thousand (40,000) words.

3.3.3: Best Novelette. A science fiction or fantasy story of between seven thousand five hundred (7,500) and seventeen thousand five hundred (17,500) words.

3.3.4: Best Short Story. A science fiction or fantasy story of less than seven thousand five hundred (7,500) words.

3.3.5: Best Related Work. Any work related to the field of science fiction, fantasy, or fandom, appearing for the first time during the previous calendar year or which has been substantially modified during the previous calendar year, and which is either non-fiction or, if fictional, is noteworthy primarily for aspects other than the fictional text, and which is not eligible in any other category.

3.3.6: Best Graphic Story. Any science fiction or fantasy story told in graphic form appearing for the first time in the previous calendar year.

3.3.7: Best Dramatic Presentation, Long Form. Any theatrical feature or other production, with a complete running time of more than 90 minutes, in any medium of dramatized science fiction, fantasy or related subjects that has been publicly presented for the first time in its present dramatic form during the previous calendar year.

3.3.8: Best Dramatic Presentation, Short Form. Any television program or other production, with a

complete running time of 90 minutes or less, in any medium of dramatized science fiction, fantasy or related subjects that has been publicly presented for the first time in its present dramatic form during the previous calendar year.

3.3.9: Best Editor Short Form. The editor of at least four (4) anthologies, collections or magazine issues (or their equivalent in other media) primarily devoted to science fiction and / or fantasy, at least one of which was published in the previous calendar year.

3.3.10: Best Editor Long Form. The editor of at least four (4) novel-length works primarily devoted to science fiction and / or fantasy published in the previous calendar year that do not qualify as works under 3.3.9.

3.3.11: Best Professional Artist. An illustrator whose work has appeared in a professional publication in the field of science fiction or fantasy during the previous calendar year.

~~3.3.12: Best Semiprozine. Any generally available non-professional publication devoted to science fiction or fantasy which by the close of the previous calendar year has published four (4) or more issues (or the equivalent in other media), at least one (1) of which appeared in the previous calendar year, and which in the previous calendar year met at least two (2) of the following criteria:~~

~~(1) had an average press run of at least one thousand (1000) copies per issue;~~

~~(2) paid its contributors and/or staff in other than copies of the publication;~~

~~(3) provided at least half the income of any one person;~~

~~(4) had at least fifteen percent (15%) of its total space occupied by advertising;~~

~~(5) announced itself to be a semiprozine.~~

3.3.12: Best Semiprozine. Any generally available non-professional periodical publication devoted to science fiction or fantasy, or related subjects which by the close of the previous calendar year has published four (4) or more issues (or the equivalent in other media), at least one (1) of which appeared in the previous calendar year, which does not qualify as a fancast, and which in the previous calendar year met at least one (1) of the following criteria:

(1) paid its contributors and/or staff in other than copies of the publication,

Constitution (continued)

(2) was generally available only for paid purchase,

~~3.3.13: Best Fanzine. Any generally available non-professional publication devoted to science fiction, fantasy, or related subjects which by the close of the previous calendar year has published four (4) or more issues (or the equivalent in other media), at least one (1) of which appeared in the previous calendar year, and which does not qualify as a semiprozine.~~

3.3.13: Best Fanzine. Any generally available non-professional periodical publication devoted to science fiction, fantasy, or related subjects that by the close of the previous calendar year has published four (4) or more issues (or the equivalent in other media), at least one (1) of which appeared in the previous calendar year, that does not qualify as a semiprozine or a fancast, and that in the previous calendar year met neither of the following criteria:

(1) paid its contributors or staff monetarily in other than copies of the publication,

(2) was generally available only for paid purchase.

3.3.14: Best Fancast. Any generally available non-professional audio or video periodical devoted to science fiction, fantasy, or related subjects that by the close of the previous calendar year has released four (4) or more episodes, at least one (1) of which appeared in the previous calendar year, and that does not qualify as a dramatic presentation.

Provided that unless this amendment is re-ratified by the 2016 Business Meeting, Section 3.3.14 shall be repealed, and

Provided that the question of re-ratification shall be automatically be placed on the agenda of the 2016 Business Meeting with any constitutional amendments awaiting ratification.

3.3.15: Best Fan Writer. Any person whose writing has appeared in semiprozines or fanzines or in generally available electronic media during the previous calendar year.

3.3.16: Best Fan Artist. An artist or cartoonist whose work has appeared through publication in semiprozines or fanzines or through other public display during the previous calendar year.

3.3.17: Additional Category. Not more than one special category may be created by the current Worldcon

Committee with nomination and voting to be the same as for the permanent categories. The Worldcon Committee is not required to create any such category; such action by a Worldcon Committee should be under exceptional circumstances only; and the special category created by one Worldcon Committee shall not be binding on following Committees. Awards created under this paragraph shall be considered to be Hugo Awards.

Section 3.4: Extended Eligibility.

In the event that a potential Hugo Award nominee receives extremely limited distribution in the year of its first publication or presentation, its eligibility may be extended for an additional year by a three fourths (3/4) vote of the intervening Business Meeting of WSFS.

Section 3.5: Name and Design.

The Hugo Award shall continue to be standardized on the rocket ship design of Jack McKnight and Ben Jason as refined by Peter Weston. Each Worldcon Committee may select its own choice of base design. The name (Hugo Award) and the design shall not be extended to any other award.

Section 3.6: "No Award."

At the discretion of an individual Worldcon Committee, if the lack of nominations or final votes in a specific category shows a marked lack of interest in that category on the part of the voters, the Award in that category shall be canceled for that year.

Section 3.7: Nominations.

3.7.1: The Worldcon Committee shall conduct a poll to select the nominees for the final Award voting. Each member of the administering Worldcon, the immediately preceding Worldcon, or the immediately following Worldcon as of January 31st of the current calendar year shall be allowed to make up to five (5) equally weighted nominations in every category.

3.7.2: The Committee shall include with each nomination ballot a copy of Article 3 of the WSFS Constitution and any applicable extensions of eligibility under Sections 3.2.3 or 3.4.

3.7.3: Nominations shall be solicited only for the Hugo Awards and the John W. Campbell Award for Best New Writer.

Section 3.8: Tallying of Nominations.

3.8.1: Except as provided below, the final Award ballots shall list in each category the five (5) eligible nominees receiving the most nominations. If there is a

tie including fifth place, all the tied eligible nominees shall be listed.

3.8.2: The Worldcon Committee shall determine the eligibility of nominees and assignment to the proper category of works nominated in more than one (1) category.

3.8.3: Any nominations for “No Award” shall be disregarded.

3.8.4: If a nominee appears on a nomination ballot more than once in any one category, only one (1) nomination shall be counted in that category.

3.8.5: No nominee shall appear on the final Award ballot if it received fewer nominations than five percent (5%) of the number of ballots listing one or more nominations in that category, except that the first three (3) eligible nominees, including any ties, shall always be listed.

3.8.6: The Committee shall move a nomination from another category to the work’s default category only if the member has made fewer than five (5) nominations in the default category.

3.8.7: If a work receives a nomination in its default category, and if the Committee relocates the work under its authority under subsection 3.2.9 or 3.2.10, the Committee shall count the nomination even if the member already has made five (5) nominations in the more-appropriate category.

Section 3.9: Notification and Acceptance.

~~Worldcon Committees shall use reasonable efforts to notify the nominees, or in the case of deceased or incapacitated persons, their heirs, assigns, or legal guardians, in each category prior to the release of such information. Each nominee shall be asked at that time to either accept or decline the nomination. If the nominee declines nomination, that nominee shall not appear on the final ballot. In addition, in the Best Professional Artist category, the acceptance should include citations of at least three (3) works first published in the eligible year.~~

3.9.1 Worldcon Committees shall use reasonable efforts to notify the nominees, or in the case of deceased or incapacitated persons, their heirs, assigns, or legal guardians, in each category prior to the release of such information. Each nominee shall be asked at that time to either accept or decline the nomination. If the nominee declines nomination, that nominee shall not appear on the final ballot.

3.9.2 In the Best Professional Artist category, the acceptance should include citations of at least three (3) works first published in the eligible year.

3.9.3 Each nominee in the categories of Best Fanzine and Best Semiprozine shall be required to provide information confirming that they meet the qualifications of their category.

Section 3.10: Voting.

3.10.1: Final Award voting shall be by balloting in advance of the Worldcon. Postal mail shall always be acceptable. Only WSFS members may vote. Final Award ballots shall include name, signature, address, and membership-number spaces to be filled in by the voter.

3.10.2: Final Award ballots shall list only the Hugo Awards and the John W. Campbell Award for Best New Writer.

3.10.3: “No Award” shall be listed in each category of Hugo Award on the final ballot.

3.10.4: The Committee shall, on or with the final ballot, designate, for each nominee in the printed fiction categories, one or more books, anthologies, or magazines in which the nominee appeared (including the book publisher or magazine issue date(s)).

3.10.5: Voters shall indicate the order of their preference for the nominees in each category.

Section 3.11: Tallying of Votes.

3.11.1: In each category, tallying shall be as described in Section 6.3. “No Award” shall be treated as a nominee. If all remaining nominees are tied, no tie-breaking shall be done and the nominees excluding No Award shall be declared joint winners.

3.11.2: No Award shall be given whenever the total number of valid ballots cast for a specific category (excluding those cast for “No Award” in first place) is less than twenty-five percent (25%) of the total number of final Award ballots received.

3.11.3: “No Award” shall be the run-off candidate for the purposes of Section 6.5.

3.11.4: The complete numerical vote totals, including all preliminary tallies for first, second, etc. places, shall be made public by the Worldcon Committee within ninety (90) days after the Worldcon. During the same

Constitution (continued)

period the nomination voting totals shall also be published, including in each category the vote counts for at least the fifteen (15) highest vote-getters and any other candidate receiving a number of votes equal to at least five percent (5%) of the nomination ballots cast in that category, but not including any candidate receiving fewer than five (5) votes.

Section 3.12: Exclusions.

No member of the current Worldcon Committee or any publications closely connected with a member of the Committee shall be eligible for an Award. However, should the Committee delegate all authority under this Article to a Subcommittee whose decisions are irrevocable by the Worldcon Committee, then this exclusion shall apply to members of the Subcommittee only.

Section 3.13: Retrospective Hugos.

A Worldcon held 50, 75, or 100 years after a Worldcon at which no Hugos were presented may conduct nominations and elections for Hugos which would have been presented at that previous Worldcon. Procedures shall be as for the current Hugos. Categories receiving insufficient numbers of nominations may be dropped. Once retrospective Hugos have been awarded for a Worldcon, no other Worldcon shall present retrospective Hugos for that Worldcon.

Article 4 - Future Worldcon Selection

Section 4.1: Voting.

4.1.1: WSFS shall choose the location and Committee of the Worldcon to be held two (2) years from the date of the current Worldcon.

4.1.2: Voting shall be by written ballot cast either by mail or at the current Worldcon with tallying as described in Section 6.3.

4.1.3: The current Worldcon Committee shall administer the voting, collect the advance membership fees, and turn over those funds to the winning Committee before the end of the current Worldcon.

4.1.4: The site-selection voting totals shall be announced at the Business Meeting and published in the first or second Progress Report of the winning Committee, with the by-mail and at-convention votes distinguished.

Section 4.2: Voter Eligibility.

4.2.1: Voting shall be limited to WSFS members who have purchased at least a supporting membership in the Worldcon whose site is being selected.

4.2.2: The supporting membership rate shall be set by unanimous agreement of the current Worldcon Committee and all bidding committees who have filed before the ballot deadline. If agreement is not reached, the default fee shall be the median (middle value) of the US dollar fees used in the previous three (3) Worldcon site selections.

Section 4.3: Non-Natural Persons.

Corporations, associations, and other non-human or artificial entities may cast ballots, but only for "No Preference." "Guest of" memberships may only cast "No Preference" ballots. Memberships transferred to individual natural persons may cast preferential ballots, provided that the transfer is accepted by the administering convention.

Section 4.4: Ballots.

Site-selection ballots shall include name, signature, address, and membership-number spaces to be filled in by the voter. Each site-selection ballot shall list the options "None of the Above" and "No Preference" and provide for write-in votes, after the bidders and with equal prominence. The supporting membership rate shall be listed on all site-selection ballots.

Section 4.5: Tallying.

4.5.1: The name and address information shall be separated from the ballots and the ballots counted only at the Worldcon. Each bidding committee should provide at least two (2) tellers. Each bidding committee may make a record of the name and address of every voter.

4.5.2: A ballot voted with first or only choice for "No Preference" shall be ignored for site selection. A ballot voted with lower than first choice for "No Preference" shall be ignored if all higher choices on the ballot have been eliminated in preferential tallying.

4.5.3: "None of the Above" shall be treated as a bid for tallying, and shall be the run-off candidate for the purposes of Section 6.5.

4.5.4: All ballots shall be initially tallied by their first preferences, even if cast for a bid that the administering Committee has ruled ineligible. If no eligible bid achieves a majority on the first round of tallying, then on the second round all ballots for

ineligible bids shall be redistributed to their first eligible choices, and tallying shall proceed according to Section 6.3.

4.5.5: If “None of the Above” wins, or if two or more bids are tied for first place at the end of tallying, the duty of site selection shall devolve on the Business Meeting of the current Worldcon. If the Business Meeting is unable to decide by the end of the Worldcon, the Committee for the following Worldcon shall make the selection without undue delay.

4.5.6: Where a site and Committee are chosen by a Business Meeting or Worldcon Committee following a win by “None of the Above”, they are not restricted by exclusion zone or other qualifications.

4.5.7: Where a site and Committee are chosen by a Business Meeting or Worldcon Committee following a tie in tallying, they must select one of the tied bids.

Section 4.6: Bid Eligibility.

4.6.1: To be eligible for site selection, a bidding committee must file the following documents with the Committee that will administer the voting:

- (1) an announcement of intent to bid;
- (2) adequate evidence of an agreement with its proposed site’s facilities, such as a conditional contract or a letter of agreement;
- (3) the rules under which the Worldcon Committee will operate, including a specification of the term of office of their chief executive officer or officers and the conditions and procedures for the selection and replacement of such officer or officers.

4.6.2: The bidding committee must supply written copies of these documents to any member of WSFS on request.

4.6.3: For a bid to be allowed on the printed ballot, the bidding committee must file the documents specified above no later than one hundred and eighty (180) days prior to the official opening of the administering convention.

4.6.4: To be eligible as a write-in, the bidding committee must file the documents specified above by the close of the voting.

4.6.5: If no bids meet these qualifications, the selection shall proceed as though “None of the Above” had won.

Section 4.7: Site Eligibility.

A site shall be ineligible if it is within five hundred (500) miles or eight hundred (800) kilometres of the site at which selection occurs.

Section 4.8: NASFiC

If the selected Worldcon site is not in North America, there shall be a NASFiC in North America that year. Selection of the NASFiC shall be by the identical procedure to the Worldcon selection except as provided below or elsewhere in this Constitution:

4.8.1: Voting shall be by written ballot administered by the following year’s Worldcon, if there is no NASFiC in that year, or by the following year’s NASFiC, if there is one, with ballots cast at the administering convention or by mail, and with only members of the administering convention allowed to vote.

4.8.2: NASFiC Committees shall make all reasonable efforts to avoid conflicts with Worldcon dates.

4.8.3: The proposed NASFiC supporting membership rate can be set by unanimous agreement of the administering Committee and all bidding committees who have filed before the ballot deadline. If agreement is not reached, the default fee shall be the median (middle value) of the US dollar fees used in the previous three (3) Worldcon site selections.

4.8.4: If “None of the Above” wins, or if no eligible bid files by the deadline, then no NASFiC shall be held and any supporting membership payments collected for the NASFiC site selection shall be refunded by the administering convention without undue delay.

Article 5 - Powers of the Business Meeting

Section 5.1: WSFS Business Meetings.

5.1.1: Business Meetings of WSFS shall be held at advertised times at each Worldcon.

5.1.2: The current Worldcon Committee shall provide the Presiding Officer and Staff for each Meeting.

5.1.3: Standing Rules for the Governance of the Business Meeting and related activities may be adopted or amended by a majority vote at any Business Meeting. Amendments to Standing Rules shall take effect at the close of the Worldcon where they are adopted; this rule may be suspended by a two-thirds (2/3) vote.

Constitution (continued)

5.1.4: Meetings shall be conducted in accordance with the provisions of (in descending order of precedence) the WSFS Constitution; the Standing Rules; such other rules as may be published in advance by the current Committee (which rules may be suspended by the Business Meeting by the same procedure as a Standing Rule); the customs and usages of WSFS (including the resolutions and rulings of continuing effect); and the current edition of Robert's Rules of Order, Newly Revised.

5.1.5: The quorum for the Business Meeting shall be twelve (12) members of the Society physically present.

Section 5.2: Continuation of Committees.

Except as otherwise provided in this Constitution, any committee or other position created by a Business Meeting shall lapse at the end of the next following Business Meeting that does not vote to continue it.

Section 5.3: Constitutional Pass-along.

Within two (2) months after the end of each Worldcon, the Business Meeting staff shall send a copy of all changes to the Constitution and Standing Rules, and all items awaiting ratification, to the next Worldcon Committee

Article 6 - Constitution

Section 6.1: Conduct.

The conduct of the affairs of WSFS shall be determined by this Constitution together with all ratified amendments hereto and such Standing Rules as the Business Meeting shall adopt for its own governance.

Section 6.2: Natural Persons.

In all matters arising under this Constitution, only natural persons may introduce business, nominate, or vote, except as specifically provided otherwise in this Constitution. No person may cast more than one (1) vote on any issue or more than one ballot in any election. This shall not be interpreted to prohibit delivery of ballots cast by other eligible voters.

Section 6.3: Electronic Voting.

Nothing in this Constitution shall be interpreted to prohibit conducting Hugo Awards nominating and voting and Site Selection voting by electronic means, except that conducting Site Selection by electronic means shall require the unanimous agreement of the current Worldcon committee and all bidding committees who have filed before the ballot deadline.

Valid paper ballots delivered by any means shall always be acceptable. This section shall not be interpreted to require that such elections be conducted electronically, nor shall it be interpreted to allow remote participation or proxy voting at the Business Meeting.

Section 6.4: Tallying of Votes.

Votes shall first be tallied by the voter's first choices. If no majority is then obtained, the candidate who places last in the initial tallying shall be eliminated and the ballots listing it as first choice shall be redistributed on the basis of those ballots' second choices. This process shall be repeated until a majority-vote winner is obtained. If two (2) or more candidates are tied for elimination during this process, the candidate that received fewer first-place votes shall be eliminated. If they are still tied, all the tied candidates shall be eliminated together.

Section 6.5: Run-off.

After a tentative winner is determined, then unless the run-off candidate shall be the sole winner, the following additional test shall be made. If the number of ballots preferring the run-off candidate to the tentative winner is greater than the number of ballots preferring the tentative winner to the run-off candidate, then the run-off candidate shall be declared the winner of the election.

Section 6.6: Amendment.

The WSFS Constitution may be amended by a motion passed by a simple majority at any Business Meeting but only to the extent that such motion is ratified by a simple majority at the Business Meeting of the subsequent Worldcon.

Section 6.7: Commencement.

Any change to the Constitution of WSFS shall take effect at the end of the Worldcon at which such change is ratified, except that no change imposing additional costs or financial obligations upon Worldcon Committees shall be binding upon any Committee already selected at the time when it takes effect.

Membership types

Attending:

This membership includes all publications, as well as voting and attending rights.

- **Adult:** Available for anyone 22 years or older as of September 2, 2013.
- **Young Adults (YA):** These Memberships are available for ages 17 to 21 as of September 2, 2013. Individuals in this age group can also be included in Family Memberships (see below). YA Memberships can only be transferred to people who also meet the YA age criteria.
- **Military Membership:** These Memberships are available for active duty or retired military as of September 2, 2013. Military ID will be required at registration.
- **Child:** Child Memberships are available for all children ages 16 or under as of September 2, 2013.
- **Family Memberships:** Family Memberships can be purchased for 2 adults and any number of dependent children ages 16 or under on September 2, 2013.

Supporting:

A Supporting Membership includes all of the rights and privileges of an Attending Membership, except the right to attend LoneStarCon 3. You can always upgrade your membership from Supporting to Attending by paying the difference between the Supporting and Attending Membership rates in force at the time of conversion.

If you voted in the 2011 WorldCon Site Selection election, you are automatically a Supporting Member of LoneStarCon 3 as a result of paying your voting fee.

Installment Payment Plan

The LoneStarCon 3 Installment Plan enables fans to spread the cost of an Attending Membership over a number of monthly payments. Under the Plan, you first buy a Supporting Membership and then pay the amount for conversion to Attending Membership in installments. The charge for your Attending Membership will be frozen at the time your application to join the Plan is received and accepted.

The benefits of the Plan are the lock-in of the rate (protecting you against future rate increases) and the opportunity to spread your costs over an extended period. Minimum payment per installment is U.S. \$30 (U.S. \$50 for a Family Membership). You can make your payments by credit card or by check (U.S. \$ only, please) sent to our U.S. office. Final payment must reach us no later than June 30, 2013. You can cancel your Plan at any time and any payments apart from the initial Supporting Membership will be returned to you.

Installment Plan Memberships are not transferable until the full amount has been paid. If you fail to complete payment by June 30, 2013, the rate will be unlocked and you will need to pay the current membership rate. Note that we are only able to provide Installment Plans for members paying in U.S. \$ by credit card or by check to our U.S. office.

To begin an Installment Plan, print out, fill out, and mail in the Installment Plan form (see link below). As an Installment Plan must begin with the purchase of a Supporting Membership, you may either print out, fill out and mail in the Membership form along with your payment, or you may purchase a Supporting Membership online. If you wish to do a Family Installment Plan, then the 2 adults in the Family must each purchase a Supporting Membership.

Once a Supporting Membership has been purchased, print out, fill out, and mail in the Installment Plan form (available at www.lonestarcon3.org/memberships). A paper form is needed so that we have a signature on file acknowledging that we will be automatically billing your credit card, or that you understand that you must make monthly payments by check.
