- 3. THE MAIN PURPOSE OF MAGI-APA IS TO KEEP COMMITTEE MEMBERS INFORMED ABOUT EVENTS. MEETINGS, CONVENTIONS, AND JUST ABOUT ANYTHING THAT MAY OR MAY NOT HAVE AN IMPACT ON THE BID. TO THIS EFFECT WE WELCOME CONTRIBUTIONS OF ANY KIND INCLUDING NEWS REPRINTS, ORIGINAL ARTICLES AND ESSAYS. ARTWORK, OPINIONS, ETC.
- 4. ALL OFFICERS AND COMMITTEE CHAIRMEN ARE EXPECTED TO CONTRIBUTE MINUTES OF COMMITTEE MEETINGS AND PROGRESS REPORTS OF COMMITTEE ACTIONS ON A REGULAR BASIS. HOPEFULLY COPIES OF ANY AND ALL MAGICON ARTWORK OR ADVERTISEMENTS CAN BE PRINTED IN THE APA.
- 5. IMPORTANT: THE **DEADLINES** FOR MAGI-APA ARE NOW SET BY THE EDITOR. PLEASE CALL WITH EXCUSES IF YOU ARE GOING TO BE LATE (I NEED A GOOD LAUGH!).
- 6. THE OFFICIAL EDITOR (OE) IS RESPONSIBLE FOR COLLATING THE CONTRI-BUTIONS, PRODUCING A TITLE PAGE, ROSTER, AND RULES PAGE, AND MAILING OUT THE APA'S. THE OE IS APPOINTED FOR A PERIOD OF ONE YEAR AND MAY BE REPLACED OR REINSTATED BY ACCLIMATION.
- 7. A) Steve Cole offers copying service for a very nominal amount to the committee! You need to send only the originals to the OE. Steve will charge the committee only 2.1 cents for single sided and 3.7 cents for double sided copies.
- B) Copy count requirements: Regular committee members currently number 20 and the subscribing associates currently number 14. The required number of copies for contributions shall be 40. This number will be adjusted as the membership changes.
- 8. If you do your own copying please try to have your contributions printed double sided to save on sheet counts and staples.
- 9. ALL MATERIAL ARRIVING TOO LATE FOR A MAILING WILL BE INCLUDED IN THE FOLLOWING MAILING.
- 10. ASSOCIATE MEMBERS WILL ONLY RECEIVE THE APA IF THEY SUBSCRIBE TO IT. THE CURRENT SUBSCRIPTION RATE IS \$10, WHICH WILL BE USED TO OFFSET COSTS OF POSTAGE AND ENVELOPES. THE APA WILL ONLY BE AS BIG AS THE CONTRIBUTIONS SO POSTAGE WILL VARY FROM ISSUE TO ISSUE. THE SUBSCRIBING ASSOCIATE MEMBERS WILL BE LISTED ON THE TITLE PAGE ALONG WITH THE AMOUNT DEDUCTED FROM THEIR \$10 FOR THE PREVIOUS ISSUE AN THE BALANCE.
- 11. PER THE RULING MADE AT THE SEPTEMBER, 1987 MEETING THE EDITOR RESERVES THE RIGHT TO NOT INCLUDE MATERIAL OF AN OVERLY CONTROVERSIAL NATURE.

#### General Directions:


#### From the South:

Take the Florida turnpike to the Fort Pierce exit, turn right and go 1/4 mile east to I-95. Take I-95 north approximately one hour till you reach exit 71 (U.S. 192) which is just north of mile marker 180. U.S. 192 is call New Haven Avenue. See map and paragraph below for detailed information.

## From Orlando:

Take the Beeline Expressway to I-95. Take I-95 south approximately 25 miles to exit 71 (U.S. 192) which is just south of mile marker 181.

Once arriving at the New Haven (U.S. 192) and I-95 intersection: Go east on New Haven about 4.2 miles until you reach the traffic light at New Haven and Dairy Road. Just to keep your bearings you will pass Melbourne Square Mall at approximately 3.2 miles. At the New Haven/Dairy Road traffic light there will be a Red Lobster on your right and a First Union Bank on your left. Turn left (North) onto Dairy Road and go about .3 or (1/3) miles. Espanola Way is the 2nd street on your right. Make a right onto Espanola Way. 905 is the 4th house on your right. It is a one story white house with a light brown and white shingle roof.

No other reimbursements of bid expenses will be made unless the convention has a surplus.
- 3. As stated above, presupporters will receive a \$5 discount on the purchase of their attending membership. There are currently over 1700 presupporters of our bid.
- 4. Magicon DOES NOT AND WILL NOT sell any "special privileges".
- III. 1. Magicon will be held in the Greater Orlando Metropolitan Area.
  - 2. The official expected dates of Magicon are Thursday, Aug. \_\_ through Monday, Sept. \_\_, 1992. We definitely encourage all attendees to come early and stay late.

  - e. We currently have a letter of agreement with all of the above facilities. [CLARION]

While it is too early for us to provide costs associated with our use of facilities in the Orange County Civic Convention Center and the Peabody Hotel, it is important to note that Florida is a "right-to-work" state and that both the Peabody Hotel and the Orange County Civic Convention Center routinely employ a non-union workforce. Magicon expects to have none of the difficulties with union workrules and requirements that many large conventions encounter.
  - 3. Our two largest function rooms are: Orange County Civic Convention Center

Hall A 48600 sq. ft.; 4700 max. seating cap. Orlando Feabody Hotel

Plaza International Ballroom 26680 sq. ft.; 3200 max. seating cap.

It is still too early to determine which activites best fit which which function rooms, although Hall A is certainly a good candidate to house the masquerade and the Hugo award presentation.

4. Our two largest exhibit halls are: Orange County Civic Convention Center

Hall C 80000 square feet
Hall B 70000 square feet

It is too early to determine which convention activities best fit these two huge exhibit halls, though clearly they could hold the dealers' room, art show, fixed exhibits, and still have room left over.

- 5. None of our facilities have previously hosted SF conventions.
- 6. There is abundant FREE parking at all of our hotels. For those attendees who wish to park at the convention center, there is currently a nominal charge of \$\_\_\_ per day.
