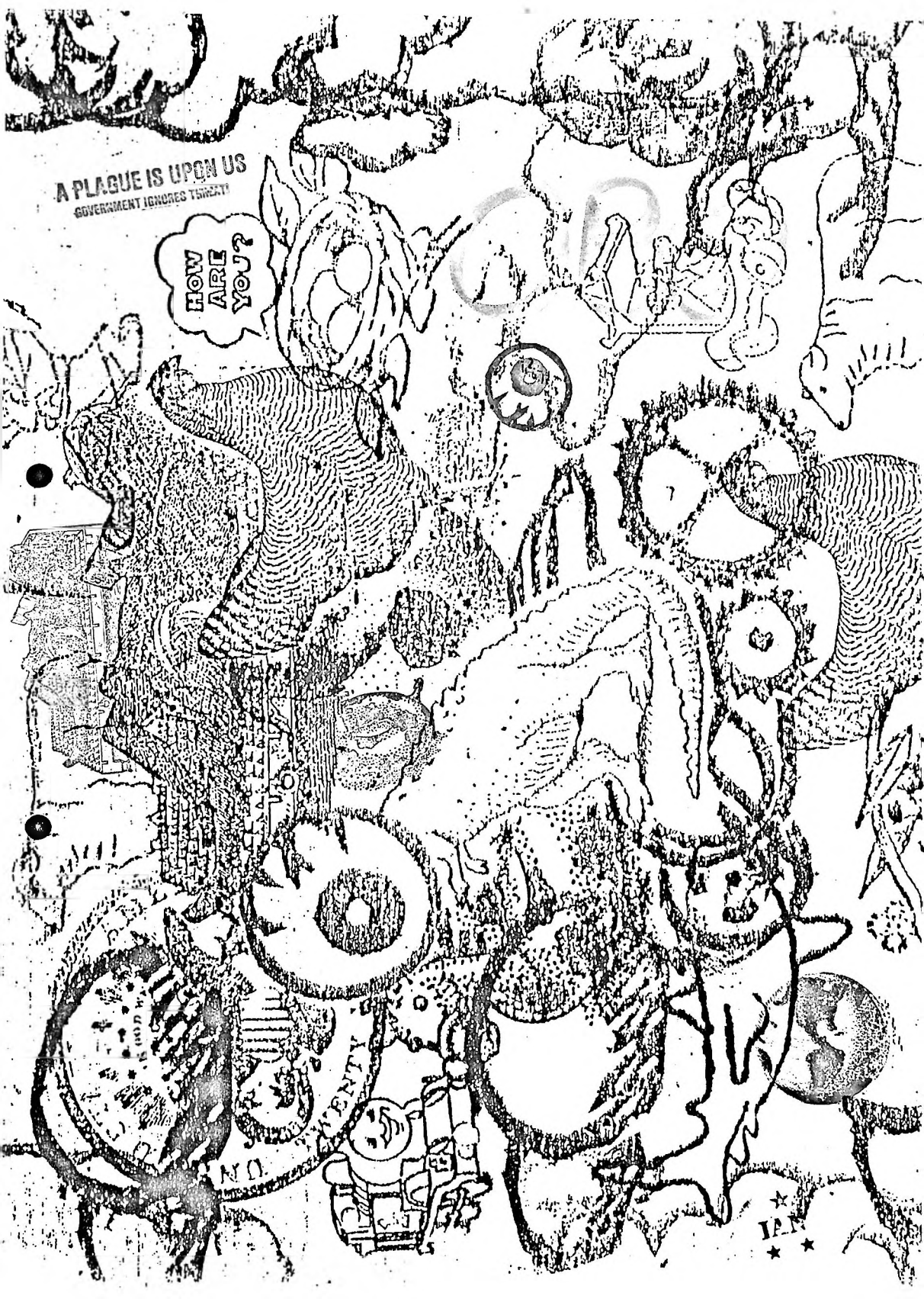

 All prices are listed in **Australian dollars (A\$)**.
 Make cheques payable to 'Alan Stewart'. Amounts in New Zealand or US dollars will incur a bank fee getting them cashed and changed.

Hand Delivery means you arrange to meet the editor and pick up your copy of the mailing at K&Ms, Myers Arcade, 6-7 pm or, if applicable, at a MSFC meeting, 7.30-10 pm, on the Friday following the deadline.

Lyn has written to me about the current 'surplus' in ANZAPA funds and I thought I'd raise a few points for discussion.

Current mailing costs (assuming 251-500 g Mailings, which #146 and #147 were)

If all mailings fall into the 251-500 g category, the expected cost for the year will be \$375.60 (not allowing for sample Mailings). Fees received in August/September are \$570.00 so we are likely to still have a surplus next year, unless there are 3-4 501-1000g mailings.

Possible suggestions for the surplus include:

- i) Donation to fan funds (DUFF, GUFF, FFANZ, TAFF)
- ii) Put it towards a mini-con/party for next year's ANZAPA 25th Anniversary
- iii) Have a 'one-off' reduction in fees by \$7 for everyone next year
- iv) Have a 'one-off' reduction of postage fees by \$10 next year

Write in with your thoughts, and hopefully we'll come up with a concensus in time for the June mailing.
