A couple of plans are afoot to reduce postage costs. I have bulk purchased C4 prepaid envelopes which means I can mail up to 500g A4 size, roughly an ANZAPA Mailing, within Australia for \$1.98 instead of the \$2.00 - \$2.65 mentioned last OBO, a small saving. There's the possibility Mark Loney might act as US 'clearing house' for ANZAPA mailings if he agrees and the internal US rates guaranteeing same time delivery as current air mail from Australia work out cheaper. I can air mail a Mailing to him for the same \$1.98 due to the type of posting he has, but I'm waiting on further cost details and his agreement before proceeding further. This arrangement would only be good for three years but may be worth the savings for this period.
