There's no Letter Bowl this.. I had a very intriguing metaphysical discussion all lined up for your enjoyment, but it turned out to be so long and so comprehensive in content that it would be almost topheavy for so slender a mag as this. Then, too, I'm too rushed right now to take the time to write it up. So, about all you'll find in this DREAM STUFF is Mailing Comments and a copy of my contribution to the Pitcon Memory Book.

However, I cannot pass up this one last chance to write up my ideas of what a good set of By-Laws should be. (Dietze, Raybin, Lichtman, Holland, et al take notice!)

#### Suggested BY-LAWS OF THE NEFFER AMATEUR PRESS SOCIETY

**PREAMBLE:** The NEFFER AMATEUR PRESS SOCIETY is an N3F Activity established for the convenience of N3F members who enjoy amateur publishing. It is an N3F subsidiary and has no separate identity apart from N3F.

#### ARTICLE I: Officers:

1. NAPS is a subsidiary to N3F, and, as such, is under the jurisdiction of the N3F Directorate and President, however, all internal matters and rulings dealing with administration shall be left to the discretion of the NAPS membership and OE.
2. There shall be an Official Editor elected annually from the NAPS members.
3. The OE shall have the necessary authority to handle emergencies or violations of NAPS rulings and to safeguard their activities.
4. In matters of administration, the decisions of the OE shall be final.
5. The duties of the OE shall be to receive individual magazines, keep the records, prepare the quarterly mailing bundle, post same, publish an official magazine of business (the OO) each mailing, and administer the details of conducting this activity.
6. In the event of sickness or failure on the part of the OE, the duties shall revert to the previous OE until the regular elections.
7. If the previous OE is unable to fulfill the duties, the N3F President shall appoint another member of NAPS to serve out the unexpired term.

#### ARTICLE II: Membership.

1. NAPS shall consist of ( \* ) paid up N3F members in good standing.
2. Application for membership in NAPS shall be made in writing, by the applicant, to the Official Editor.
3. No proxy applications are permitted.
4. There will be no dual memberships. Husbands and wives, or twins, may participate as one entity, but only one of them shall be considered the member. If both desire membership, the other may join in the usual manner.

\*Fill in your own number -- I really don't care what the membership is, so long as we pick a figure and stick with it! The turnover will be fast enough, no matter what.



5. If the quota is filled the applicant may be placed on a Waiting List from which vacancies shall be filled in chronological order.

6. The OE shall notify applicants each quarter as to their status on the Waiting List (preferably by a copy of the OO), requesting confirmation. Applicants failing to reply will be dropped from the Waiting List.

7. Any person dropped from the Membership Roster or Waiting List may re-apply for admission in the same channels as a new application, if desired. A place on the Roster or Waiting list which is forfeited cannot be re-instated except on proof of error.

#### ARTICLE III: Dues.

1. Dues shall consist of an additional \$1 added to the annual N3F dues and paid to the N3F Treasurer along with the regular dues. The N3F Treasurer will forward the NAPS dues to the OE together with a list of members paid up as of March 1st.

2. Any member who has not paid his dues prior to March 1 shall be dropped from the NAPS Membership Roster or the Waiting List.

3. In case of doubt, the burden of proof is on the member. A cancelled check, Postal Money Order receipt, or similar acknowledgement shall constitute grounds for re-instatement.

#### ARTICLE IV: Activity Requirements.

1. Each member must contribute at least 6 pages of substantially his own material every two mailings.

2. Any member failing to meet activity requirements for 2 consecutive mailings shall be dropped from the roster and his place given to an applicant from the W/L.

3. All material is subject to examination by the OE. Material likely to be in violation of Postal Regulations, or too illegible for normal reading, may be withdrawn from the mailing at the OE's discretion.

4. No activity credit may be given for material withdrawn from the mailing, but the activity deadline may be extended one mailing to permit the member to make it up.

5. Guest material by non-members is permitted in a member's fanzine, but material which is completely the work of non-members may be distributed under a member's frank only by arrangement with the OE with regard to postage and/or suitability.

6. If an applicant on the Waiting List has been notified of his admission as a member and the vacancy later proves to have been erroneous, the applicant shall be continued as a supernumerary member until the next vacancy.

#### ARTICLE V: Mailings.

1. Mailings shall go out quarterly, the 15th day of March, June, Sept. & Dec.

2. Deadline for receipt of material by the OE is the 10th of the month.

3. Postmailed material shall receive no credit, nor have official standing in the mailing, except by arrangement with the Official Editor.

4. Mailing contributions shall be submitted in at least (\* +5) identical copies.

5. Excess copies may, at the OE's discretion, be sold as surplus stock to N3F members, the money thus obtained to be applied to the NAPS Treasury.

6. The OE shall publish or cause to be published, a magazine of business (known as the Official Organ or by its fanzine title, if preferred) to be included in each mailing and listing the status of memberships, applicants on Waiting List, treasurer's report, plus whatever else of interest may pertain to the administration of NAPS.

#### ARTICLE VI: Elections & Voting.

1. Ballots for the Annual Election of the Official Editor shall be distributed in the December Mailing.

2. The Previous Official Editor shall be the Official Teller.

3. All votes cast must be in the hands of the Teller prior to February 1.

4. Records, money, and surplus stock must be in the hands of the new OE by Mar. 1.

5. Upon vote of 3/4 of the full NAPS membership, and subject to the approval of the N3F Directorate and President, these by-laws may be changed as necessary.

6. Nothing in these by-laws shall be construed as hampering the smooth, efficient administration of NAPS. The details of administration, subject to the limitations contained herein, shall be left to the OE unless proven unworthy of the trust. The N3F President may then invoke ART. 1, 6.

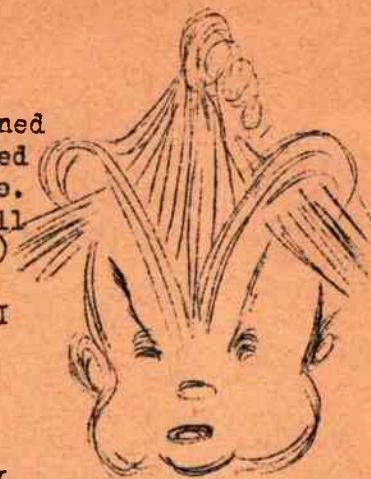

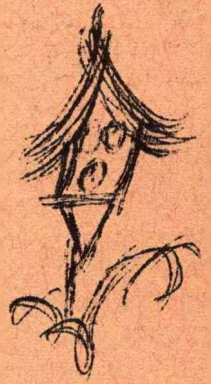
THE VAUX HALL FANATIC - Seth Johnson. Seth took a pretty severe ear-chewing on two counts, I see, and I should like to speak up in his defense. First, it really isn't entirely his fault that his repro is so lousy. Art Hayes has been running the stuff and Art has been having trouble with his own material. Secondly, I don't think Seth really understands what Belle is trying to put across. Sure, sex is a legitimate subject for discussion if it is being discussed, ie, being referred to in the course of debate. It's the sniggering sort of verbal masturbation which is indulged in for the erotic "thrill" of reading and writing nasty words, which is not suitable for this apa. Anybody who wants to get their 'kicks' out of seeing risqué words in print had better go see about getting PAPA revived.... As to the "love-starved" females who get their "thrill" out of indulging in erotic love-play via letter whos Seth mentions, I doubt very much they ever were fans or interested in fandom. Practically every section of this proposed revision is so snarled up in unnecessary qualifications and extraneous stipulations (some of them almost absurdly officious: for instance, "will be mailed first-class" -- why make such a foolish limitation? Who can force at this time the state of the NAPA treasury 10 years from now; or the bulk of future OOs, or even the Postal Regulations which may apply in the future?) I should regret very much to see these proposed "corrections" adopted. I think they are worse than what we already have. If any corrections are needed (and I agree they are) they should be in the nature of eliminating needless red tape, rather than adding more. All that we need in the way of By-Laws is a list of what this club needs done, and who is to do it, and how often. A broad outline of purpose, not a "Mother-In-Law type" of do-it-my-way minutia. A small club like this needs no more By-Laws than will fit on 1 page, merely a statement of purpose, membership, dues, frequency of distribution, and whatever activity requirements are decided upon. The administrative details should be left to the elected officials and so long as they get the job done, it is none of the business of anybody else how they go about doing it. After all, the By-Laws are merely supposed to give an outline -- not a detailed Chart of Instructions!

SONOMA #1 - Motcalf. I'm afraid I got lost 'way back there when you said you couldn't comment because you didn't have the mailings... I mean, if you haven't got the Mailings, how can you read 'em? This shouldn't come as a surprise to anyone, Ed. A nubile female is an unconscious mirror when it comes to reflecting the hobbies and interests of the males in the vicinity. Well, Eva, maybe you and Thoreau would, as you mentioned, "...rather sit on a pumpkin, and have it all to myself, than to be crowded on a velvet cushion" but I'd much rather be "crowded on a velvet cushion" -- especially by a handsome specimen of the opposite sex! Pumpkins are allright for pies, Jack-o-Lanterns and hiding secret documents, but I should judge they'd be rather uncomfortable for sitting. I can remember when I learned to read -- in fact, I can pinpoint the incident because it made such a dramatic impact. My older sister used to read fairy tales to me out of the library books I brought home. One day she was fixing up to go out on a date and I kept pestering her to read to me and she astonished me by the suggestion, "Why don't you read it yourself? You ought to know how to read by now, you've been reading in school... I'll help you with the hard words you don't know." This was a new idea to me because I had never connected the idea of the words I had memorized at school as having any relation with the library books, but inasmuch as she was adamant and I wanted a story, there was nothing for it but to try... So I did, running to her with every other word or so. I suspect it was more nuisance to her primping than if she'd taken time out to read it in the first place, but I did struggle through the page-and-a-half of text. When it was done, the realization flooded over my entire being (as the saying is) that I HAD READ A REAL STORY OUT OF A REAL BOOK! It was such a sense of achievement as I have never forgotten -- although I don't remember anything about the story itself except that the word I needed most help on was P\*R\*I\*N\*C\*E. That incident was the turning point, and from then on there was no holding me -- I had my nose in a book practically all my waking hours.

TULGEY WOOD #5 - Guy Terwilliger. "I find that I am...wondering if most apazines really have much value" says Guy, then turns around and supplies the answer, "Regardless of the fact that I like a good genzine, I still find that an apazine gives me an opportunity to know more of the real personality of various fan." This, of course, is the real value of an apazine. Attempting to evaluate an apazine by the same scale as a genzine is as futile as attempting to judge a letter from a friend on the same basis as a newspaper. Just because there is a superficial resemblance, ie, they both are written on paper, arrive via the mailbox, contain news and information, and must be perused in order to be appreciated, does not mean they have the same scale of value. However, while we are on the subject of the value of apas -- and the extension of further apa groups -- it has occurred to me that if the proposed Postal changes DO take place, it will increase the importance of the apas. The special rates which are under fire at the PO have never affected the large bundles of mags which are mailed out under Parcel Post rates. The only ones that would be affected would be the individual fanzines. If the single mags have to be mailed first class, it would obviously be prohibitive -- which would mean that apas would be about the only way we could distribute our zines without going broke in the process. Therefore, I suspect fanpublishing is likely to be confined to apazines, and the era of free "sample copies" being broadcast at random for letters of comment or exchange, is practically extinct. If it does turn out that way, apas will be springing up all over and may even have to merge for greater coverage. Bi-apas may disappear, with memberships of 100 or 200.





(Terwilliger, Cont'd) For instance, unless SAPS has changed a great deal since I left there is probably 1/3 to 1/2 of the membership which is bi-apan with FAPA and/or OMPA. And many of those who are not bi-apan, exchange fanzines with the members of the other apas. If Postal rates on individual fmz become excessive, it might be possible that out of sheer self-defense, these top-level apas might have to merge (which could be easily done, considering the high rate of lap-over.) I should guess that the combined memberships, once the bi-apan are merged, would come to little more than 100 or 150. Even if the combined membership included the Waiting Lists, I doubt it would come to more than 200. But supposing it did -- How many fans, outside of this minuscule NIAPA run less than 100 copies of their fanzine? My guess is that once the shock of readjustment is over, we'd find the same fanpubbers producing at their same regular rate and in much the same manner as before, but the only difference would be that instead of picking and choosing the fans with whom they wish to correspond, they would find it necessary to bundle off all their zines to one apa for distribution. Instead of having their choice of exchange mags, they'd be limited only to what they'd get thro the apa. This might turn out to be a very desirable innovation. Certainly, it would give some point and reason for the existence of different groups. And it would certainly give point and meaning to an NSF apa for newcomers. It is not beyond the bounds of probability that all the currently well-known and well-established fanpubbers might find themselves in one apa-group, with the newer (or less active) in another; from which vacancies in the older apa could be filled. I do not say this would be the inevitable result of too great a Postal hike, but I do think it might turn out that way.)

ZZZ - Berry/Hill. (Sounds appetizing, put that way...doesn't it?) Welcome, Berry. Glad to make your acquaintance. Alma, I certainly congratulate you for your effort to give meaning to the Classics in high school English. It certainly is time that somebody did... In most cases, the high school exposure to good literature acts only as an inoculation against it. I know in my case, the study of Shakespeare was so excruciating - both from the <sup>class</sup> reaction to Elizabethan four-letter-words spoken in mixed company, and the stumbling, bumbling attempts to read the unaccustomed language out loud - that to this day I cannot read Shakespeare for pleasure. The plays performed on stage, movie or TV, I enjoy immensely. But there just isn't any pleasure in reading it. In fact, this was true of all the books we had in highschool, but I was curious enough to hunt up and re-read them in later life when I was better able to understand and appreciate what I read. Now some of my favorite reading is Dickens, Jane Austen, Thackeray and the Brontes. But it was only because I fought against that high-school conditioning and managed to overcome it. In my opinion, this premature exposure of adolescent minds to great writing, is tragic. I was stubborn, so I learned to like it in spite of my highschool classes. But many students never did get over this unfortunate experience. A whole world of enjoyment was lost forever...needlessly.

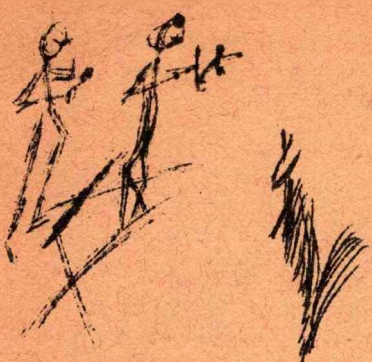

As I mentioned in my comments to Lichtman and Terwilliger, the by-laws and the size of the apa should conform to the needs of the group, rather than red-tape for its own sake. Elect a good OE, and then sit back and forget the details!





e - Joe Casey. That's a nice mag, Joe, and I like most of what's in it. But there's one thing in it that irks me so much I can't comment on the rest of the mag for sputtering and fuming at this one thing: I mean, that horrible affectation you picked up from one of the other kids back there, "NF<sup>3</sup>". Now, maybe you are still in grade school and haven't gotten around to studying Algebra yet. But when you do, you'll soon find out that "N3F" and "NF<sup>3</sup>" are two entirely different symbols! You try using them interchangeably and you're going to find yourself really screwed up in your calculations. Now, same thing here in N'APA. "N3F" means one letter "N" followed by 3 capital "F" -- it is a contraction, legitimate, for "NFFF". But "NF<sup>3</sup>" means "N multiplied by F brought to the third power" or a total of nine NFs. "N3F" stands for National Fantasy Fan Federation. But NF<sup>3</sup> stands for absolutely nothing at all -- unless it stands for the sheer ignorance of those who use it!

Naturally, you enjoy writing the comments, because you are participating in a conversation with the rest of the members... But when they, in turn, leave you out of their remarks to everyone else, no wonder you are bored. The secret of interesting Mailing Comments is to make them general enough to be enjoyed by all the readers, not only the person whose mag is being reviewed. And the only way this can be done, is to address your remarks in your own mind, to the entire membership. Let everybody in on the act and it's fun...

DERO - Coslet. You are quite right when you say in your comment on Terwillegor's LITTLE ACORNS that it is equally applicable to use "cruel" with regard to God and Nature... But I wonder how many people ever stop to realize that "Cruel" is merely a human evaluation? Actually, "cruel" applies only to humans because only they are limited by the values involved in this concept. For instance, there is no reason for assuming that occurrences which human beings consider "cruel" have any such connotations as far as either God or Nature are concerned. Human beings do not consider it "cruel" to scrub a floor with disinfectant... but undoubtedly if germs were able to formulate an equivalent opinion they would consider it "cruel" to exterminate whole germ-populations in such a ruthless manner... Neither does a bull-dozer operator regard it as "cruel" if, in the course of excavating for a building, he scoops up an anthill. In fact, he probably wouldn't even know it if he did. But I'm sure if the ants were able to speak, they'd regard the destruction of their elaborate cities in much the same terms as some humans use when speaking of the earthquakes which demolish their metropolises. The same people who rail at God for letting babies die, will not hesitate to pull up the tiny weeds sprouting in their garden, although it is undoubtedly as "cruel" to kill the baby weeds -- at least, "cruel" from the weeds' standpoint! # G M C A R R reviews

THE FANTASTIC UNIVERSE OMNIBUS, Edited by Hans Stefan Santesson. (Prentice-Hall, Inc., Englewood Cliffs, N.J.) \$3.95. This anthology of short stories from Fantastic Universe has probably been reviewed in more sf mags than any hardcover book since "Childhood's End", but before you moan, "Oh, no .. not again..", let me also point out a thing or two. Probably one reason why this particular book has received so many reviews from fans --- especially from fans who do not ordinarily review books --- is because fans are honorable when it comes to acknowledging favors, and Hans Stefan Santesson has favored fandom with more free copies of this book than any I know of since "Revolt of the Triffids" was distributed gratis at the Chicago Convention in 1952. (And "Revolt" was in the paperback edition, at that.) This edition is a beautiful hardcover book, with a black and white, star-spangled dust jacket - trimmed in green (no doubt to match the green cloth covers) - with 270 pages of fiction plus an additional 15 pages of introduction. There are 19 stories listed, plus two delicate prose-poems "The Flowers of Venus" and "The Day Will Come" which are not mentioned. The 19 stories have been listed in so many reviews that I will not repeat them here, except to mention that this anthology contains Robert Bloch's noted extrapolation of fandom. The one wherein he flouted all existing taboos by naming the names of actual living fans, and referring to real fannish organizations like NSF and FAPA. This story is one of those fannish "naturals" which is assumed to be in every fans library -- it is rapidly approaching the "If you haven't read it, you just aren't a Fa-a-a-an!" category. No mere listing of the titles, even including the authors, could begin to give an idea of the range of subjects covered, nor the variety of writing moods. There is one aspect of the editing which deserves mention: These stories seem to have been deliberately and knowingly aimed to appeal to Fans and Fandom. If there ever was a pro publication which could be called a fannish "must", surely FANTASTIC UNIVERSE OMNIBUS falls in that category. Here we have a pro's recognition of fandom as a way of life. More than any anthology I can recall, the selection of stories seems to have been made with fandom in mind. Stories intended for a discriminating and knowledgeable group of readers -- recognition of fandom as worthy cognoscenti in a literary tradition. I think it is this aspect which is responsible for much of the attention this book has received. True, it would have been widely reviewed in any case, in view of the wide distribution of review copies. But, even more than the inherent obligation to review it which inevitably accompanies a free gift of this nature, this fan-slanted collection of stories has intrigued the fans who have read it. Another thing which makes this anthology of special interest to fans, is the fact that the magazine from which these stories were taken, Fantastic Universe, is now defunct. That not only means there will be no more anthologies from this particular source, but it also carries with it a sense of finality... another monument to science fiction's past glories. Fandom may or may not feel a sense of responsibility for FU's failure. Fandom is relatively too few in numbers to have compensated for the snafu in distribution which cut this mag away from its market. Even if every last one of us had subbed, it probably would not have saved it. But, nevertheless, the mag did fold for lack of sales, which places a burden of guilt on every fan who did not buy it regularly. This feeling of personal responsibility toward the mag, plus the fannish quality of the stories taken from it, plus the sheer quantity of fannish comment about it, can hardly fail to result in making this particular book somewhat of a Fannish Tradition. Now don't misunderstand me --- I'm not saying that FANTASTIC UNIVERSE OMNIBUS is Great Literature. It is just what it purports to be --- a collection of pulp fiction with a fannish slant. But there is no way of telling, at this point, whether this book is going to turn out to be one of those much-sought after "collector's items" which become scarcer than rubies once they are out of print. So, just to be on the safe side, if you do have a chance to pick up a copy (I mean buy it, natch!) it might be a good idea to latch on to it while you can.
