A good showing, even if the page count does include quite a few blank pages.

Information concerning postmailings to the last two mailings and a correction to the last mailing list will be found on the back cover.

The present situation in regard to the status of President of Fapa is a very wwward one. I am stitting uncomfortably on a tester-totter. Our good teller Dick Lupoff announces the election of Len Moffatt on a write-in plurality. He was not aware of the considered decision of the Fapa members and officers present at the meeting at Nycon 3. I ask you to believe me that I want only what is best for Fapa and will happily accept the final decision. I will not try to tell you that I am unwilling to serve again as President, I thoroughly enjoyed my year in office. On the other hand I do not wish to occupy the office a noment more than is right and proper. The other officers and members at the Mycon 3 meeting felt that the write. in campaign lacked constitutional legality, which it unquestionably does. There is not a single word in the constitution allowing any form of write-in ballot. I think probably there should be. We should frame a well written amendment to take care of this emission. Meanwhile there is the precent situation to be resolved. Since I cannot be considered a disinterested party I prefer to keep out of the argument and let the other officers and members decide the issue. Failing such an agreement I could resign, since I am no longer supposed to be holding office anyhow, wouldn't be if anyone had troubled to file for the offise. This would not constitutionally clear the way for Len Moffatt, which is a pity as I think he would make a fine prexy. My withdrawal would bring VP Ed Cox to the presidents spot leaving the Vice Presidency vacant. I am not entirely sure Fapa doesn't need a Veep even more than it needs a prexy.

It might seem that I should just step aside for Len, but it would not be a legal and constitutional act, an extra legal act in the administration - no matter how well intentioned - is undesirable and her a way of becoming awkward. The consensus of equation of the members at the Mycon meeting seemed to be that perhaps if we sit this out this way it mught serve as an object lesson and convince members of the need to file for office and vote in the next-and following-elections. If it would have this desirable effect it would be a great thing for Fapa and nothing would budge me. As I aid, I want only what is best for the organization. I earnestly hope that the confusion will be smoothly resolved, and without illegal or unconstitutional action.

Me also have a PRESIDENT'S MESSAGE as follows from Len Moffatt;

We have a situation here. I was going to say a "peculiar.situation," but the situation we have is not peculiar--for FAPA.

Some of you will remember the time when I "took over" as Dictator of FAPA. I had been appointed Teller for an election in which there was only one candidate for each office, and I received only a handful of ballots. Apparently the majority of the membership felt that voting was a waste of time, an attitude I find deplorable in any election, mundane or fannish. I decided to shake things up a bit by interpreting the election results in the way it might be done by a power-mad person. My intent was to satirize (or burlesque, if you will) the situation by turning the Teller's Report into a Dictator's Proclamation. As you might imagine there was a variety of reaction to my report. There were even a few who understood my intent.

I softened the blow by "appointing" the various nominees to the posts for which they had been running, although I am sure that they

## The Waiting List

I have decided to make some changes. No, I'm not throwing everyone off the waiting list, or anything that drastic. However, I have decided to go back to the old plan of requiring the wlacknowledge the FA each mailing. This is not a hard and fast rule; there are escapes. You can miss one acknowledgement. Dut not two in a row. This will not penalize the person who misses the Nov FA, because it wasn't forwarded, or was buried under schoolwork. It will not drop school from the list if the PO decises to throw that FA into the river. It will also let me - and the membership as a whole - know that you are still interested in FAPA - at least enough to write a postcard every three months.

[And I'd suggest every three months - the PO might lose a postcard, too...]

At the same time, I'm abolishing the 25¢ per year fee; to get on the list will cost a buck, but that is all. [If FAPA ever gets that poor, we can ask for some more] I've credited the 25c fees already paid; the total still due is shown below.

In the past, there have been objections that such a scheme makes more work for the S-T. Having worked under both plans, I don't believe it. Keeping track of the two bits, in stamps, in coins, sticky with tape, is just as much trouble. So, unless I'm everruled by the powers that be, this is it.

You must acknowledge the FA each mailing, to indicate your continuing interest in FAPA.

You are permitted one miss. A second consecutive miss drops you. [And note that a returned FA, no address, amounts to a miss.] Non-consecutive misses are permitted, but it's skating on mighty thin ice.

would have proceeded to do their jobs regardless of my "appointments." I did make one non-nominee appointment to underline my basic point, and in any case I felt that it should be obvious to one and all that I wasn't really power-mad. I was merely using my sense of humor to illustrate the dangers of lethargy in elections.

I now find myself in a similar situation. Don't panic, friends, I am not about to declare myself Dictator again; the situation is similar but not exactly the same. When we learned that there were no nominees for the office of President, a couple of friends and I came up with the idea of writing in my name. Although I am inclined to go along with the interpretation that the Constitution does not allow for write-ins, I was interested in what the results would be, for once again there was an opportunity to point up an unhealthy (i.e., lethargic) attitude in FAPA. (Only one person running for each of three of the offices, and no one at all running for President--the easiest job of the lot!)

I assume that whoever provided for write-ins on the ballot did not agree with Bill's interpretation that write-ins are not allowed, but rather felt that the Constitution did not specifically prohibit write-in votes. Although I agree with Bill's interpretation on this one point, I do not agree that 6.2 applies or that 7.4 does not apply. Now please understand that I have no personal objection to Chuck continuing in office, but I feel that the <u>intent</u> of the Constitution (7.4) is that we should have a new President and a new Vice President every year within each five year period. Consequently, as no one ran for the office, and if write-ins are not allowed, then Ed should be President as well as Vice President under 6.12.

However it is not my job, nor Bill's, to interpret the Constitution. That duty belongs to the duly elected Vice President, and he can't call the shot unless the election is contested, and two or more sides of the controversy are presented to him by others.

In the meantime I shall assume that I am in fact--if not Con titutionally--President of FAPA. I do consider it an honor, and I want to thank not only the ones who voted for me but also all 14 non-lethargic members who did not consider it a aste of time to send in their ballots.

If accepted, I will serve. If replaced by Ed or Chuck I will make no objections whatsoever. I see no harm in anyone contesting the write-ins for President. I would do it myself if I were not one of the parties involved. It's up to you "others" (6.12)....

Also postmailed to the 120th were FAPA ELECTION RESULTS - OCTOBER 1967, but required extra copies were not received, hence this is not an official postmailing.

A manilla clasp envelope doesn't stand up too well in postal channels. Please, if you use one to get your magazines to me, at least tie string around it. Ruth Berman, the PO had to re-wrap both of your packages, and from the shards of the original packages I was surprised that all 68 copies were present.

Sunday p.m., no veep's message, and no packages from three "ATM's."
