Note that No Credit Is Listed For Material In This Mailing! Some of the letters I get....

SYMBOLS: % = CoA. D = Dues are now due and must be paid before midnite, 10 November, 1962. \$ = Dues are overdue, and if they're not in my greedy, corrupt li'l hands by 11 August 1962, this may be your last mailing for quite a spell unless you can round up the number of signatures required by either Sec. 3.3 or 3.5 of the Constitution. A = Activity, completing your necessary eight pages, must be in this mlg, in the next, or be postmailed before next mlg deadline, or you'll not be eligible to renew. ATM = Activity (see above) must be in this mlg, or have been postmailed before this mlg's deadline, or you may be bidding us adiós. Simultaneous mailing is acceptable, upon proof of simultaneity. ANov, AFeb, etc. = you're a new member, and must have published your eight pages before on in the indicated mailing in order to remain a member (see Sec. 2.4). 
