Filking at Westercon 42

Gary (the Grim) Anderson is in charge of Filking at Conosaurus. He has some really good plans for filk activities at the Con. How these plans will turn out remains to be seen. In the left column below is the letter he sent to the ConCom requesting space for filksinging at Westercon. In the right column is the latest available information on what space has been granted by the ConCom, and what we can try do about it. Don't blame Gary for what we've got, he asked for a lot more.

Filking: Preliminary Estimate And Program For 1989 Westercon

This is the full text of the letter Gary Anderson submitted to the rest of the ConCom requesting facilities and time slots for filking at Westercon 42.

Fliking will have three main events:

- 1. The general, open filking with the usual three flavors; bardic circle, midwestern chaos, and anybody's guess. This is a late evening activity, lasting until 4 or 5 in the morning (or later).
- 2. The flik concert, where the better performers, having been invited and warned ahead of time, play to the flik audience. This is usually an afternoon activity, on one or two days.
- 3. Filk programming, wherein various knowledgeable people get up and explain what it is they are knowledgeable about. This is an afternoon or evening activity, usually a single room, and organized much better than the other two.

Basic needs:

One room, 50 to 75 people capacity, in the afternoon from 1 or 2 to about 6 PM.

Three rooms, 35 to 50 people capacity (One should be the 50-to-75) from 8 or 10PM until ???.

Water service in the room(s). Intense in the afternoon (once an hour), decaying toward evening to once every 2 hours, picking up to once an hour at about 8, and dropping off to once every 2 hours after midnight.

Rooms not near dances, movies, or other noisy activities. This will keep the filkers out of the halls, or at least in the halls by the filk rooms, and avoid the repetition of filk wars.

Suggested Bill of Rights and Responsibilities for a Filk

Part 3 of 4

II. Filkers' Rights and Responsibilities (Continued)

B. AS A PERFORMER:

- While performing, the right to the undivided attention of filkers present.
- 2. The responsibility to be ready with a song when it's your turn--don't keep the rest of us waiting, please.
- The right to entertain the rest of us with your musical talents. If you have something to sing/perform, take your turn.
- 4. The responsibility NOT to be a flikhog. Let others have a chance to perform too.
- 5. The right to pass WITHOUT HARASSMENT.
- The right to choose your form of torture, be it filk, folk, synthesized, accompanied, a capella, instrumental, OSE, bawdy, whatever.
- 7. The responsibility to announce any caveats to your performance. Some people are offended/upset by some types of filk, such as OSE, bawdy, etc. This is neither their fault nor yours. Don't let it stop you from performing, but allow them to leave gracefully (see Listener #3).
- The responsibility to keep your introduction short and to the point. Your song should stand on its own merits without apologies or long explanations.
- 9. The right/responsibility to define/request your desired accompaniment, i.e., vocals/no vocals (it's a solo, general sing-along, chorus only, etc.) and instruments/no instruments (solo, harmonizing, all together now, etc.). If nothing is said, anything is fair game!

C. AS A LISTENER:

- The responsibility to give the performer your undivided attention and to respect his/her choice of music (i.e., NO chitchat in the flikroom during the music!).
- 2. The responsibility <u>NQT</u> to hog any down time (time between performers), i.e., don't rush in to fill the vold with conversation.
- If you don't like the song/performer/whatever, you have the right (if not the responsibility!) to leave the filkroom (see Performer #7).
- 4. The responsibility to leave the filkroom quietly so as not to disturb the rest of us who are enjoying the performance. (Hint: If you leave frequently, sit near the exit.)
- The responsibility to respect the performer's choice of accompaniment and <u>NOT</u> to join in without invite/consent (if not immediately clear, ASK FIRST before joining in).
- The responsibility to move to an alternate room/ space if you want to converse.

From the Editors Regarding the R & R's

Over the past few months we have heard several thirdhand rumors and complaints about the Filking R&R's. This is really disappointing because it seems that the people complaining either have not read them or have not understood what we have said about them. When they were first published in the Con-Chord 4 program book, we said we were looking for comments and discussion on them. The only comments we have ever received have been when we backed someone into a corner and threatened them with violence unless they talked. We are still looking for comments and public discussion on the R&R's. Would someone please send us a letter???

There is a tremendous body of unwritten, understood conventions and traditions covering filking and filksings, many of which are regionally unique and specific. All we did was collect those most suited to us (Southern California) and set them to paper for reference purposes only. Nearly every item came to mind as the general solution to a specific problem encountered at past filksings and conventions. We feel that, to a large extent, most of these problems originated in ignorance of filk customs and etiquette.

Most or all of the old-time filkers are familiar with these customs. What about newcomers? Some people are astute enough to pick up on our silent signals very quickly; many are not. And how about someone new to hosting? How do you help them become aware of what is expected at a filksing and what options are available to them as a filk host? We tried to write the Filking R&R's to have a short, written list that new (and some not so new) filkers could read and learn from.

The last point to be made here is that these are rights and responsibilities, NOT, repeat NOT, rules and regulations. This is still our personal opinion of good filk etiquette. This is what we expect at a filk in our home. Other hosts can (and have!) run a filk however they prefer. We do hope that eventually many of the R&R's can be accepted as universal standards for good filk etiquette, with local variants as needed.

7. The right as an audience (en masse) to short circuit an unpleasantly long intro (see Performer #8 above).

Here we go again--the high season for filking is nigh upon us, what with BayCon, Westercon, Worldcon, Con-Chord, and OVFF fast approaching. This is the next to last installment of the Filking R&R's and covers filking listener/performer etiquette/abuse, a topic hotty debated in most circles. You know what I mean--who trashed what filksing in which horrible fashion (filkhog, boring intro, breaking the mood, talking over and around the singing, etc.). See Rights on Page 7.

"Quoth the FilkLord..."

If I were Dictator of the Universe, there're a few things I'd like to change; taxation would be revealed as the Government-sponsored theft (or extortion at best) it always has been, all lawyers would either be summarily executed or else receive \$50k per year to not practice law, and people would take responsibility for the consequences of their own actions rather than shift the blame onto the nearest source of Big Money. - 2) Vocal/instrumental tutoring would be free for all flikers who want to take advantage of it. Maybe Joe Filker sings like a dolphin with laryngitis right now, but who says he'll be that bad forever and ever, worlds without end, Amen? The idea is to improve the general level of quality, not merely to expel the bad performers.
- 3) Bob Kanefsky would find his every worldly need supplied for him, so he could devote all his time to writing more songs without having to worry about paying the rent or other such trivial nonsense. Bob's voice isn't good enough to sing his own stuff (or anyone else's, for that matter), and I'd keep him busy enough writing that he wouldn't have time for vocal lessons, but this is a small price to pay to enlarge Kanef's body of work.
- 4) Any and every filksing would have an Autocrat to deep the filk going. The Autocrat gets to decide whether it's going to be a bardic circle, "chaos", or what, and his (or her) word is final and unchallengeable. The poor, subjugated filkers would always have the right to "vote with their feet", of course -- If an Autocrat's power goes to his head, he may find himself without a filksing to lord

Tentative schedule:

Opening Day: (Friday) Evening flikrooms only. Begin 8 PM.

Second Day: Afternoon concert starts at 3 PM, runs through until 5, with programming from 2 to 3. This features one-shots and the first day of performers. Followed by evening open filk, 8 PM. Need only two rooms. (Masquerade day)

Third Day: Afternoon concert starting at 3 to 4 PM, runs through until 6 to 8 PM. Programming from 1 or 2 to 3 or 4 depending on wishes of filk community. Followed by evening filk, 8 PM. This is heavy night, need all three rooms.

Fourth Day: Afternoon programming from 2 until 5 PM, with perhaps some late-arriving performers. Evening sing as usual, 8 PM, possible last concert section.

Fifth Day: By now, even the flikers are tired. No formal activity planned.

Programming schedule:

Second Day: What Is This Stuff Called Filk?? - Introduction to filk for the neo or neofliker or amused bystander. Basic explanation, history, "In" jokes, traditions, and demonstrations. No throwable vegetables permitted. (1 hr)

Third Day: Whatever Happened To Filk Communication?

The demise of The Philk Phee-nom-ee-non, or perhaps its resurrection (depends), the demise of a lot of other filkmags, and suggestions (and commitments) for their replacement. A short treatise on the use of Compuserve and other nets to Get the Word Out. Info from The Filking Times and Xenofilkia. If Paul Willett's wife Janet isn't having her third child, a short explanation from the pre-eminent filk publisher on why two kids and a 16 hour-a-day workday impacts publishing activities. Otherwise his friends will provide whatever seems likely explanations, and mall him a tape of the result. (2 hrs)

Fourth Day: The Business of Filk. - How do those tapes, etc., get produced, what to watch out for, some basic copyright/contract stuff to absorb, and a rousing debate over whether filk is/can become a real business. (or should, for that matter) Some info on where to buy tapes, songbooks, etc. (2 hrs)

Filk Etiquette, or Why You Don't Eat Potato Chips Over Someone Else's Songbook...- What to do and not do at a sing, the different kinds of sing, and how "host's rules" applies at house sings. The Two Big Bananas, Bardic Circle and Chaos - differences and similarities, and when they break down. (1hr)

These are tentative, and may be split, but the time slots are correct and the rough emphasis correct.

SoCal Filksing

May 5th at Terry Hopwood's

A Review, by John Creasey

The Filk was well attended. However, everyone arrived somewhat later than anticipated. Some of those who planned to come were "swamped" with household emergencies and could not make it. All who came had a good time, at least until we had to leave (at 10 PM, Mary had to work). The Filk room was better arranged than it was at their last Filk, and we were not too crowded. I personally want to thank the efforts of all involved for keeping the cat "sequestered" for the evening.

The Filk was in the modified "Poker Chip" (non-topological bardic circle - ed.) style, as pioneered by Lee Gold; with one slight modification, no poker chips. Well, these are some basic guidelines for good filkish behavior, appropriate for both the new and not-so-new filker (and just in time for convention season). They are not meant to be rigid or mandatory rules, but instead try to target some areas of frequent filker abuse.

Let's be upfront and open among ourselves and clearly state what behavior will and will not be tolerated. What better way than to have a short list available for easy reference? While such a list can never replace common courtesy, it can ease the way for new filkers unsure of what to do and also pointedly illustrate group expectations to repeat offenders (especially those who can't seem to decipher group dynamics and need written operating instructions).

Next issue will present the final installment of the Filking R&R's, including a comparison of revised points with the original and the complete revised version of the R&R's.

- 5) There would be a universally-recognized "Generic Standard Filksong Library" of "standard" versions of every known filksong. Nobody would be required to sing the Library's version of any given song, but at least there would be universally-accepted "default values" for those songs that have two or more regional variants.
- 6) The filkers Bill of Rights and Responsibilities would be enforced in force. If BoRaR turns out to not work so good in practice, I'd modify the silly thing until it does work properly.

Concert participants: Kathy Mar, Cathy and Paul MacDonald, Duane Eims (If in town), Cindy Mcquillin, Jane Robinson, Karen Jolley, many more. (We are still dragooning them.) One shots (Get up and do your thing, but only once) will be held as part (or most) of the Saturday concert session.

Schedule should be known in advance, but I need some kind of easel or other approved stand outside the filkroom door so as to advise all the filkers as to what the latest schedule changes are, and what needs to be done. I can take care of the signs and info, but I'll need some posterboard. There needs to be one room, on a noon-to-6 AM basis, which is THE filkroom, so program participants, singers, out-of-towners, and anyone else who wants to participate will be able to find us. Besides, the first thing filkers do is rearrange all the chairs, so one might as well go with the flow. The second and third rooms are only needed during regular filking hours, 8 or 10 PM to 6 AM.

Signs needed from the regular signmaker:

- 1. MAIN FILKING ROOM CONCERTS, PROGRAMS, AND CHAOS
- 2. FILKROOM # 2 BARDIC CIRCLE
- 3. FILKROOM # 3 DO YOUR OWN FILKTHING

The above are regular, big, information signs, I also could use three small signs, about the size you wrap around your head, saying "Filk Ghod", "Demighod #1", and "Demighod #2". These are intended to go on baseball caps, if I can't find someone to actually print them on the caps.

It is my intention to appoint the above 2 demighods from time to time, like during the Masquerade, when I can't be in the room. I will need a contact in Con Security to be able to make sure we have the bases covered, and someone else is informed. (Although a bright yellow or red plastic baseball cap with the above logos would be kind of obvious).

Noise. The filkers make a fair amount, but if you give them competition, they will either make a great deal more, or more likely become a moving target, roaming throughout the hotel, and in general causing problems. The main filkroom, at least, is going to have to be free of much outside noise. (We will also be taping the concerts, one shots, programming, and most of the sings.) Also, the 2 main filking styles, bardic and chaos, are mutually incompatible, and this is why at least 2 and preferably 3 rooms are necessary. The usual tactic is to assign them to the filkers after 10 PM, when everyone else is off at a party and the other programming has died.

Please don't hesitate to contact me on this. I have left some flexibility in the schedule to allow you some, but if you need definitization, that can be supplied also.
