Rules of the Southern Fandom Press Alliance

- 1. There are 27 available memberspots. Copy requirement is 32.
- 2. The minimum activity requirement is four pages of original material (no prior distribution except to contributors) in any two consecutive mailings. All four pages must be the member's own material; at least three must be writing.
- 3. Dues are \$2.00 per year (except when extended).
- 4. A couple may share a memberspot, paying one set of dues and receiving one copy of each mailing. Both must meet activity requirements; both may vote. Instant Membership, with full privileges, is available to spouses of current members.
- 5. To owe activity is Gauche. To miss a mailing is a Faux Pas.
- 6. Applicants for membership are added to the waitlist upon payment of \$1.00. This is simply a waitlist fee and does not apply against future dues.
- 7. A waitlister's failure twice consecutively to acknowledge receipt of THE SOUTHERNER will result in his removal from the waitlist.
- 8. The minimum activity for a new member in his first mailing is four pages of material as defined in Rule 2.
