Re Motion #3 and #5 on this ballot. Joanne stated that she would like to hear

what the current President and Treasurer think of the motions. I agree.

On the Public Relations committee. I already know of one person that would help on this committee in various ways. At this moment, if it's okay with Stan and Stan doesn't already have someone picked out, he wouldn't mind doing the layout, artwork, and pasteup for the ad to go in the Worldcon program book. His artwork can be good. Also on future PR, he might (actually probably) be able to enlist the aid of other artists in the Kansas City Arca. This is Ken Keller, who lives in the KC metro area.

Also certain people havementioned to me some things concerning the present symbol. Although it could still be a traditional symbol that can be continued, a newer, more modern design might be developed that would capture the eye a little bit better. This could be especially used in the PR releases. Blue and gold could be incorporated into this design also.
