St Fantony ceremony went off well, Forrie Ackerman inducted. Rick Sneary was to be, but couldn't make it, so Dave Kyle worked up a "dress rehersal" at Bjo's in Los Angeles and had Rick play the part of the inductee and only told him when it was all over that the ceremony had been the real thing. Society for Creative Anachronism put on fabulous fashion shows, most admirable costumes and no small number of adorable femmes to fill them. I shall send you slides. The Tournament also went well from fannish viewpoint, creating erstauntheit when SCA claimed that real ones were even better. Exegesis of MaoThink went over very well, even, or especially, with the Anarchist crew. I drank at least six Grasshoppers, somehow. Fancyclopedigest moved pasaably well, about fifty sold. Red Baron costume photographed & chortled at by all but not selected even for semi-finals by Studebaker, who goes by name of Red Baron in Society for Creative Anachronism. Distributed two half-gallons of wine in the form of sangrias, a Vampire Sangria (white wine and peaches) at Cult Seance naturally. Will send you menu from Seance in near future. I thanked Krenkel and DeCamp on behalf of the TO&FMESRG when accepting the Hugo for you. Liz Lokke showed up last day of con and had to go off to rescue her kids right away, drat the luck. I would have given her the Hugo to hold on to for you if she'd been around long enough. Berkeley Barb had comic strip on 'Czechago' after DemoCon, showing Activist types lurking and assembling bombs in consequence of unutterably tyrannical oppression.

The Pelzii f/r is the only one of the 220th Period and my Lagduf the only one so far for the 221st, but there are many days to go before I can count it closed as far as f/r receist coes.

Back to Tapscott: there has been nothing so far about appointing another Election Officer. Don't know how that is supposed to work --- especially as one is supposed to selfnominate a week before his [should be: Scithers'] pubdate, or your pubdate, or somethin. At any rate, I didn't nominate myself.

e went to a stamp show here in Rochester yesterday. At least, to us it was just a show, but to the regulars it was a Convention, somewhat in the tradition of Our Convention. Weeven got asked if we were going to Tucson next year, and signed a petition for some kind of stamp to be issued at Tucson. I could have done a UN first day cover f/r for the Cult, but didn't realize how easily and was broke in any case.

Don't let anyone kid you. The Baycon Costume Ball was a real, genuine, first class, accept-no-substitutes, abortion. Hardly anyone seemed to be able to get good photos. When Studebaker called up possible winners for the last time, some couldn't be found. Let's hope a repeat performance can be held next year at St Louis [of Scotty disbelieving in Peggy??].

FR #219 (Avanc #9) I'd almost forgotten what good FR's you put out, Dick; it's a delight to get this. A lot of interesting information on Viet Nam -- I enjoyed reading it, at any rate -- and full publication of letters.

Who is "China's Khrushclev"? Liu Shao-Chi? Or have they started tearing down Chou En-Lai yet?

Speaking of CPR blather -- does nao still hold the world's swimming record? -- I visited Tijuana withe the Trimbles and the Shibanos a couple of months a o and was surprised to see that there's a very big Communist propaganda outlet there now. It's the biggest bookstore in town, in fact. I don't remember the name, and I don't know exactly who's running it; it seemed to stock as much Russian literature as Red Chinese literature. There are a couple of big, beaming portraits of Lenin and Mao on the wall; none of any other nussian statesmen. I got a couple of Soviet s-f anthologies translated into Spanish (one of which says, "We hope that this collection will please the reader and serve to reinforce the mutual friendship between our countries."; about as clear a declaration of intent xx as a piece of propaganda as you could want), some multilingual Russian travel booklets ("Along the Volga River", etc.), and a couple of other things. One was a Red Chinese comic book, or at least a children's book -- a beautifully printed pamphlet with a minimum of text and a maximum of illustration per page. It's a WWII story about two Chinese peasant children who, inspired by the revolutionary doctrine taught in their village by the local commisar, smuggle important information through the Japanese lines to the reople's Army, which results in the defeat of the Japanese. As far as it goes, it's no worse than American war comics, which give the impression that the war was fought solely by Sgts Rock & Fury -- this one implies that Mao's army was the only force fighting the Japanese. It was priced at 20¢ US, or \$2.50 mexican, which I'd guess wouldn't begin to cover the printing and shipping costs. The storekeeper was a very pleasant fellow, and I wonder how many American tourists he gets in his store? (A couple of blocks away is the Tijuana local Kuomingtang headquarters, and about this time I began wondering how many Chinese there really are in Baja California, anyway -- and whose side are they on?)

A pity you couldn't get enough of any of those safe conduct passes that we keep dropping behind VC lines to put through the Cult. Some of the ones I've seen are pretty humorous, in a sick way; like the one with a picture of an ARVN (or GI?) and a VC trooper buddying it up.

Snider: How did your NIMROD BayCon Project work out? Your brochures looked quite good. Ken Rudolph brought up the latest issue of SHAGGY, published the same day he arrived, and he says that he sold a lot of copies and got a lot of subscriptions. Is your brochure bringing you any subs for NIMROD?

Rogers: I doubt that worldCons are likely to "get small" again. If it's not "Star Trek" bringing them in, it'll be something else. Not every year, maybe, but often enough. And, of course, you have to define your term of "sane and relatively normal proportions". What do you consider "normal"? 400 attendees? 500? 600? I doubt St Louis' attendance wild be under 1,000, with another season of & "Star Trek" to go, probable ads in the prozines, and so on. I wonder how much of St Louis' geographical location will help fans from all over the country to get there? Either Heidelberg or Bermuda will be small, but then '71 will be on the East Coast, and East Coast cons are usually large, I think. The WorldCons had better resign themselves to providing accomodations for attendances of over 1,000, instead of planning small and hoping that only a "normal" crowd will come.

[Well, one thing that would have cut con size down real quick would be a con put on by a really incompetent con committee. Having seen some examples of the nitwittery that passed as correspondence by the Columbus committee, I am sure that, had they won the bid, we would not have had to worry about oversized cons for years afterwards. 'Course, it might have been impossible to find a hotel willing to take us for a small con after a real fiasco...]

From where I was sitting at the Banquet, that tie vote for best novella simply wasn't believed. "Oh, they're kidding!" "I guess they felt they couldn't let their Guest of Honor look bad by not getting it" "Does giving him a sympathy award make him look good?" That was just a couple of prople, but I gather from what I've heard since that it's pretty representative of reactions. The most charitable opinion I heard was that the Committee was trying to do a Good Deed by making sure that as many nominees as possible won awards, so that as few fans as possible would be disappointed by having their favorite stories lose. The real damage, whether the tie vote was genuine or not, is that practically everybody believes that it was rigged. [I agree.] Yet nobody seems to mind too much, because, as one fan said, "Well, we all know that the HUGO is just a popularity contest, and it never was a real 'best' award." With the categories shifting every year, and the fans not trusting their own voting -- because for every fan who's sure the Novella tie was rigged by the Committee, there are others who are equally sure that Harlan was voted the Best Dramatic Production by the fans as a joke to embarrass him, and who know that THE BUTTERFLY KID got on the final ballot despite a lack of any serious literary merit -- the awards are being respected less every year. Before the announcement of the awards, a number of fans thought that there was a real chance that THE BUTTERFLY KID might win on a tide of gag votes -- "vote for the fannish underdog!" Several fans

told me that they voted for it, for that reason. Others felt it really deserved to win, because it was the most enjoyable book for the year (to them), even though they all admitted that there was a number of x other books that were better in a literary sense. There's still all sorts of confusion as to what the HUGO is, and what it should be, and the way the rules are changed every year "to make fandom happy" [or to "prove that the con committe has complete freedom to break promises, or whatever] doesn't clarify matters any. Incidentally, I see that the latest Ace Double-Novel carries an ad for 'THIS IMMORTAL -- winner of the XXX HUGO Award as best of novel of 1965". If I recall correctly, at the time of that HUGO race, people were making a sharp distinction between "And Call Le Conrad", which was the xxxxxxx version that was technically up for the award, and THIS IMPORTAL, which was the expanded and generally preferred version but which was technically ineligible because it came out in 1966, the year the voting was being held. And now it's THIS IMMORTAL that won the award. Well, it was, because everybody knows that the fans were really voting for THIS IMMORTAL when they cast their ballots for "And Call Me Conrad."

Dear Cult:

Snider's, Van Arnam's, and Crayne's f/r's finally arrove, via the obsolescent Box O NJ address. I shall assume that Crayne & Snider did so get theirs in before midnight and the Post Awful goofed. I know my (misnumbered) f/r 222 1/13th (shd be: 221 ...) was mailed the morning of 30 Sept and it got a 1 Oct postmark too.

I find myself deeply upset by Scotty's depression anent "Law & Order" as a campaign issue; in some ways I agree: allace is using the slogan to cover his racism, and the Chicago police riot was indeed horrid. However, consider that many people (I believe Nixon among them) are using "Law and Order" to mean law, and order, like that, with no racism implied. Consider that Negroes are in fact the principal victims of Negro criminals. Consider that about threequarters of the population of this country faces a very real curfew, non the less real because it is not governmental, which makes them unable to walk alone in large sections of every big city. Consider that the Constitutional protection against unreasonable search and seizure protects not the man seized & searched -- mugged -- on a public street or -- worse -- in his own home. Is not the loss of this facet of liberty worth some concern? I have been in Scandinavia, France, Germany, Italy, Greece, even South Korea; in all of these, I feel safer on a strange street, at night, alone, than I do in most big US cities. Only, the thrust of "Law & Order" seems directed (as Heap mentioned) at the trivial crimes, not against robbery and burglary.

Nevertheless, I do not see why the impending collapse of Civilization in North America is any reason to slack off on one's 'Cultac. After all . . . !

My filin for the OAcy, overleaf, is to end the current OAic crisis. Now, please: will some others file too? I am strictly a last resort candidate for the OAcy.
