
In Fantasy Rotator # 8, evershadowed by a move to abolish or at least restrict amendments, Stuart Mock proposed an amendment in rather confusing terminology that I think bears explanation.

During Christmas week, I managed to write four or five letters to Cultists sounding them out on a proposal to elect a three-man committee, whose business it would be to argue out the constitutional squabbles that all thirteen of us had been fighting over. I planned to make it more or less directly concerned with the membership lists, with moving up waiting-listers, and with expelling delinquent members, with a jamority vote of the Cult as a whole the only thing necessary to make their membership-decisions valid. On the constitutional questions, no amendment could be submitted to the Cult except by the committee, whether they thought it up themselves, or just passed it on. But full vote and ample rebuttal-time had to be allowed.

That was the essence of the proposal. Letters went to Don Wegars, John Hitchcock, Dennis Moreen,
Stuart Nock, and Pete Vorzimer, before finals loomed large
on the horizon and put a stop to my activities. None of the
recipients, except Nock, expressed enough interest in the
committee idea to make me think an amendment would have a
chance. Pete didn 't even answer.

The letters had a deeper effect, though, because I went a little farther than just proposing the committee, I made suggestions as to its composition, and asked for further suggestions.

My main points were that I wanted no persons of extremex opinion on the committee, and that I would prefer to exclude any members from candidacy who felt they were, or who were assumed by others to be "leakers." I wanted a cool, deliberative, logical board of governors, and I wanted no chance of autocracy. My suggestion was Magnus, Moreen, and either Nock, Wells, or Hitchcock. By letting this board quibble on constitutions, I'd hoped to rid the FR's of such hysteria as we've had in the first revolution.





Then I made my fatal error.

With only too brief a study of the Cultists, most of whom I didn't know before Spit arrived at my home. I began to tick off complaints of extremism and authoritarian behavior which prejudiced me personally against a few colleagues AS MEMBERS OF A DELIBERATIVE BODY. As debating opponents, most of them are highly prised andhighly respected.

I excluded myself from candidacy on grounds of extreme opinion --- on letters in FR's.

I excluded White on identical grounds.

I excluded Anderson also for the same reason

The three of us were all involved in stating violently our extreme opinions on only or question; could any committee remain cool and logical with any of us as a member? I didn't think so, and don't now.

But the area in which I probably created the most confusion (certainly in Nock's mind) was that of excluding members from candidacy on grounds of possible autocratic behavior. I wanted no one member of the committee to act arbitrarily, and most important, I wanted no one member capable of swaying a majority of Cultists merely on the merits of his own personal prestige.

For that reason Peter J. Vorzimer and Charles Wells I considered unacceptable as committee members.

Vorz, as founder had and still has more prestige, more weight, than other Cultists. Some members go so far as to consider him an "Expert on cults" because the organization sprang full blown from his brain.



But even more important, from my point of view, Vorz has far too often presented arguments with less coherence than emphasis --- arguments which appear to trade on this Great White Father prestige. I don't think it is intentional, but nevertheless the trend toward independant, daprecious, autocratic action was strong enough for me to express opposition to his candidacy on a board of governors. It was my opinion that Vorz, as an independent entity, might well organize his prestige-won power to either support the committee, or to make an effective opposition whenever the occasion arose.

Your Interpretation?"

OUTSIDE the committee, Vorz would perform a logical service; inside, he could only destroy its effectiveness by his potential autocracy and his private power.

Wells I considered an enigma at the time. He had, by requesting dictator powers and by rushing ahead with his new constitution without any formal okay, openly ASKED for the position which Vorzimer had merely ACQUIRED. He had not been granted what he requested. Nor could I find any illogical capriciousness in either his actions or his motives. Perhaps Charles is just more thorough in stating his arguments.

However, I was reluctant to add the name of one who had admittedly sought to be dictator to that body I had presumed would be selfless in its ultimate opinions.

THAT was the background for Stu's contorted amendment --- not that anybody seemed to have noticed it, except Vorz, who had a right to be a little concerned at Stu's interpretation of my opinions.

Since then, things have become more acute. No matter what the hopes of the three or four who is turned down my letter proposal for a committee, the Cult will elect a leader or a leader-clique of some kind, if it progresses long enough; whether the election be conscious or unconscious. The struggle for that position seems to have been joined, finally, and it appears by no means to been simple nor an unviscious scuffle.

Remember, I wrote Vorzimer around Christmas, expressing generally the same sentiments as I have here, and adding that possibly my prejudices would disappear if Pete and I might correspond a little more, personally I have never received a letter from Pete; a duplicated broadside once, and once a carbon of a letter, and perhaps once part of a reader column letter was headed by my name. But there's been no attempt to change those opinions.

After FR #5, Vorz tangled with White on a couple of points in a protracted exchange. Also, Pete objected to my suggestion that the Zrov that put out Abstract was the same Zrov that founded the Cult. I think he concluded that both Ted and I were dedicated enemies of Vorzimer Enterprises, Inc, and engaging in collusion to multiply our enmity. He was wrong; we're friends who argue more bitterly with one another than with outsiders; but the impressions was planted and grew, nevertheless.

Ted, meanwhile, had managed to gather his own bit of prestige. He'd answered every opportunity to comment, produced a monster FR, and instituted the Fractionals. Later, he gained in stature by placing his mimeo at the disposal of Sam Johnson and myself --- and by persuading Multog to combine FR's 9 and 10 in order to make a try at regaining the two-week schedule. Without fully meaning to, Ted acquired the position of a leader candidate; most probably because his name and address has appeared so often in Cultzines, and his activity is envied.

Wells, who asked in Fiendetta that he be granted some power, seems still to be ignored by most of the Cultists as a potential leader. I don't know how long he will continue to be ignored; personally, his motives appear sound, and his energy seems boundless enough to get something done. We'll see by the time this gets into print. (16 March is its writing date.)

Anyway, Vorz and White appear to be the only contendors who have openly challenged one another, or who seem to have developed dislike for one another.

The first real clash came when Vorz proposed amending Fractionals out of existence. It was in all probability a move with sound altruistic motivation, but it's apparent that, were the amendment passed, the prestige Ted tained by publishing the monster FR # 5 would have the edge taken off it. But it was defeated by a pretty decisive wote, too -- in a partial sense, a vote of confidence for Ted's industry, and an approval of his issueing a post amendment Fractional in open defiance of Pete's views on the matter.

Now, of course, the big explosion had occurred, and the argument has flared into full view of everyone. Both Ted and Pete are attempting to gather public favor unto themselves, and since the battle is being fought with constitutional phrases as weapons, everyone believes he has a vital interest, if not a legal right to an opinion.

(For the record, I just received and read Magnus' FR a paragraph ago: I had no idea ALL of this was going to be made so topical. I'll bring it up to date, eventually, so that things make more sense.)

Vorzimer noted these facts: I went to Washington; Multog and myself put our zines in White's hands for publication; and Peter J. Vorzimer was removed from the waiting list. To his eyes, all of them had a common origin: Hatred Of The Great White Zrov. He demanded reinstatement, accusing Ted and I of fomenting a four-man anti-Zrov Committee in the Balto-Wash area, and all in all turned out a pretty masty note. Some day I'll have to quote it.



Man, woman, That was the real match in the powderkeg. I made some effort to right things (In the manner of Magnus final decision) and to prevent a broadside from either of the contenders. Were I sudcessful in preventing Ted's initial explosion in FR # 11, maybe Vorz could have been reinstated quickly and quietly, without even Pete getting stirred up. I didn't, so now everyone's stirred. /-/ Hah. Undetstatement. Hahl//

> What impresses me most is the surprising devaluation of both Ted and Pete that has occurred since the ugly mess started. prestige that a hundred pages and four FR's of work created for Ted has completely evaporated; no one looks up to a child, and

since his first yelp of outraged dignity, that's precisely what he's been.

Vorz isn't much better, either. As the opening of this article shows, I was pretty certain that everyone had forgotten that Nock amendment --- but since Vorz is convinced that Ted and I hate him TOCETHER? he's raked it up as collateral ammunition. (It's interesting that we find little in Ted's and Pete's letters OUTSIDE their own private little battle; strikes me as pure exhibitionalism on both their parts to throw their invective in public instead of KEEPING it a private war.) Figally, I think there's a little more than a mere question of right involved in Pete's demand of "Position # 1 or Nothing."

Undoubtedly, these two will be the loudest and most talked-about Cultists for quite a while to come ---but not in the respected tones that were used about them before. Ted is a hothead and Bete a special-privilege pleader, and as such, neither commands much respect, not even as much as was accorded them before.

Notice the gyrations Charles Wells has gone through to stay on the fence throughout the whole conflagration, though. He was fair and honest in the decision in his own zine, and made certain that everyone was made aware that he hadn't all the facts when he did make it. While Ted and Pete have called curses down upon one another's heads, and appealed in public for support of their separate "Right stands," forcing the rest of us to choose sides, Wells has acted arbiter, made at certain that his honesty was well displayed, and has managed to wire-walk the chasm LENGTHwise, supporting neither side, yet always voicing his fairness.

Not that I'm anti-Wells; for his sake, and ours. I hope this publicity he's receiving as an interpretor of constitutional convolutions and as an honest individual gets him into a position with an honest infleunce, if not actual power. If I were inclined toward one, I think Charlie'd make a good dictator.

He is honest, and more energetic than any two of us put together, and in all he's proposed and done, he HAS had the best interests of the Cult in mind. My one quarrel with him is his passion for FORMAL structure and FORMAL ckay. If he wants to be dictator, he shouldn't ASK for the power, he should EXCERSISE it; if we don't like it, we'll let him known soon enough. I do think, however, that if someone with an honest, logical approach to the Cult insisted on voicing his opinions and making positive moves, we'd all follow pretty easily.

Which brings me to the real problem of the Cult, and the point I would have made whether or not FR # 12 arrived, but which I can make a little easier now that it has.



The Gult HAS damn good leadership timber, but none of it is in use. The sad thing about the Cult is that all the noise, and all the argueing, has been done by fools like me, who aren't qualified to do any leading. Ted has, unquestionably, put more workds into Gult-circulation than any other member, and one of the highest-prized attributes a Gultist can have is frequency of publication and lengthiness of argument. Without Too, and his monsterissues, his Fractionals, there would have been MONTHS in which NO communication would have connected all yhr members. His energy is deserving of respect.

But not of Honor and Elevation.

We have members I wish would become more widely distributed, more emphatic, more direct in their statements --- so that they can be heard over the babble. For one, John Magnus --- who is proving his intelligence by getting out of the Cult. It's a tradgedy, not that John thinks he ought to ge, but that's he's never asserted his mature supriority. His is the oldest, the wisest, the coolest he ad among us, and his authority is deserving of respect, his opinions of an attentive ear. Instead, he's been revolted by his experiences and would rather leave than try to do anything to improve them. Perhaps he's right. Certainly it will be better for HIM if he does leave. It might help the rest of us if he'd stidk around a while, though.

Moreen is another fan whose abilities I've respected --- and mourned the loss of. Instead of succinct opinions on the childishness of the Cult, and the preferable possibilities, all that come from Denny are notes on all the outside activities that are preventing him from making many significant contributions. Ifeel he's actually leaving fandom without realizing it; at least he is certainly abdicating his Cult responsibility of participating to the FULLEST. We could use an Illinois opinion occasionally, if it were stated as forcefully as its cogency deserges.


And it might not be such a bad idea for more of us to listen a little more closely next time Wells asks for some power to do something. So far as I know, his constitution hasn't yet been ratified, though there's no opinion against it. If all he's waiting for is a vote of confidence to free his energies for some dictating, I'm for giving it to him to see what he has in mind. He's an idealist with a paper plan, but at least he's willing to ACT instead of sitting on his desk-stool griping. With guidence and backing, maybe he could perform a miracle. Maybe.


Well, anyway, # 12 is here, and Magnus is no longer here. I'll miss you, John, probably a lot more in the future than I have in the past. I'm sorry we disappointed you. Personally I'm not completely proud nor satisfied with many of the things I've done or said in the ten issues I've commented or contributed to. In my case, though, I think I'll have to say it happened to be the best I could accomplish at the time, given the particular question to opinionate upon. Perhaps if some of the questions had been ridiculed into obscurity as honestly and mercilessly as you've ridiculed the Cult as a whole, I wouldn't have been able to make a fool of myself so often. I don't know.

I do know I could have used your experience and advice oftener than I heard it. I could still use it, and what's more, perhaps I could try to help get it listened to a little more often.

But I'm thinking about a future that won't even hold the PROMISE of comment from Magnus, as the past at least had. If anyone persuades you to stay around a little longer, I'll try to reform. But I don't want to try to make up your mind for you.

This "Article" began objectively: I have a feeling it hasn't stayed that way... At any rate, perhaps some of the origins of a lot of the enmity and invective that has infused the FR's of late have been cleared up by this. I have no idea where the search for a leader will take us next; I'm fully prepared just to sit back and watch the trends, and make occasional reports to my sociology class. We'll have a leader, eventually, whether he's someone with a vote attached, or just the person whose initial opinion is agreed with most often by most people --- a sort of leader by default. I don't know whor it'll be, but I'll have fun watching him emerge.
