#### NoLaCon Hugo Voting by Mary Kay Jackson

The Filking Times published an article by Duane Elms ("Ticked Off", issue #3 Page 3) relating his views and knowledge of the ballots for the 1988 Hugo nominations in the "Other forms" category. Although no longer timely, this reply from Mary Kay Jackson deserves attention.

I realize that the topic I want to address here appeared a couple of issues ago, but I only recently acquired the back issues. I really feel that I have to comment on Duane's article about how he was "robbed" of a Hugo nomination. First let me say right off that I have known Susan and Jim Satterfield, the folks in charge of the Hugos for New Orleans, for over ten years. I know them to be honest and resent, on their behalf, the clear implication In Duane's article that they were not. I have talked to Susan on the phone twice since reading Duane's article and will attempt to recount to the best of my ability the gist of those conversations. (I might add that Susan knows I am writing this letter and I will be sending her a copy.)

Susan says that now, more than a year later, she does not really remember just what the postmark on the famous package of ballots was. That really was not the point. What Duane falled to make clear in his article was the circumstance regarding the receipt of those ballots. That package of ballots arrived after all the other ballots had been talled. After the final ballot had been typeset. After the final proof had been sent to the committee for printing. After Locus had been notified. After the final nominees had been notified. # ConChord V Update Child Policy Revised PR #2 Out Soon Preliminary Program Ideas

Things are moving ahead for Con-Chord V to be held at the LAX Quality Inn Hotel on October 6-8. The hottest topic to date has been the Child Policy presented in PR #1. After further discussion, the Con-Com has responded to comments and feedback from various sources by fincreasing their life insurance eoverage] modifying the official policy for ConChord. The new official policy will appear in PR #2. Preliminary notes from the ConCom meeting appear in the box on Page 4. These changes are not yet finalized! The unofficial policy remains the same: you are urged not to bring small children to the Con. The same applies to pets - members should think at least twice before bringing life-forms other than Homo sapiens Into the Convention areas. Do remember, though, that this applies only to the specific Convention function space. Your hotel room and the public hotel lobbles do not belong to ConChord.



Progress Report #2 should be on its way to all Con members Real Soon Now (mid-September). Until it arrives, here are a few tidbits to keep you interested. Concerts are being planned for Saturday evening and Sunday afternoon. Neither will be a big marathon session - three to four hours max. Confirmed performers at this time include Cindv McQuillin and Dr. Jane Robinson, Kathy Mar, and of course, our guests of Honor, Bill Roper and Carol Poore, Rumor has it that the notorious Clif Flynt and Barbara Reidel may accompany Bill and Carol to ConChord. If this happens, It is also feared that ConCom will be unable to prevent their appearance on stage.

Other things to watch out for at ConChord will include the Kazoo Awards, to be presented to various deserving people when they least expect it, and the Totally Tacky Tasteless Concert, presented by Chrys Thorsen, Ralphie Baby, and the Thor Records crew. Westercon in Anaheim last weekend had relatively little fliking in spite of having a committee member (Gary Anderson) responsible for filking. this was largely due to other evening activities that many of the filkers were Interested in. Westercon ran Friday through tuesday. Friday most people were tired from work and travel. Saturday the Masquerade was well attended by filkers as Gary Anderson and Janet Wilson (two well liked filkers) had a very impressive costume (which won "Best of Show) and Dr. Jane robinson was doing the Intermission entertainment. Sunday was the filk concert starting at 6 PM (I.e. no dinner break), followed by Dr. Jane and the Primordial Oohz (see the "Wackadamla" tape just released from Thor). After that, many people needed food and then it was guite late to start filking (at least that was how it felt to those of us who needed to be up for our hucksters tables in the morning). Monday evening had some reasonable filking, but many people were tiring as It was the third or fourth day of the Convention. Fliking was, however, well represented in the Dealer's Room, DAG Productions, Off-Centaur/Firebird, Thor Records, Wall Songs and Quicksliver Fantasies all had tables. There were at least six new tapes out - Wackadamia (Dr. Jane Robinson/Thor), Through My Eves (Larry Warner/Thor), Shake The Dust Off (Bill Sutton/DAG), Strangers No More (Brenda Sinclair Sutton/DAG), On Filkley Moor (Brit-Ish Anthology), and Wassall Test (British Anthology). This letter has been prompted by our reading of the Official Policy on Children in Progress Report #1, and subsequent conversations with various persons. As requested in the Report, we would like to make a few comments and suggestions, in

### hopes of improving the situation as we see it

First of all, it was only recently that we learned that every child attending is **REQUIRED** to purchild's chase a membership, as well as being expected to stay clear as much as absolutely possible. Now, the idea of a child's membership would not trouble me if it appeared to entitle the child to however. anything; as it stands, this charge seems to be nothing but a penalty fine to parents for the crime of having to bring their children along. Furthermore, as it is an understood fact that one or both parents will be required to miss all of the significant events which will be declared child-free, we furthermore have to view this as an added fee for the

privilege of missing these events.

Please do not misunderstand me. I agree fully that there need to be child-free zones for the concerts and such. However, since the majority of those at the con will be attending these events, it would seem fair to me if, during child-free

# **ConChord V Noise Policy**

Any member, child or adult, creating a disturbance or unnecessary noise, especially at the Concert or One-Shots, will be asked to leave the Convention area.

#### **ConChord V Child Policy**

Preliminary Revised Version 1.1.

- 1) Child memberships will be sold at one-half the adult membership rate.
- 2) Parents will be held responsible for the behavior of their children.
- 3) A child member must be accompanied by an adult member at all times. Unaccompanied children and their parents will. be asked to leave the convention area.
- 4) The convention staff are not babystiters, and we will not be forced to be babysitters by default.
- 5) ConChord V can not provide any kind of babysitting service at all, nor can ConChord V provide any room for a babysitting co-op.
- 6) Parents who must bring their children to ConChord V are encouraged to co-op babysitting on their own, in their own hotel rooms, keeping children out of convention areas.
- 7) Children's memberships will be sold only under these terms and conditions.
- 8) Only children's memberships will be sold to children. A child may not have an adult membership.
- 9) If there is any question of whether a person is a "child" or able to buy a full adult membership, the decision of the ConChord Committee will be final.

# **Revised ConChord** Policies

A Commentary and Explanation by Gary Anderson

#### New Nolse Policy

Children and adults will held responsible for their behavior at all times. This especially means with respect to noise or other distur-

> bances, with special reference to the concerts and other direct fliking activity. If an adult member engages in disruptive activity (carries on loud conversations. becomes drunk and disorderly) he/she will be asked to leave. If a child member engages in disruptive activity (whines, snivels "Mommy, I wanna drink, Daddy, I wanna go"; whiz, the kid flashes past) the custodial parental entities will be expected to remove them immediately. Remember - the judgement as to disruptive is at the sole discretion of the ConChord committee

#### Revised Child Policy

There were originally 9 points in the Officlai Policy. The only ones being modified are #1 and #3.

New #1: Children's memberships will still be sold. Children may attend all of the convention subject to their good behavior.

New #3: Children MUST be ACCOMPANIED by a custodial parental entity at ALL times. This means right near the kid, preferably See Comments on Page 6.

### A Reply to The FlikLord

Being a rebuttal to Quentin Long's column in TFT Issue 5. by Kay Shapero

I'd say Quentin is missing the point somewhat. We're not talking about professional singers for the most part, we're not even talking about an amateur singing group like the Madrigais we're talking about individual amateurs involved in a hobby. Few hobbies demand a high minimum standard to get involved. For example, look at hking. This can be anything from a short trip on a level path to a class 6 climb up a rock face. Now there's a fairly steep minimum skill required for the latter, but almost anyone who can walk, roli a wheelchair or whatever can manage the former. But all are part of the same hobby, hiking. The guy with years of training and a special telescope making long term exposures of distant galaxies and the kid out in the backyard looking at Jupiter with Dad's binoculars are both practicing the hobby of astronomy,

I feel that if some re-thinking on this subject is not done, fandorn will uttimately suffer. Many of the parents reading the Official Policy will catch the same bad vibes that struck us, and it will probably anger some of them sufficiently to cause them to drop out. Furthermore, many children of fans are likely to grow up with similar fannish interests, but may well be turned off by what seems to a strong "we don't want you" attitude. I also think that the classification "children" needs to be See Child Policy on Page 8.

within grabbing distance. If the kid wanders too far, you will be asked to corral him/her. Unattended children will have their memberships revoked.

Explanation: (Atthough it is usually a mistake to explain policy.) There were several cases of children left basically unattended in the lobby area outside the main room at the last ConChord. This forced the notparticularly-child-oriented registration table attendants into a babysitter role, which they did not want, heartily resented, and could have incurred considerable liability for. I suggest it might be wiser for him not to go casting doubt on the veracity, honesty, and integrity of people he doesn't even know. Especially in print.

It might be noted that in addition to the consideration of their honesty and integrity, both Susan and Jim are regular attendees at filks in their part of the world. Susan has even been known to pen the occasional filksong. She told me that she would have loved to have seen a filksong on the ballot...

The other thing that bothered me in that article was his lusting after "validation" and somehow suggesting this is necessary. subdivided. Certainly toddlers have to be somewhere that they can run around and make noise; but many older children are definitely capable of sitting in a filk room and enjoying the music, and there are some who can even contribute their own performances. To this purpose, there should be an arbitrary age division, with children from, say, 8-16 being charged the full children's rate and being permitted to attend events; and a lower charge, or possibly no charge, for the younger children, who will be expected to stay away from these events. If keeping the peace at the cons is carried to such extremes at to allenate the fans and filkers of the future, we are throwing out the baby with the bath water. It goes without saying that disruptive behavior will not be tolerated, but it must be understood that this will apply to adults as well as children, and that what is not acceptable from one will also not be acceptable from the other.

Please be aware that, at this moment, it is our plan if possible NOT to bring our child to Con-Chord; so these suggestions are not being made simply for our own benefit, but for that of the increasing numbers of parents among fandom, a group which must be taken into consideration for the sake of the continued wellbeing of fandom and


