President's Report 1990

1990 has seen the Foundation continue to foster Science Fiction in Australia in a variety of ways. It supported aspiring Australian writers by sponsoring the short story competitions run by Danse Macabre, the 1990 Australian Science Fiction Convention, and HuttCon, the 1991 Australian National Media Science Fiction Convention. This support will continue with the sponsoring of short story competitions run by SunCon and Vampiricon, the 1991 NatCons. The Foundation also provided a seed loan to HuttCon, a loan which, I am pleased to report to this meeting, was recently repaid in full and with a generous donation to the Foundation.

The Foundation is also sponsoring a Ditmar Design Competition, entries for which close at the end of January 1991. The Foundation hopes to be able to provide future Australian Science Fiction Conventions with the choice of their own Ditmar Award design or an attractive statndard design from the Foundation. Additionally, the Foundation has agreed to provide a seed loan to Jack Herman for the preparation of a history of Australian Science Fiction Conventions. To further promote Australian fandom overseas, the Foundation presented a display of Australian Worldcon material at the 1990 World Science Fiction Convention in Den Haag, The Netherlands. Material from Aussiecon, Aussiecon II and the Sydney in '95 bid was included. The Foundation has begun to collect data for a Directory of Australian Fandom to be made available to conventions and fannish groups.

Although our membership numbers have grown, it is disappointing that more people are not supporting the Foundation by joining and/or offering suggestions regarding how the Foundation can better foster Science Fiction in Australia. It is true that most of the Management Committee reside in Melbourne, although it is also true that they are not all originally from Melbourne, but we value the input of our interstate agents and all of our members, The Foundation has never attempted to favour melbourne in its activities and, although the Management Committee must be based somewhere, it is up to fans in other states

to express their ideas and keep us in touch with ways in which the Foundation can best use its funds or structure to promote Science Fiction in Australia. We are always open to suggestions.

The ASFF Logo

1. Introduction

I have considered for some time the advisability of providing the ASFF with an easy-to-recognise and simple-to-duplicate logo. The benefits of a logo include superior visibility in a page of (possibly non-ASFF-related) text, a convenient ID for ASFF-sponsored items and activities, and a more 'professional' appearance for stationery used in contacts with non-sf people and organisations.

2. Requirements

The logo should be distinctive, attractive, and eye-catching. It should be easy to accurately reproduce using almost any printing system. Given the common usage of mimeography in fandom, the design should be suitable for reproduction by this method, meaning that there should be no large black areas that cannot be eliminated. It should be simple enough so that it can quickly be redrawn by hand or accurately traced. It should retain its main attributes at almost any size likely to be used in fanzines.

3. The Design

With the foregoing ideas in mind, I created the design which heads this page and which is discussed in detail in the Appendices that follow.

4. Conclusion

I presented the design to the AGM held on the 20th of January, 1991. After discussion, the meeting voted to accept the design as the official logo of the Australian Science Fiction Foundation. I have prepared this dossier to introduce the design to the ASFF membership.

Note that the design is a proprietary mark of the Australian Science Fiction Foundation and should not be used without permission from the ASFF.


Apprendix A Proposed Designs

1. Schematics

a: Elements: The design uses four design elements. In order, they are: the Cross, the Shield, the Map, and The Letters. With one exception these may be thought of as being 'layered' from lowest to highest, so that each higher element conceals a portion of those elements beneath it. The exception being the smallest of the five stars of the Cross, which may be thought of as being coequal with the lettering. The Cross should appear to be supporting the Shield with two arms from each star. The Cross should be considered as a diamond shape drawn so that the long axis 'points' up and right, left and down. The two stars on the upper short segment should be approximately level. The stars of the Cross should each have seven points except for the smallest, which should have five points. One point of each star should point vertically upwards on the page. The stars should be cross-hatch shaded. The Shield should be a simple opaque circular disk. The Map should be an outline of Australia, including Tasmania but otherwise featureless. The Letters should be the initials of the Foundation, 'ASFF', in capitals, using a serif bold italic typeface. The Letters should be styled solid black or else outline. They should not be shaded.

b: Scales: The short segments of the 'diamond' shape outlining the Cross should be approximately 100 units long. The long segments should be approximately 130 units long. The small star should form an isosceles triangle with the top two stars, with sides of 100, 115, and 115 units. The Shield should have a diameter of 140 units. The Map should be so sized as to just fit within the Shield without touching the outline of the Shield at any point. The Map may be detailed or stylised as seems appropriate for the scale at which it is to be reproduced. The Letters should be sized so as to fit entirely within the Map, and drawn on a circular base so as to approximately follow the curvature of the Great Australian Bight.

Apprendix B: Explanation of symbology:

- 1. The Cross: This is the Southern Cross. The seven-armed design is based on that of the stars on the Australian flag. Laid on its side for esthetic reasons and to accommodate the overlay of text in, e.g., letterheads or other usages without interference with the underlying design.
- 2. The Shield: The World, an Orbit, the simplest geometrical shape take your pick. In from the astronomical to the worldly. Supports the higher overlays and separates the stars from the map.
- 3. The Map: Fairly obvious symblism, the next step in from the worldly to the national. Left blank because inclusion of state lines or capital cities distorts the symbolism and muddies the design.
- 4. The Letters: In from the national to the specific, namely the Australian SF Foundation. Initials only for graphic clarity. Curved for esthetic reasons a design with the letters straight across was considered but abandoned as being inferior to the design proposed above. Curved design intended to convey the impression that the Foundation spans Australia.
