

#### **NEW OFFICERS**

Stanley Wells 1915 - 1998

Stanley Wells was born and grew up in Tacoma, Washington, the eldest of three brothers with an older sister. He attended Stadium High School, the College (now University) of Puget Sound, and University of Washington and received a bachelor's degree from CPS.

He served as a navigator for the Army Air Corps in World War II and was one of three to survive an air crash over India.

After the war, he moved back to Tacoma. At one point, he was offered the chance to buy into a new housing development; as was always characteristic of him, he refused because of their discriminatory convenients. This was many years before the Equal Housing Act.

In 1947, he married Margaret Huseman, whom he had first met when they were students at the University of Washington. They raised two sons, Roger and Marc. They lived first in Seattle for a few years, then in Port Orchard on the Kitsap Peninsula.

He started work as an accountant for the civil service. Because of his high aptitude scores, he was selected to train on the early mainframe computers, and thus was one of the early pioneers of computer programming.

He had a lifelong interest in space exploration and science fiction. In school, he wrote an occasional science fiction story for English classwork. He was a member of the Space Society and would read FANTASY AND SCIENCE FICTION on his commute by boat to and from work.

When he and Margaret retired, they lived in Auburn, Washington, and traveled extensively. When Marc married and had children, he adored his grandchildren.

After the loss of his wife in 1994, he moved to Portland, Oregon to be near his beloved grandchildren.

He is deeply missed by his children, his daughter-in-law, his grandchildren, his many friends in fandom, his associates at his retirement home, and the innumerable lives that he has quietly touched.

#### DAM NUISANCE!

This was reportedly an actual letter from and a reply to the Michigan Department of Environmental Quality, State of Michigan:

Mr. Ryan De Vries 2088 Dagget Pierson, MI 49339

Dear Mr. DeVries:

SUBJECT: DEQ File No. 97-59-0023-1 T11N, R10W, Sec. 20, Montcalm County

Ilt has come to the attention of the Department of Environmental Quality that there has been recent unauthorized activity on the above-referenced parcel of property. You have been certified as the legal landowner and/or contractor who did the following unauthorized activity: Construction and maintenance of two wood debris dams across the outlet stream of Spring Pond. A permit must be issued prior to the start of this type of activity. A review of the Department's files shows that no permits have been issued. Therefore, the Department has determined that this activity is in violation of Part 301, Inland Lakes and Streams, of the Natural Resource and Environmental Protection Act, Act 451 of the Public Acts of 1994, being sections 324.30101 to 324.30113 of the Michigan Compiled Laws, annotated.

The Department has been informed that one or both of the dams partially failed during a recent rain event, causing debris and flooding at downstream locations. We find that dams of this nature are inherently hazardous and cannot be permitted.

The Department therefore orders you to cease and desist all unauthorized activities at this location, and to restore the stream to a free-flow condition by removing all wood and brush forming the dams from the stream channel. All restoration work shall be completed no later than January 31,1998.

Please notify this office when the restoration has been completed so that a follow-up site inspection may be scheduled by our staff. Failure to comply with this request or any further unauthorized activity on the site may result in this case being referred for elevated enforcement action.

We anticipate and would appreciate your full cooperation in this matter. Please feel free to contact me at this office if you have any questions.

#### RESPONSE

Dear Mr. Price:

Re: DEQ File No. 97-59-0023; T11N, R10W, Sec 20; Montcalm County

Your certified letter dated 12/17/97 has been handed to me to respond to. You sent out a great deal of carbon copies to a lot of people, but you neglected to include their addresses. You will, therefore, have to send them a copy of my response.

First of all, Mr. Ryan De Vries is not the legal landowner and/or contractor at 2088 Dagget, Pierson, Michigan - I am the legal owner and a couple of beavers are in the (State unauthorized) process of constructing and maintaining two wood "debris" dams across the outlet stream of my Spring Pond. While I did not pay for, authorize, nor supervised their dam project, I think they would be highly offended that you call their skillful use of natural building materials "debris." I would like to challenge your department to attempt to emulate their dam project any time and/or any place you choose. I believe I can safely state there is no way you could ever match their dam skills, their dam resourcefulness, their dam ingenuity, their dam persistence, their dam determination and/or their dam work ethic.

## JOB DESCRIPTION: ELEPHANT HUNTERS, BY CATEGORY

MATHEMATICIANS hunt elephants by going to Africa, throwing out everything that is not an elephant, and catching one of whatever is left.

EXPERIENCED MATHEMATICIANS will attempt to prove the existence of at least one unique elephant before proceeding to step 1 as a subordinate exercise.

PROFESSORS OF MATHEMATICS will prove the existence of at least one unique elephant and then leave the detection and capture of an actual elephant as an exercise for their graduate students.

COMPUTER SCIENTISTS hunt elephants by exercising Algorithm A:

- Go to Africa.
- 2. Start at the Cape of Good Hope.
- 3. Work northward in an orderly manner, traversing the continent alternately east and west.
- 4. During each traverse pass,
- a. Catch each animal seen.

ENGINEERS hunt elephants by going to Africa, catching gray animals at random, and stopping when any one of them weighs within plus or minus 15 percent of any previously observed elephant.

SYSTEMS INTEGRATION ENGINEERS are not so concerned with hunting elephants as with creating a seamless interface between the elephants and their environment.

ECONOMISTS don't hunt elephants, but they believe that if elephants are paid enough, they will hunt themselves.

STATISTICIANS hunt the first animal they see N times and call it an elephant.

CONSULTANTS don't hunt elephants, and many have never hunted anything at all, but they can be hired by the hour to advise those people who do.

As to your request, I do not think the beavers are aware that they first must fill out a dam permit prior to the start of this type of dam activity.

My first dam question to you is: (1) are you trying to discriminate against my Spring Pond Beavers or (2) do you require all beavers throughout this State to conform to said dam request? If you are not discriminating against these particular beavers, through the Freedom of Information Act I request completed copies of all those other applicable beaver dam permits that have been issued. Perhaps we will see if there really is a dam violation of Part 301, Inland Lakes and Streams, of the Natural Resource and Environmental Protection Act, Act 451 of the Public Acts of 1994, being sections 324.30101 to 324.30113 of the Michigan Compiled Laws, annotated.

I have several concerns. My first concern is - aren't the beavers entitled to legal representation? The Spring Pond Beavers are financially destitute and are unable to pay for said representation - so the State will have to provide them with a dam lawyer. The Department's dam concern that either one or both of the dams failed during a recent rain event causing flooding is proof that this is a natural occurrence which the department is required to protect. In other words, we should leave the Spring Pond Beavers alone rather than harassing them and calling their dam names.


If you want the stream "restored" to a dam free-flow condition please contact the beavers - but if you are going to arrest them (they obviously did not pay any attention to your dam letter-being unable to read English) be sure they are read the Miranda rights first. As for me, I am not going to cause more flooding or dam debris jams by interfering with these dam builders. If you want to hurt these dam beavers-be aware I am sending a copy of your dam letter and this response to PETA. If your dam Department seriously finds all dams of this nature inherently hazardous and truly will not permit their existence in this State-I seriously hope you are not selectively enforcing this dam policy - or once again both I and the Spring Pond Beavers will scream prejudice!

In my humble opinion, the Spring Pond Beavers have a right to build their unauthorized dams as long as the sky is blue, the grass is green and water flows downstream. They have more dam right than I do to live and enjoy Spring Pond. If the Department of Natural Resources and Environmental Protection lives to its name, it should protect the natural resources (Beavers) and the environment (Beavers' Dams).

So, as far as the beavers and I are concerned, this dam case can be referred for more elevated enforcement action right now. Why wait until 1/31/98? The Spring Pond Beavers may be under the dam ice then and there will be no way for you or your dam staff to contact/harass them then.

In conclusion, I would like to bring to your attention a real environmental quality (health) problem in the area. It is the bears. Bears are actually defecating in our woods. I definitely believe you should be persecuting the defecating bears and leave the beavers alone. If you are going to investigate the beaver dam, watch your step! (The bears are not careful where they dump!)

Being unable to comply with your dam request, and being unable to contact you on your dam answering machine, I am sending this response to your dam office via another government organization - the dam USPS. Maybe, someday, it will get there.



### Ask Mr. Know-it-all

A Ms. JB of Olympia asks: Why do the British drive on the left?

There are many advantages to driving on the left, not the least of which is the annoyance it gives to the upstart colonists in America who got rid of their monarch and then began to drive on the right. Another advantage is that it is easier to utilise older Japanese automobiles. Japan prohibits automobiles that are more than a few years old, even though they may still be fine vehicles.
