HOWARD MENGER'S CONVENTION SNAFFOOD BY HALL'S N.I.C.A.P.

As reported in the last issue of THE SEARCHLIGHT famed UFO researcher and author of FROM OUTER SPACE TO YOU, Howard Menger, is planning a space age convention on Nov. 26, 27 & 28 in Sebastian, Florida. This was until rather recently when NICAP sent a very pointed letter to the City Clork of Sebastian dated September 14 (photo copy available for inspection). In this letter Richard Hall, NICAP's Acting Director, called Henger's New Jersey convention of 1958 a "circus-like convention of tall tale tellers, each trying to outdo the other in extravagent claims of sojourning with spacemen in the vicinity of High Bridge, New Jersey". The United UFOlogical Association, composed of almost 50 scientific The United UFOlogical Association, composed of almost 50 scientific UFC research groups similar to curs located around the world (to which NICAP does NOT belong and NOT offering their co-operation claiming that such co-operation would show that they approved of such groups) passed a "Code of Ethics" at the Congress of Scientific UFOlogists held in Cleveland, Chio in June of 1965. Three points that they approved were "no organization or individual should take any action which shall have the effect of suppressing free inquiry of UFO information" -- "NEITHER shall any such organization or individual whether by word of mouth or in writing say or write anything which shall have the purpose or effect of discrediting, defaming, libelling or slandering other organizations or individuals" -- "NOR shall any such organization or individual attempt in any way to impose any specific set of values, whether his own or that in any way to impose any specific set of values, whether his own or that of others; or take any steps which shall have the purpose or effect of dominating, controlling, monopolizing or tending to create a monolithic sphere of influence which shall inhabit, restrict or maliciously interfere with the operation or activities of such organization and individuals." NICAP IS GUILTY OF ALL OF THESE THREE POINTS AND MUCH MORE.

As soon as Menger completes the finishing touches on the X-4 (a free energy circular take off and landing craft) he will have movies taken of it in flight and will appear on radio and television nation wide

announceing this new discovery. Judge Lloy Harrison of Sebastian, Florida says about Menger "here is a man who knew what he was doing and had something to offer." Howard has asked us to get the wheels turning up here and get the word around about this convention which will be held right after Thanks-giving. Menger states "We would like as many of you folk up there as possible to come down."

AN ENTRANCE TO THE CAVES IN BY JOHN ROBINSON STAFFORDSHIRE, ENGLANDASSISTANT EDITOR

This entrance to the caves now lost, was discovered by a laborer, who was digging in a lonely field somewhere in Staffordshire, England. The exact location of the field and extrance has never been discovered. However, the story is related in "A History of Staffordshire" by Dr.Plot, who wrete the book in the late 1770's.

I shall relate the highlights of the events as they appear in this ancient historical book.

A dull ignorant laborer was digging a trench in a field which lay in a valley surrounded on almost all sides by woods somewhere in Staffordshire. The sun had gone down and the laborer, who later related his experience, asserted that just as he was about to stop work his pick hit a large flat stone. The stone had an iron ring mounted in it. He stayed and cleared the stone which was in the form of a large oblong. His attempt to pry the stone up was met with failure but he utilized ropes he had brought to obtain more leverage and managed to slide the stone over This revealed a stone staircase which sloped down into the earth.

Since his first thought was that this might lead to an ancient temb contain-ing treasure. ^Because of this possibility he gradually descended the stone stairway while looking back he could still see the sky glowing with the last light of the sun. His decent continued until he was about, according to his estimation, 100 feet underground. It was at this point that he suddenly reached a sort of landing. The planet Venus had risen by this time and was shining directly down the shaft, so that he was able to discern the beginning of another stairway

which descended at a right angle to discern the beginning of another stairway in gold or jewels, made him feel his way in the darkness down another 120 steps. At the foot of these steps was a turn and far below down another long flight of stone steps he could see a pale but steady light. While descending this long flight of steps he heard the sound of some sort of machinery or the rumble of a large vehicle semewhere far in the

distance. He paused; frightened, but the sound was gone and in the surround-ing stillness he forced himself to ge forward teward a light which glowed unnaturally in the bowels of the earth.

Reaching the end of the steps he found himself in a large stone chamber, the roof of which seemed far above him and the walls of which he could not see even by the light of a globe which glowed on the floor before him. Suddenly a hooded cowled figure appeared from some side passageway. This being pointed what he described as a baton like object or as we would understand it a tube at the light and destroyed it with a thunderclap which echoed and reechoed through immeasurable subterranean passageways. or up the stone stairway when he related his story. Any attempts to get him to visit the valley again were unsuccessful. Others who scarched for the digging were unable to locate either because of the terrible wind and rainsform which occurred that night. This ripped and washed the vegatation of the valley away leaving only the bare earth with no trace of the trench, the stone or the staircase. Because of this the Staffordshire entrance has never been located again.

THE THING HOLDS A TOWN IN ICY GRIP OF FEAR

A normally quict market community of 10,000 persons in Warminister, England has been terrified since last Christman morning of a strange object

which stocks the city hurling women and children to the pavement while being "stricken by strange poworfulblows on the head and shoulders." The "Thing" as it has been so described makes horrowing sounds and causes icy chills to run up and down a persons spine. Animals have been injured by the "Thing" and strange noises in the dead of night have been

attributed to this object described by some as cigar-shaped and by others as looking similar to Adamski's scout ships. On September 5, 1965 at 1:55 a.m. the night was ripped by a terrible explosion and a strange orange light appeared in the bedrooms of many residents. Those who ventured outside in their night clothes said they observed this cigar-shaped object hovering in the sky, with a glowing core in its center.
